1. General description

The 74AHCT17A is a hex buffer with Schmitt-trigger inputs, capable of transforming slowly changing input signals into sharply defined, jitter-free output signals.

Designed to operate over a V_{CC} range from 4.5 V to 5.5 V, the inputs are TTL compatible. This range allows the device to be used to translate from 3.3 V to 5 V.

This device is fully specified for partial Power-down applications using I_{OFF} . The I_{OFF} circuitry disables the output, preventing the damaging backflow current through the device when it is powered down.

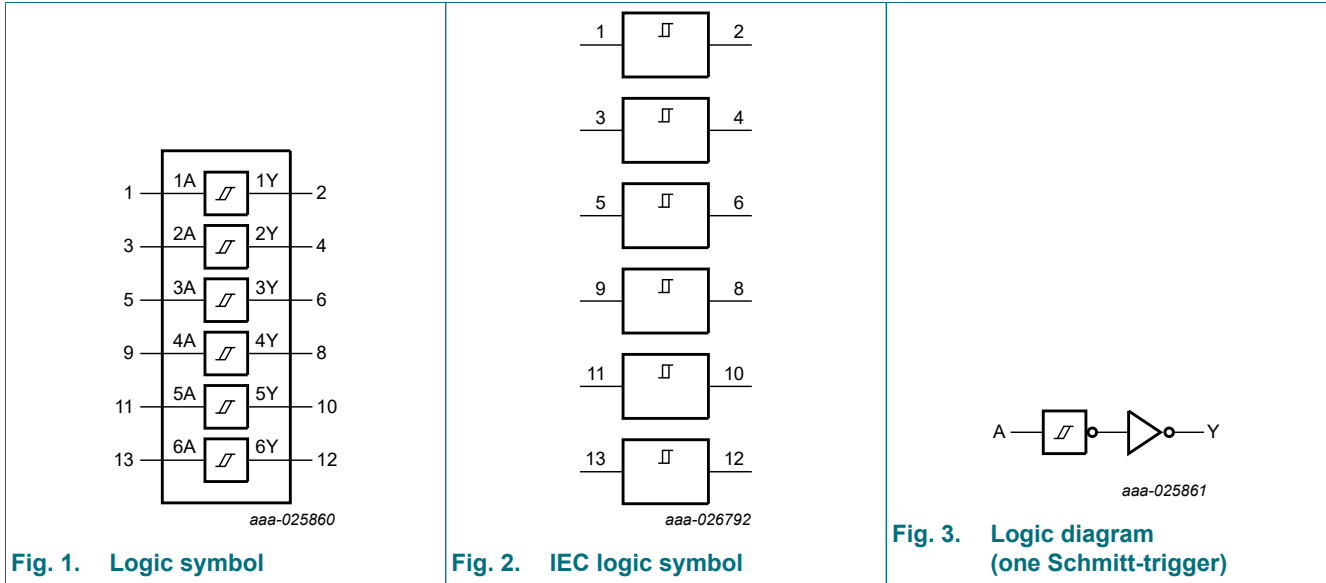

- Supports mixed-mode voltage operation on all ports
- I_{OFF} circuitry provides partial Power-down mode operation
- Latch-up performance exceeds 250 mA per JESD 78 Class II
- ESD protection:
 - HBM: ANSI/ESDA/JEDEC JS-001 class 2 exceeds 3000 V
 - CDM: ANSI/ESDA/JEDEC JS-002 class C3 exceeds 2000 V
- Specified from -40 °C to +85 °C and from -40 °C to +125 °C

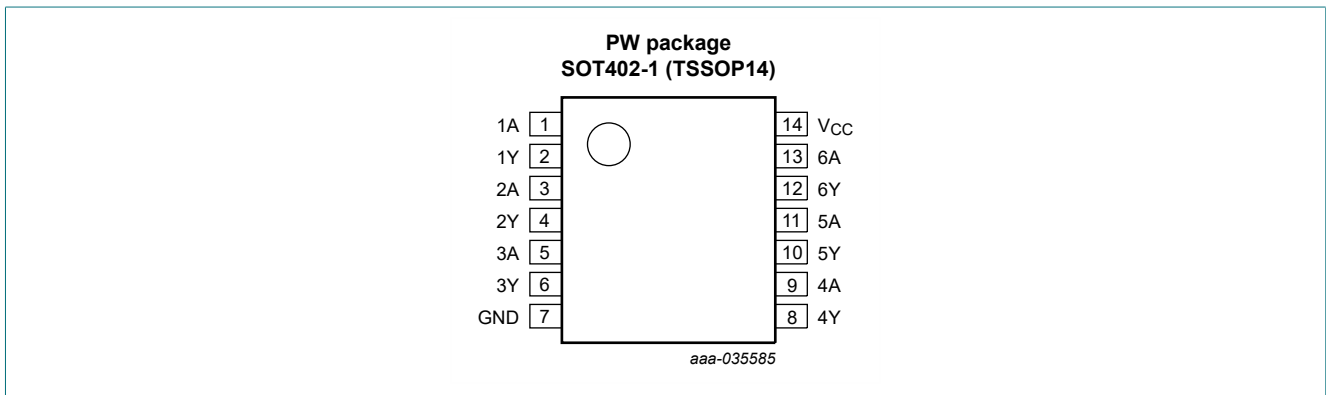

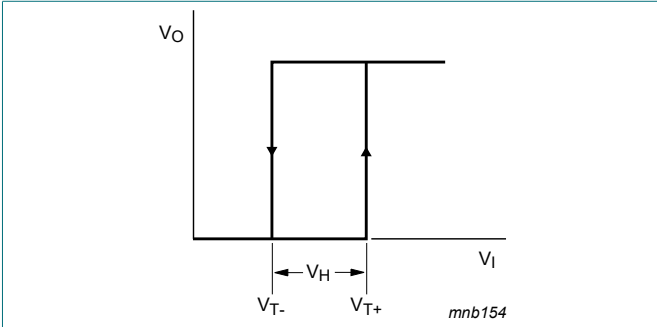


Fig. 4. Transfer characteristics

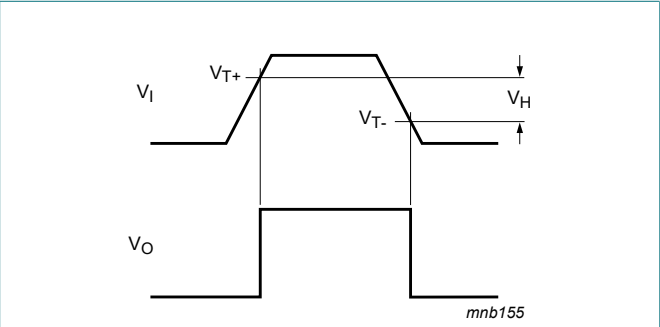
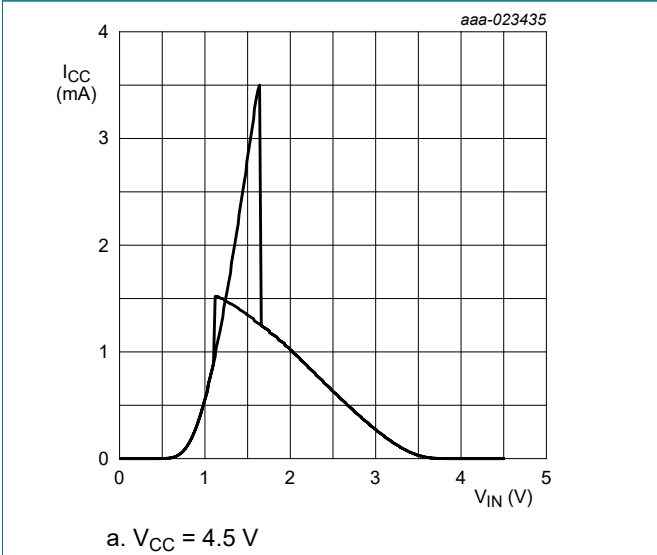
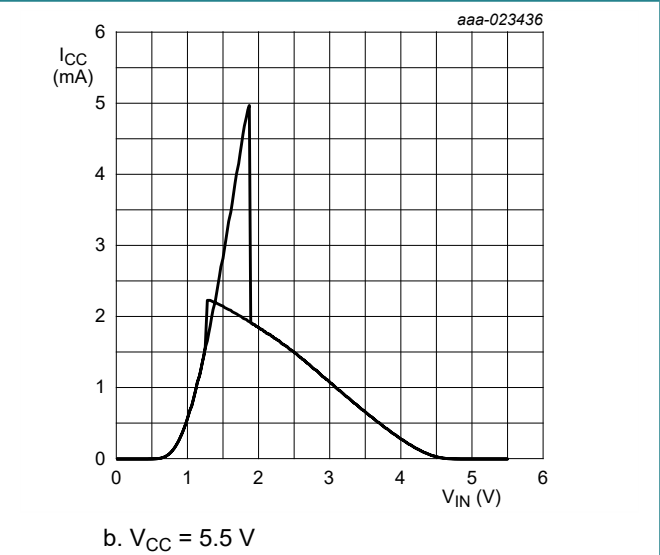


Fig. 5. Transfer characteristics definitions

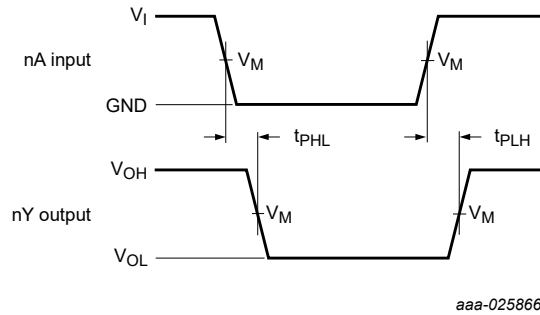

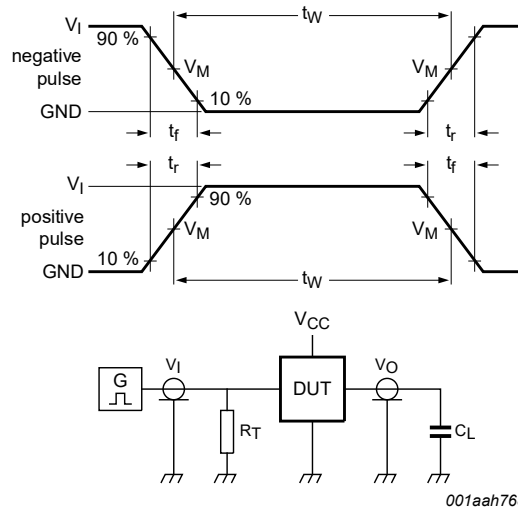

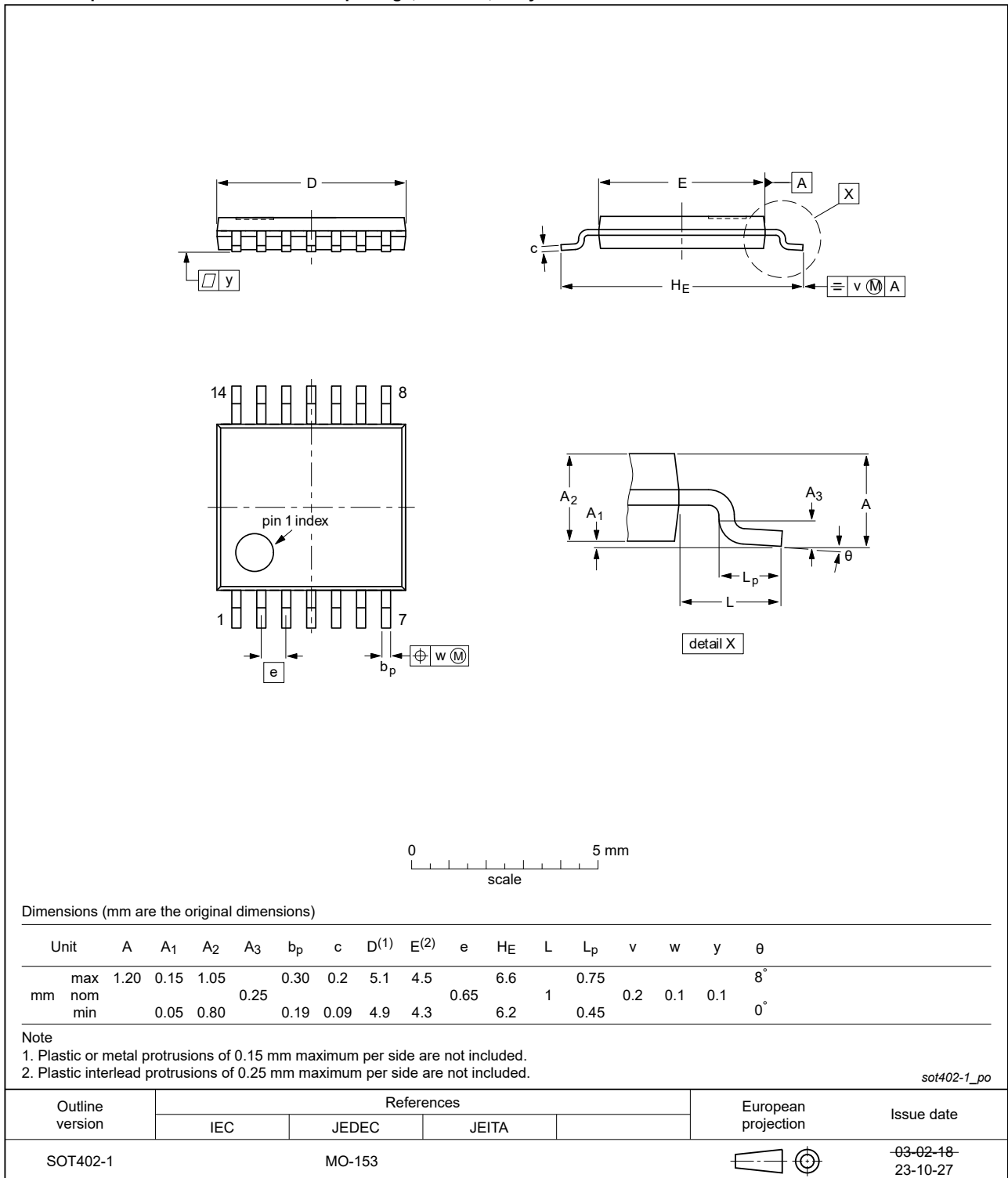


Fig. 9. Package outline SOT402-1 (TSSOP14)
