## 1. General description

The 74AHC00; 74AHCT00 are quad 2-input NAND gates. Inputs are overvoltage tolerant. This feature allows the use of these devices as translators in mixed voltage environments.

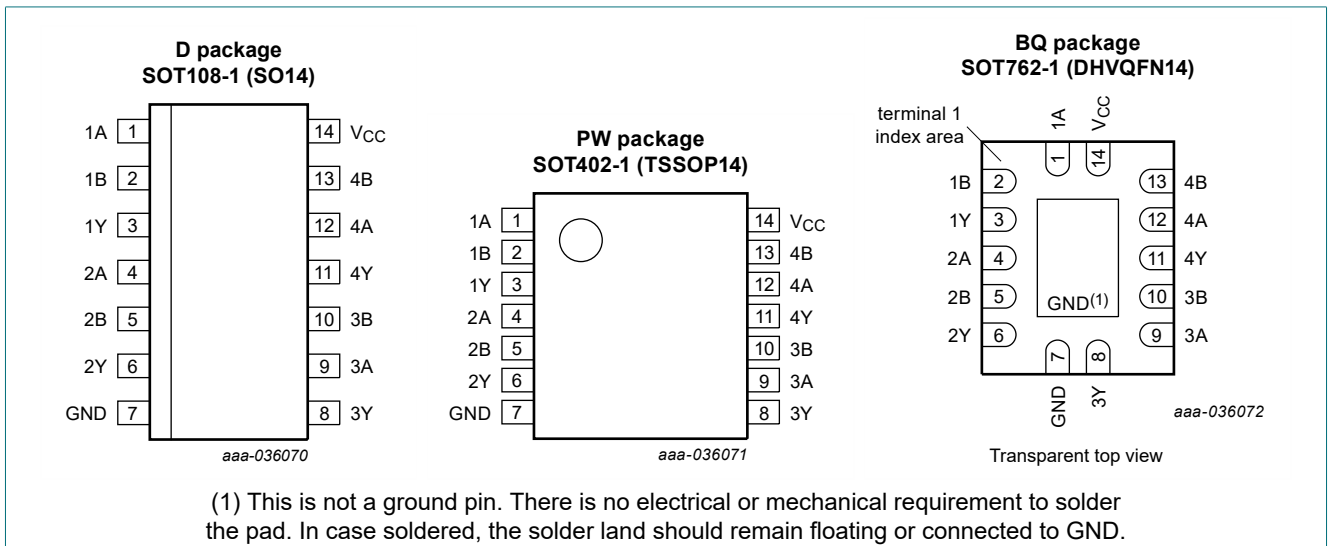

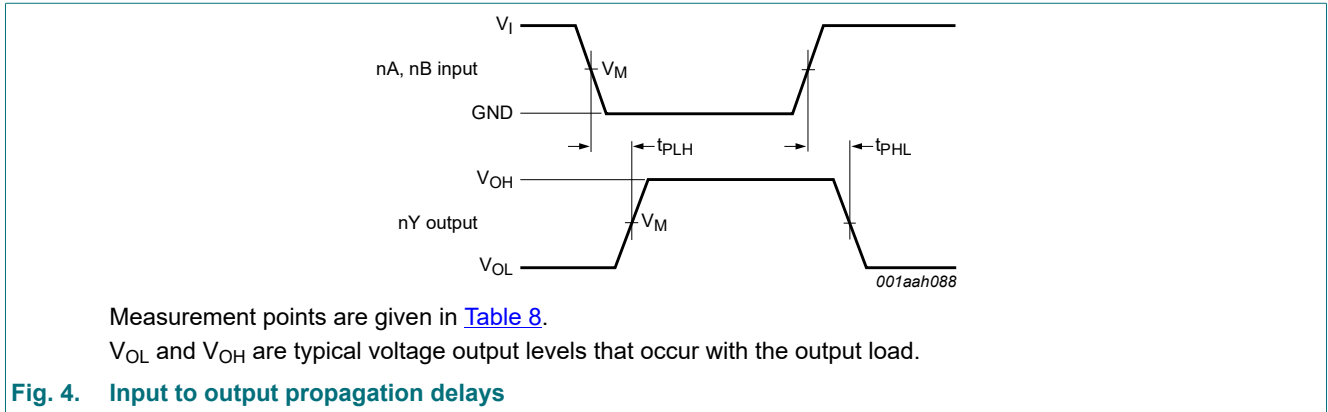

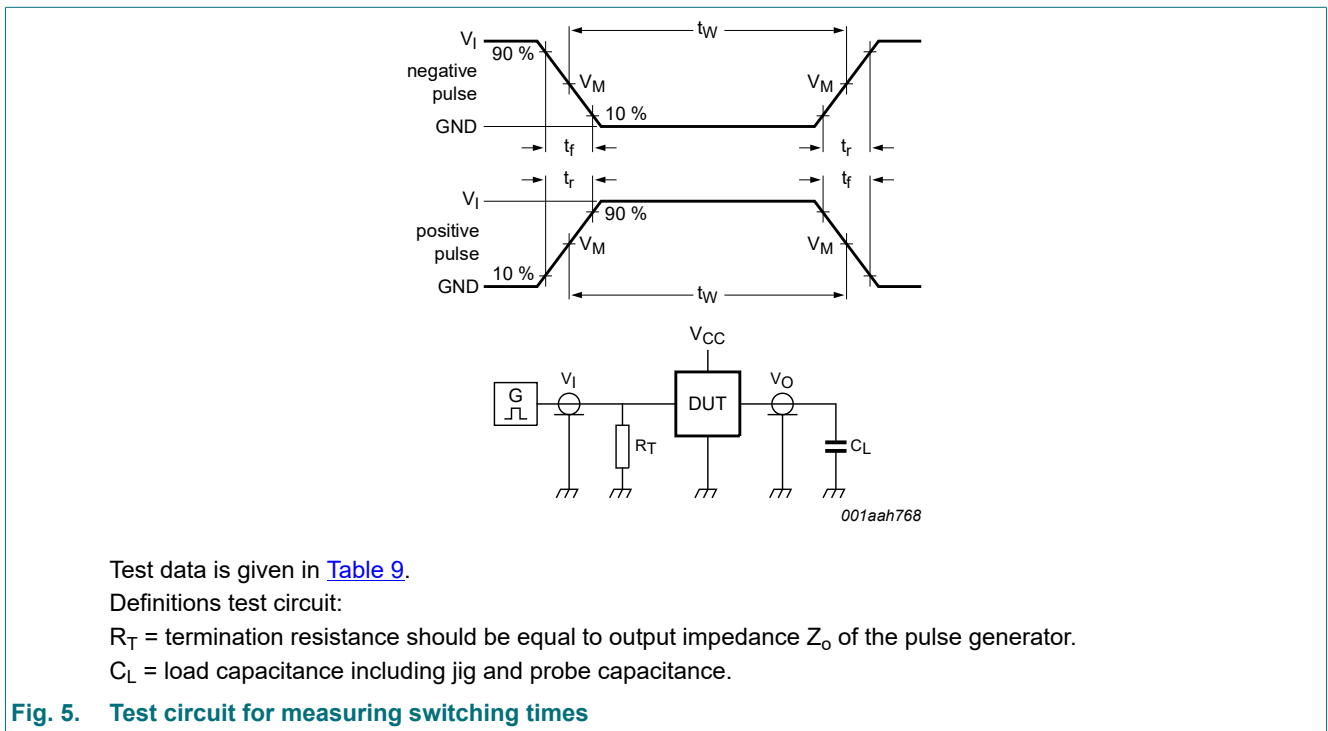
