1. General description

The 74HC1GU04 is a single unbuffered inverter. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess of V_{CC} .









11.1. Waveform and test circuit






Fig. 9. $V_{CC} = 2.0 \text{ V}; I_O = 0 \text{ A}$

Fig. 10. $V_{CC} = 4.5 \text{ V}$; $I_{O} = 0 \text{ A}$




Fig. 11. $V_{CC} = 6.0 \text{ V}$; $I_O = 0 \text{ A}$










Fig. 15. Package outline SOT353-1 (TSSOP5)




Fig. 16. Package outline SOT753 (SC-74A)
