1. General description

The 74HCT241-Q100 is an 8-bit buffer/line driver with 3-state outputs. The device can be used as two 4-bit buffers or one 8-bit buffer. The device features two output enables (1 $\overline{O}E$ and 2 $O\overline{E}$), each controlling four of the 3-state outputs. A HIGH on 1 $\overline{O}E$ or LOW on 2 $O\overline{E}$ causes the associated outputs to assume a high-impedance OFF-state. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess of V_{CC} .

The 74HCT241-Q100 device features reduced input threshold levels to allow interfacing to TTL logic levels.

This product has been qualified to the Automotive Electronics Council (AEC) standard Q100 (Grade 1) and is suitable for use in automotive applications.

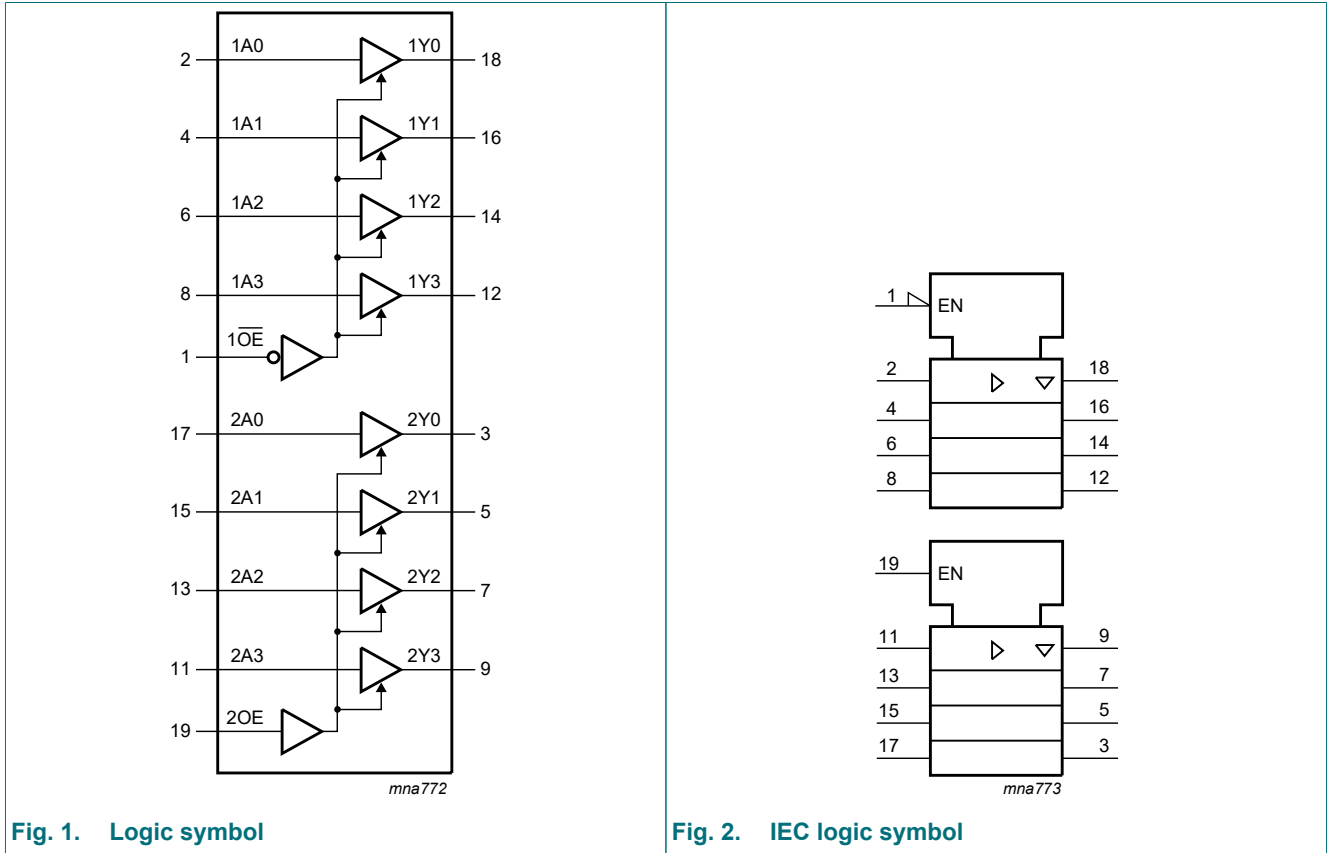

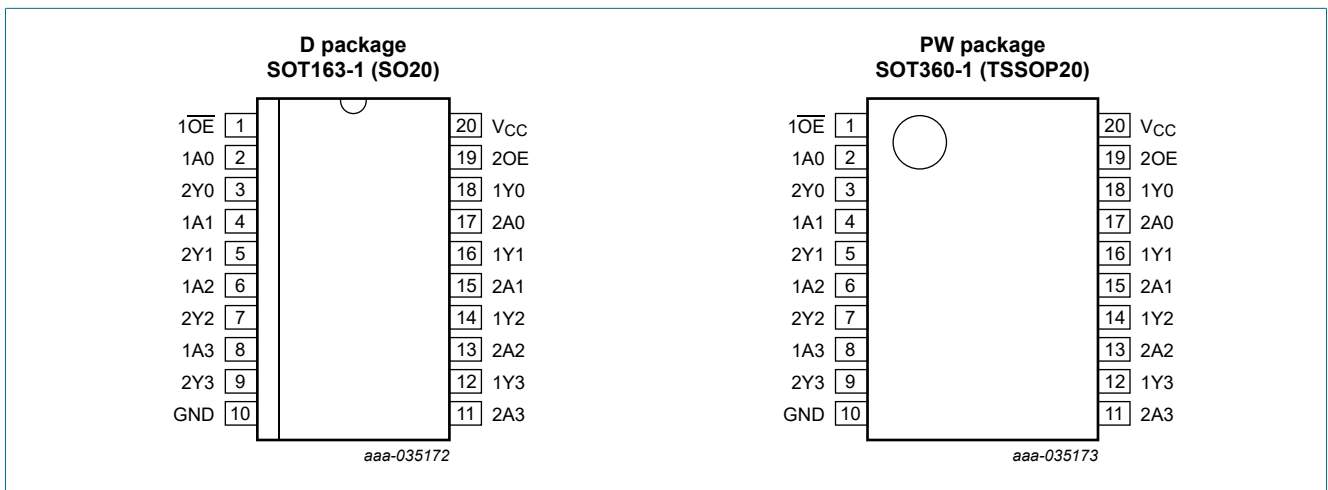

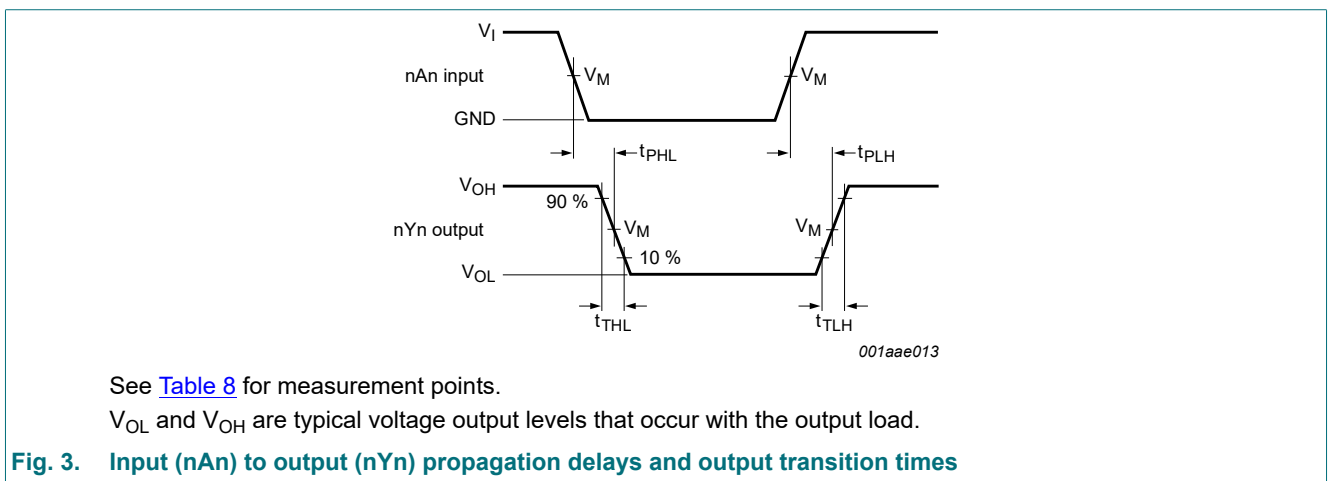

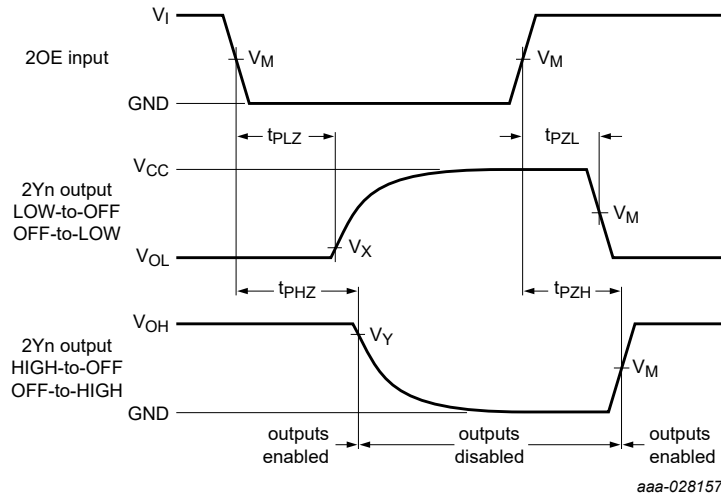

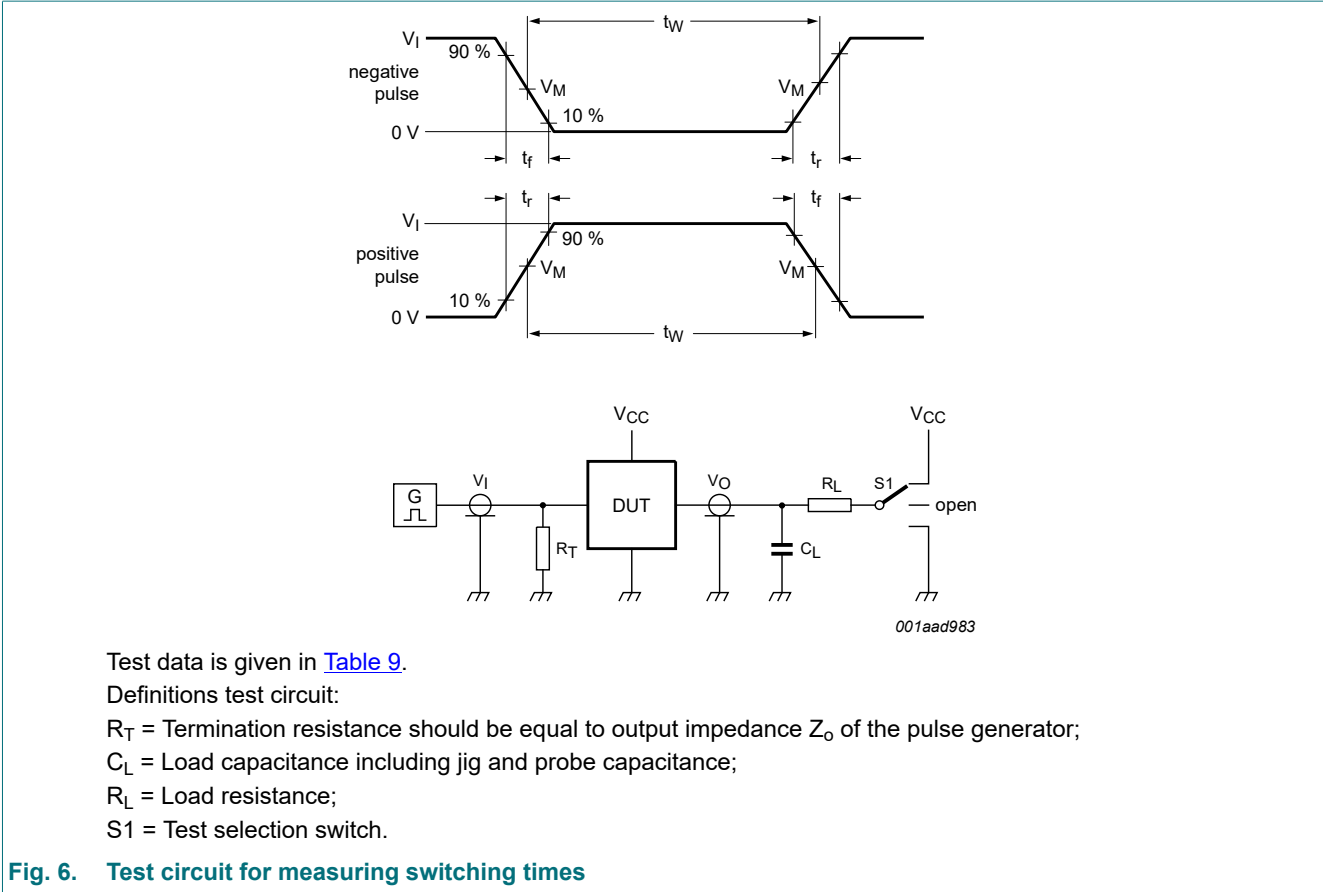


Fig. 6. Test circuit for measuring switching times

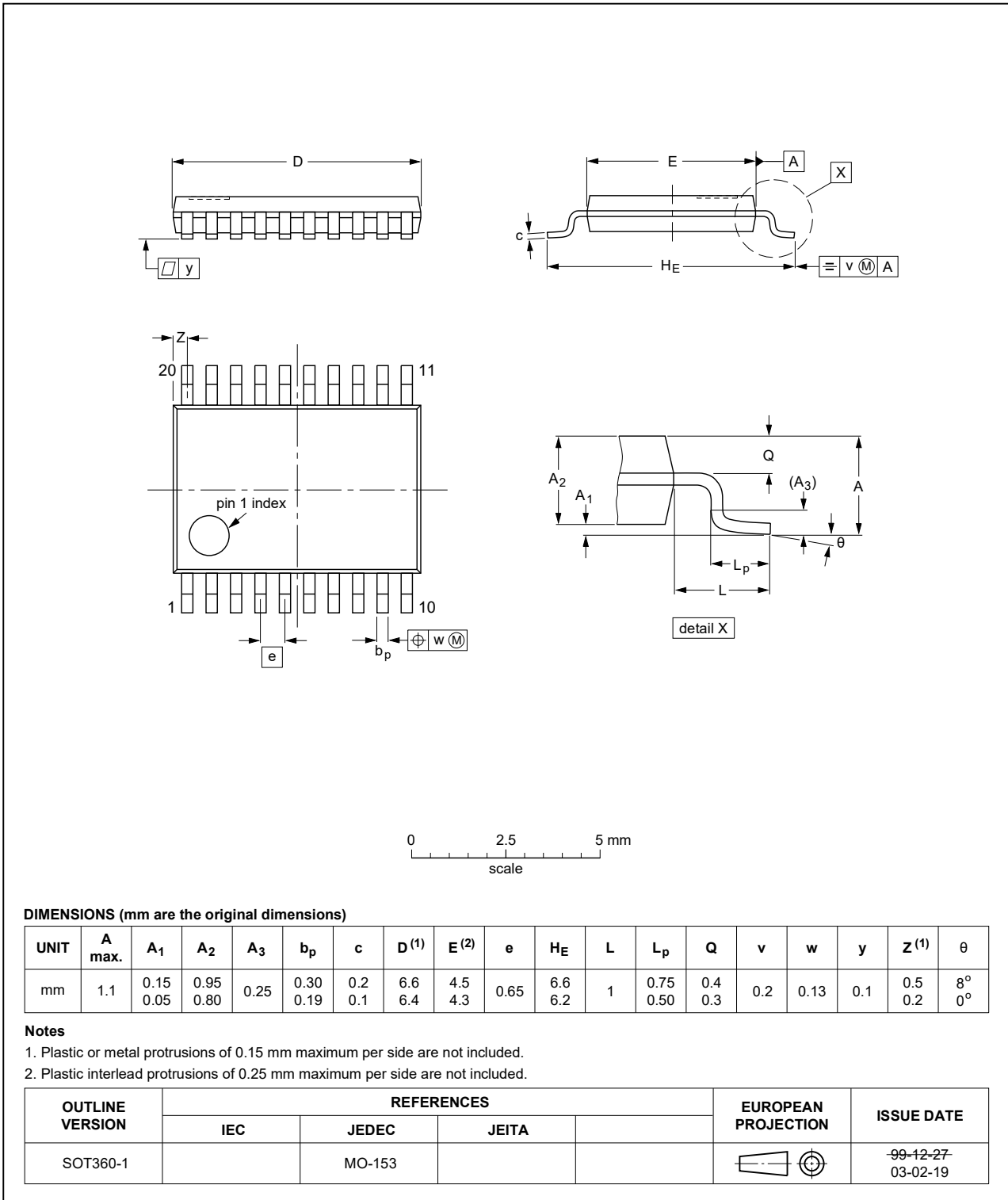


Fig. 8. Package outline SOT360-1 (TSSOP20)
