The 74HC10-Q100; 74HCT10-Q100 is a triple 3-input NAND gate. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess of  $V_{\rm CC}$ .

This product has been qualified to the Automotive Electronics Council (AEC) standard Q100 (Grade 1) and is suitable for use in automotive applications.







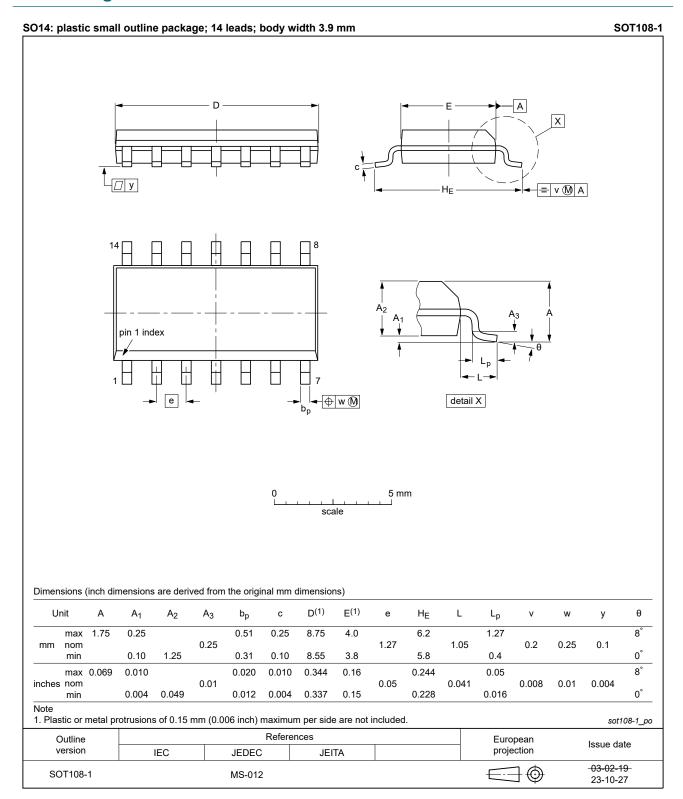


Fig. 6. Package outline SOT108-1 (SO14)




Fig. 7. Package outline SOT402-1 (TSSOP14)
