



1. General description

The 74LV02A is a quad 2-input NOR gate.

Inputs are overvoltage tolerant. This feature allows the use of these devices as translators in mixed voltage environments.

Schmitt-trigger action at all inputs makes the circuit tolerant of slower input rise and fall times.

This device is fully specified for partial power down applications using I_{OFF} . The I_{OFF} circuitry disables the output, preventing the potentially damaging backflow current through the device when it is powered down.

- Wide supply voltage range from 2.0 V to 5.5 V
- Maximum t_{pd} of 10 ns at 5 V
- Typical $V_{OL(p)} < 0.8$ V at $V_{CC} = 3.3$ V, $T_{amb} = 25$ °C
- Typical $V_{OH(v)}$ > 2.3 V at V_{CC} = 3.3 V, T_{amb} = 25 °C
- Supports mixed-mode voltage operation on all ports
- I_{OFF} circuitry provides partial Power-down mode operation
- Latch-up performance exceeds 250 mA per JESD 78 Class II
- ESD protection:
 - HBM: ANSI/ESDA/JEDEC JS-001 class 3A exceeds 4000 V
 - CDM: ANSI/ESDA/JEDEC JS-002 class C3 exceeds 2000 V
- Specified from -40 °C to +85 °C and from -40 °C to +125 °C









Fig. 4. Input (nA, nB) to output (nY) propagation delays




Fig. 6. Package outline SOT402-1 (TSSOP14)
