

1. General description

The 74LV03-Q100 is a quad 2-input NAND gate with open-drain outputs. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess $V_{CC}.$

This product has been qualified to the Automotive Electronics Council (AEC) standard Q100 (Grade 1) and is suitable for use in automotive applications.












Fig. 6. Package outline SOT108-1 (SO14)
