## 1. General description

The 74LVC86A is a quad 2-input EXCLUSIVE-OR gate. Inputs can be driven from either 3.3 V or 5 V devices. This feature allows the use of these devices as translators in mixed 3.3 V and 5 V environments.

Schmitt-trigger action at all inputs makes the circuit tolerant of slower input rise and fall times.

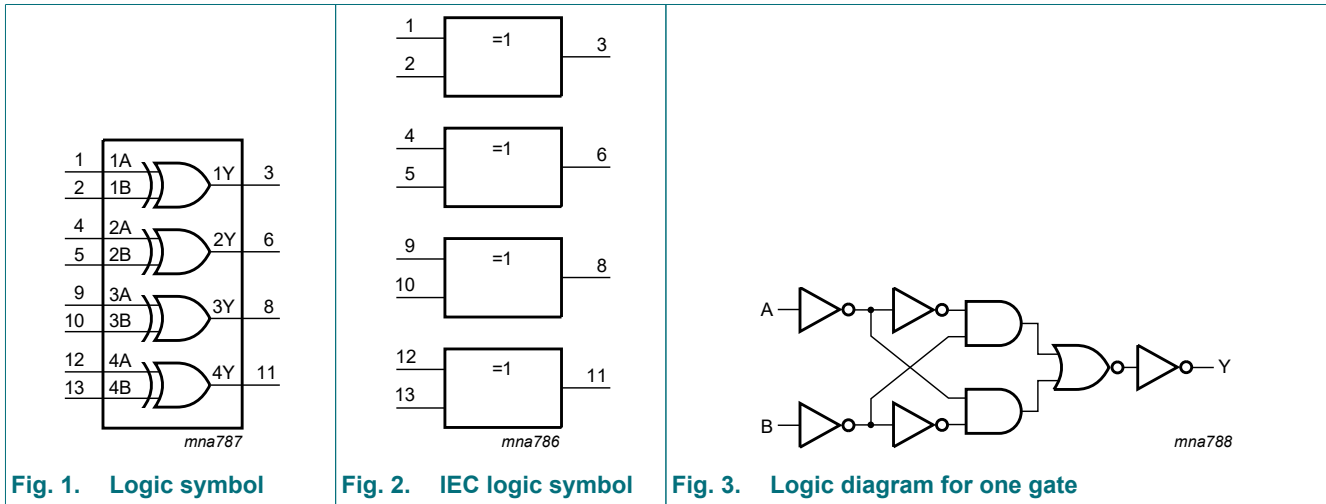

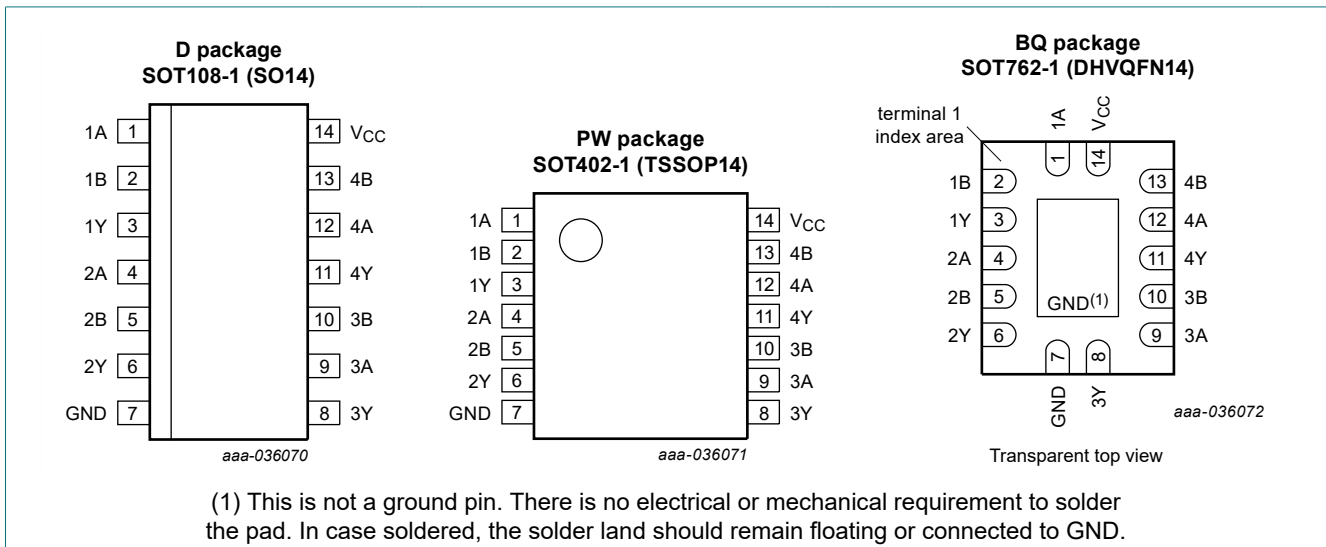

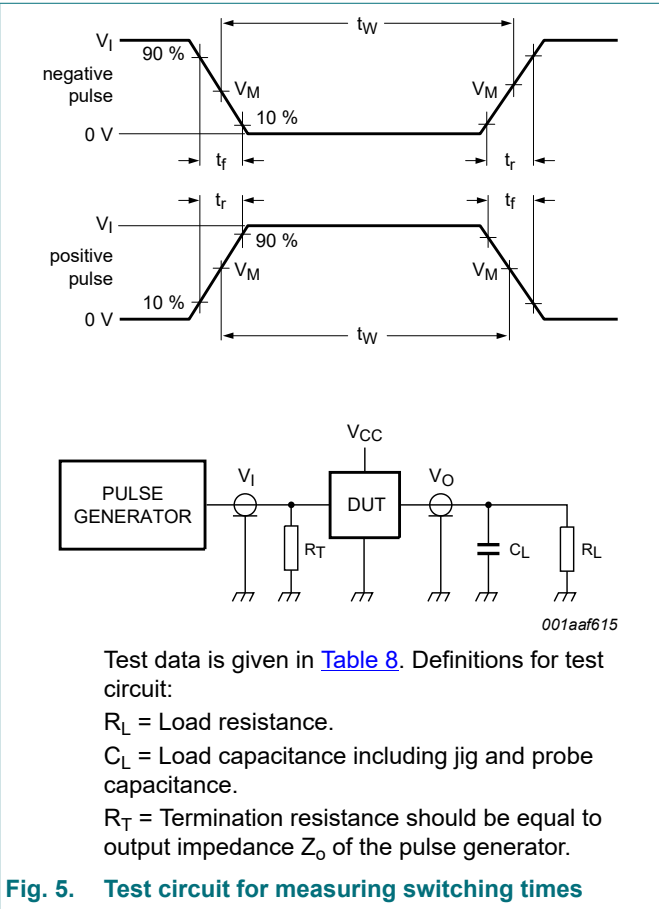
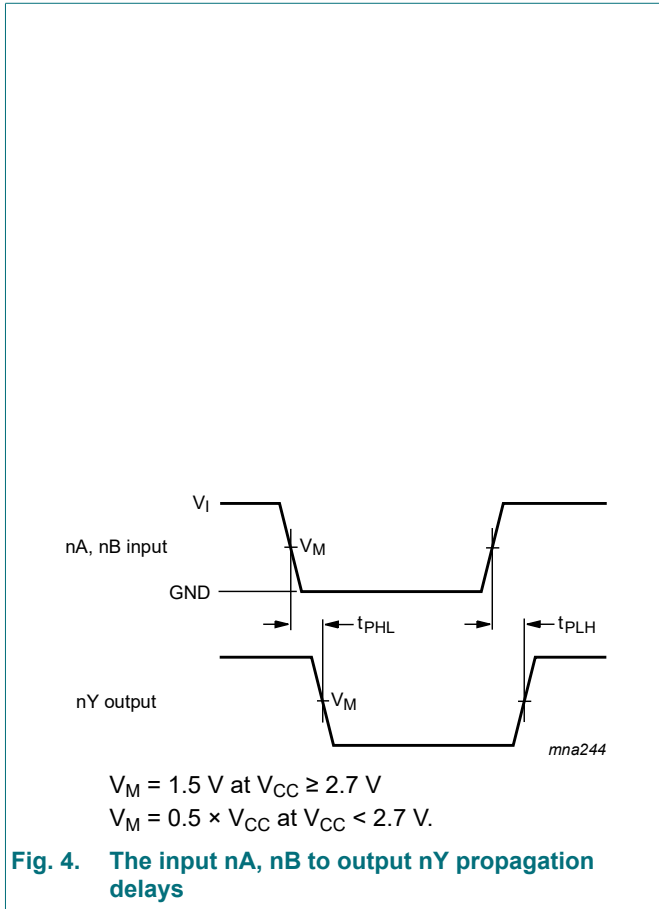

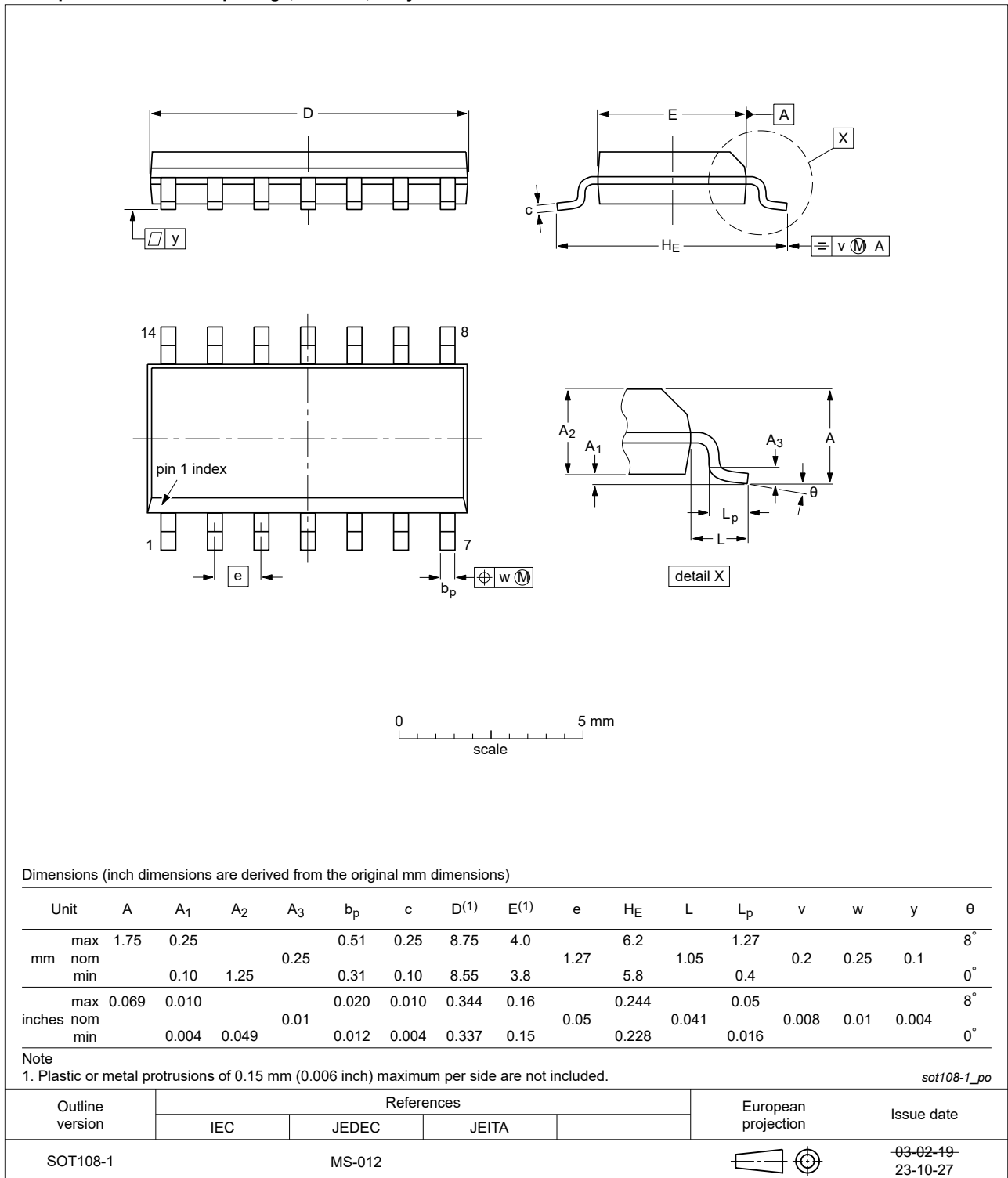


Fig. 6. Package outline SOT108-1 (SO14)
