High-voltage switching diode, encapsulated in an SOD123 small Surface-Mounted Device (SMD) plastic package.

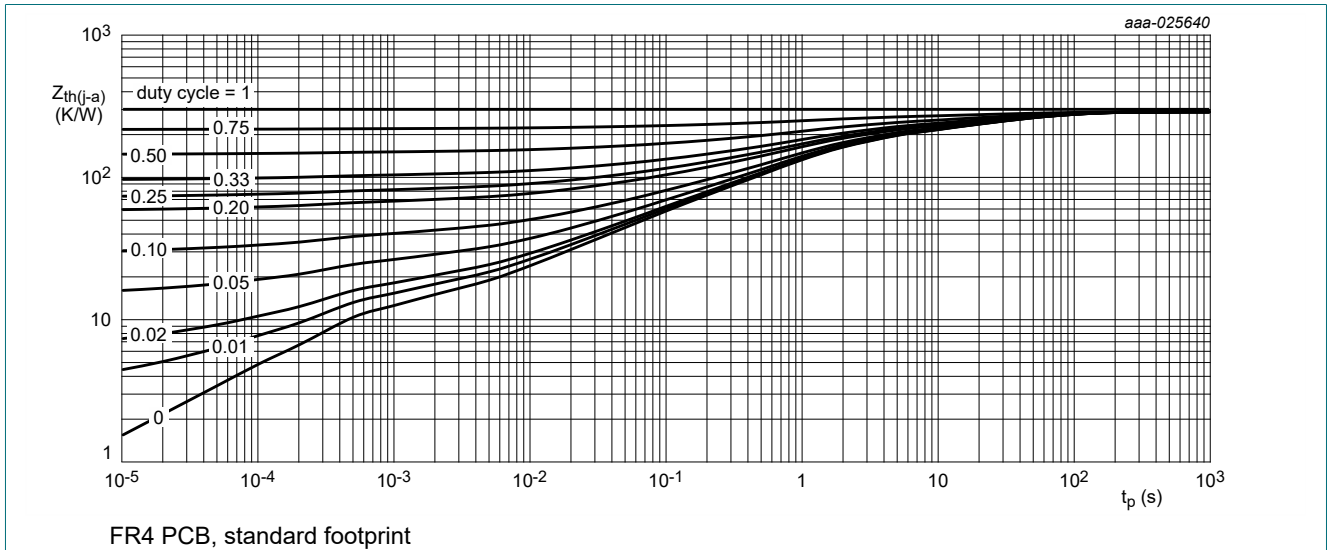


Fig. 1. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

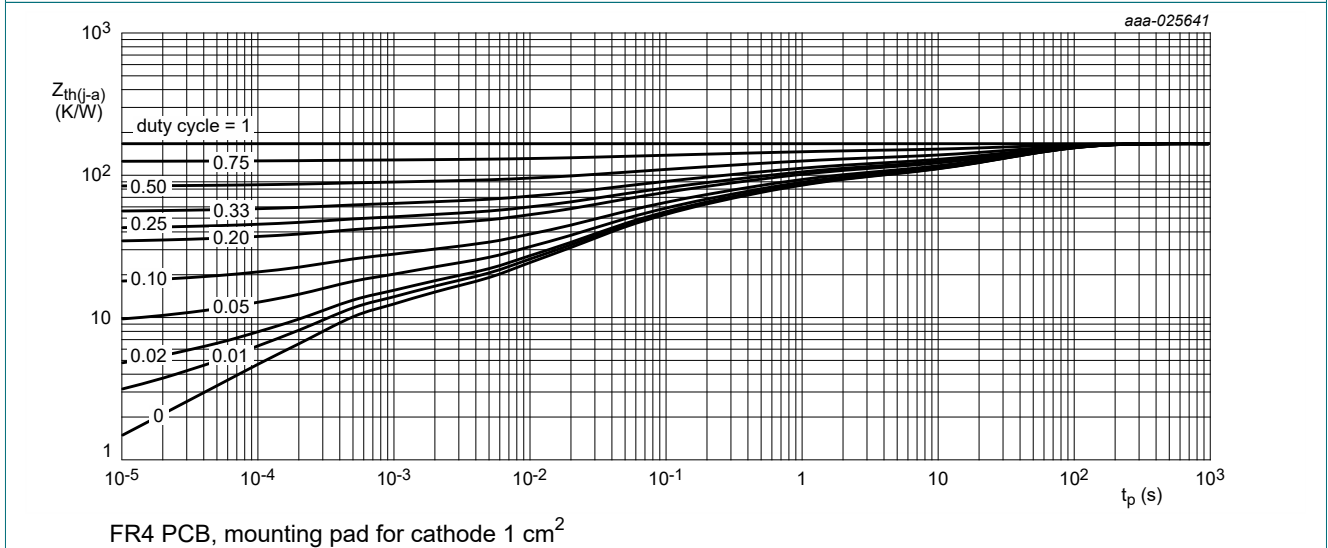


Fig. 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

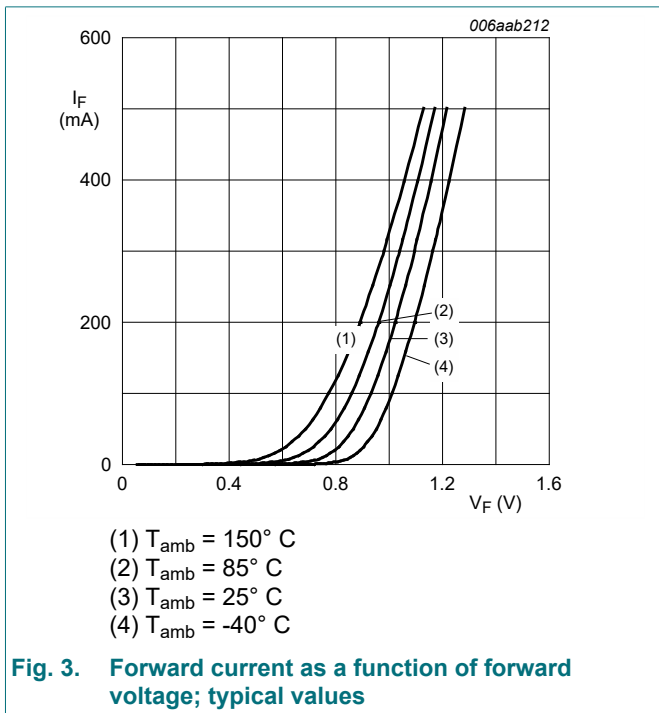


Fig. 3. Forward current as a function of forward voltage; typical values

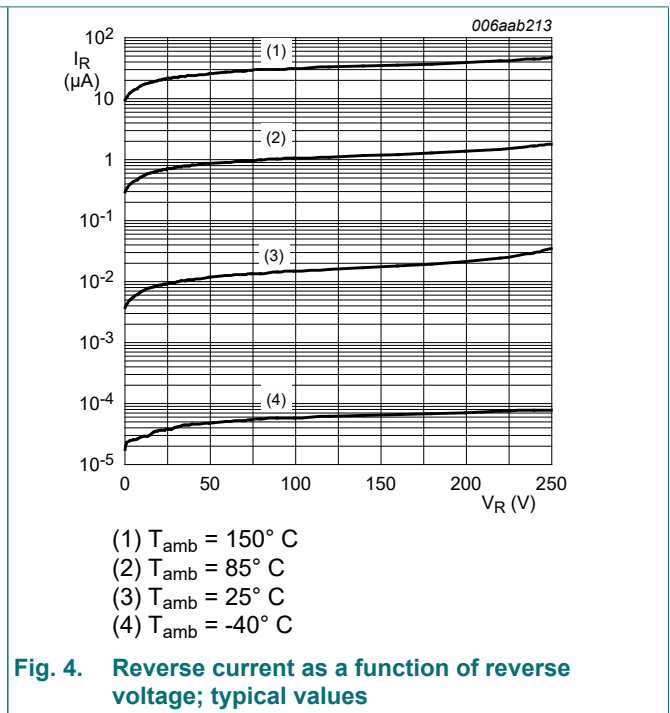
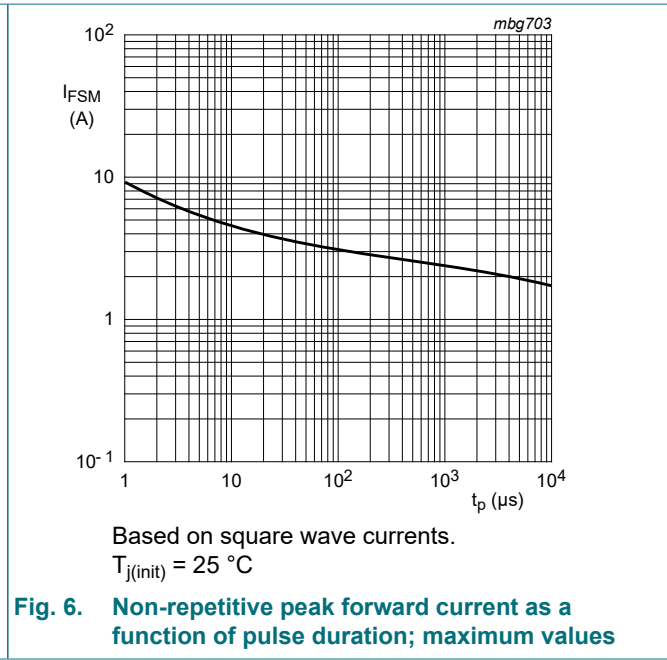
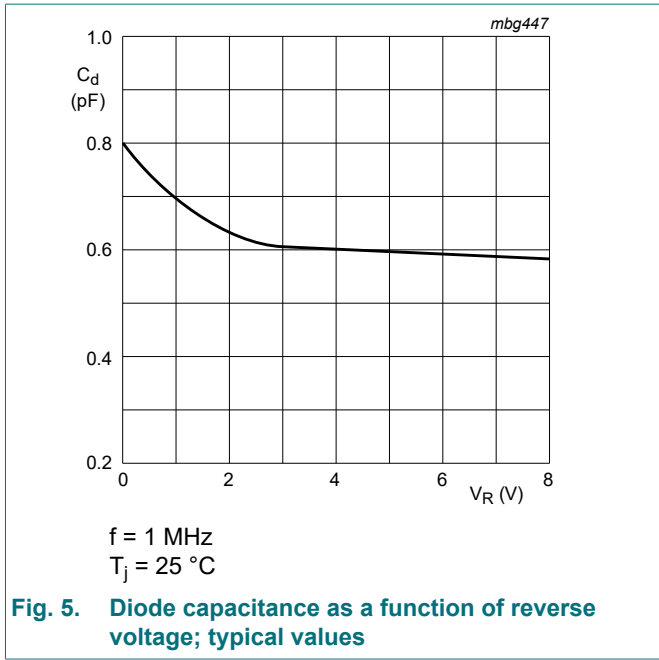
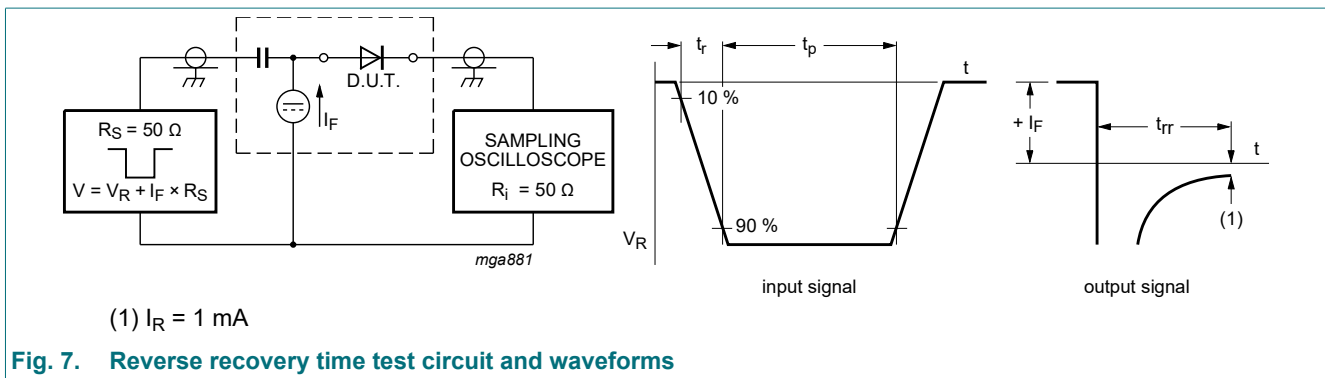


Fig. 4. Reverse current as a function of reverse voltage; typical values

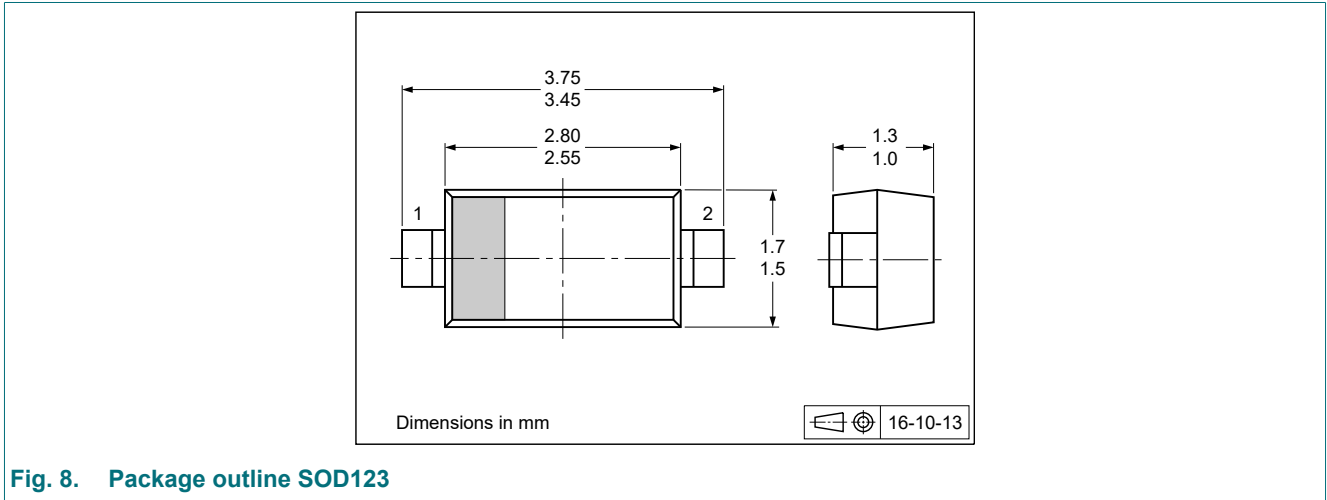


Fig. 8. Package outline SOD123

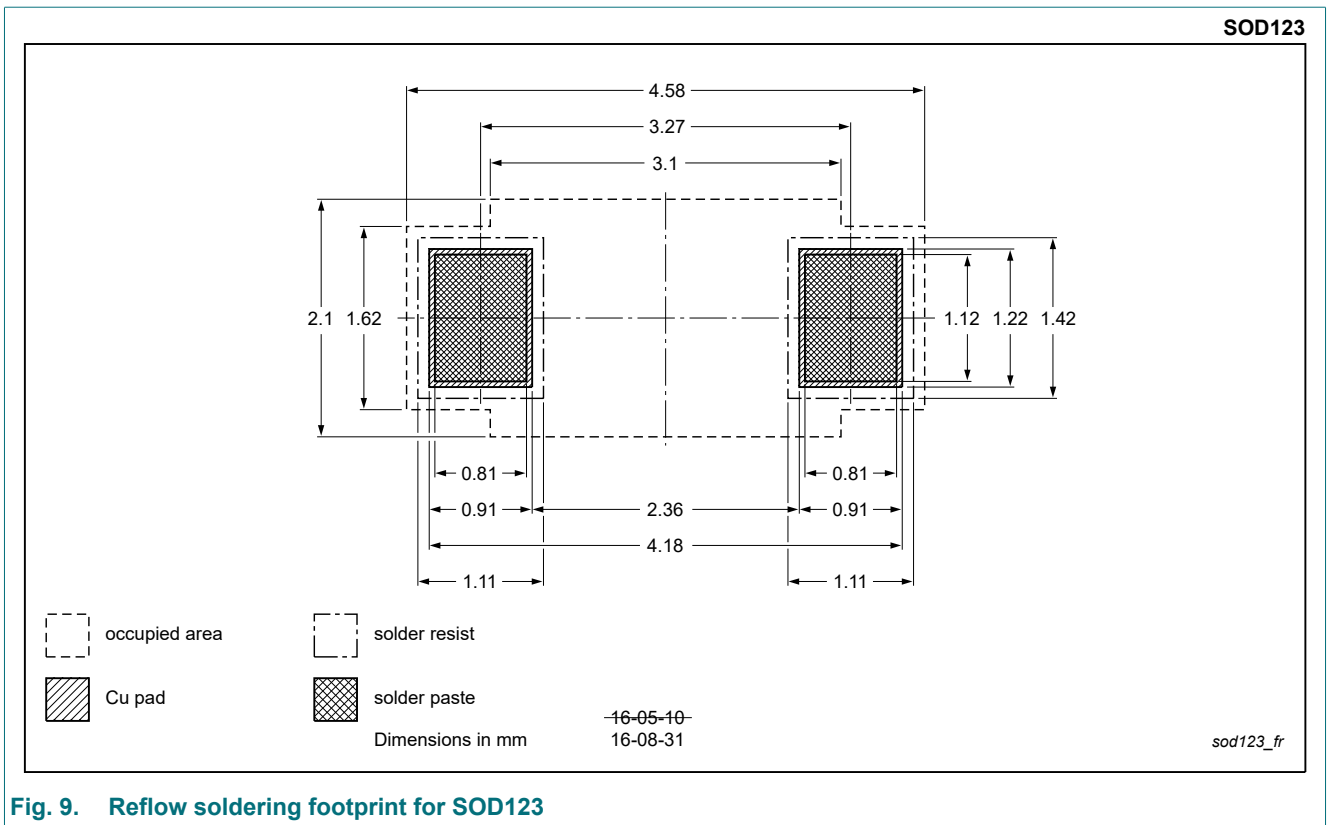


Fig. 9. Reflow soldering footprint for SOD123

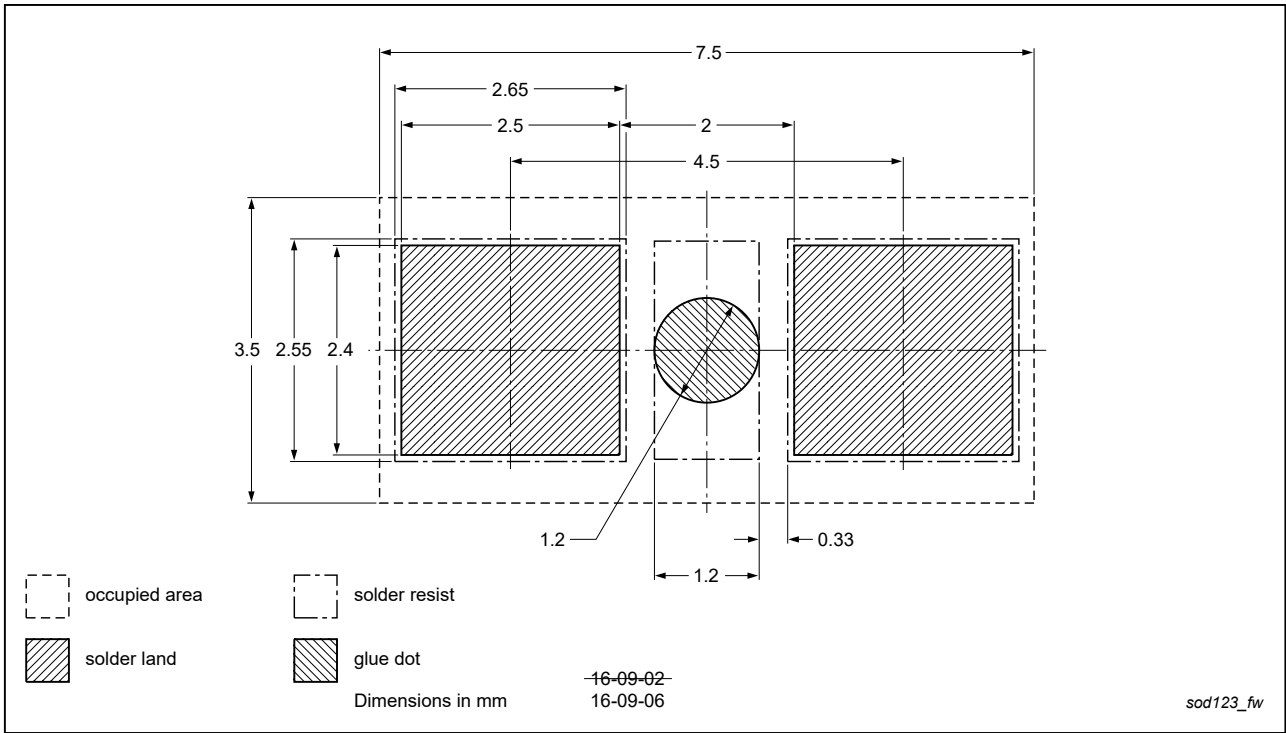


Fig. 10. Wave soldering footprint for SOD123
