






Fig. 3. Forward current as a function of forward voltage; typical values




Fig. 4. Reverse current as a function of reverse voltage; typical values




Fig. 5. Diode capacitance as a function of reverse voltage; typical values





Fig. 6. Non-repetitive peak forward current as a function of pulse duration; maximum values






