




Fig. 1. Maximum permissible continuous forward current as a function of ambient temperature.

Fig. 2. Forward current as a function of forward voltage; per diode




Fig. 3. Non-repetitive peak forward current as a function of pulse duration; typical values

Fig. 4. Reverse current as a function of junction temperature




 $f = 1 MHz; T_{amb} = 25 °C$





Fig. 7. Package outline SC-79 (SOD523)
