1. General description

Dual common cathode high-speed switching diode encapsulated in a leadless ultra small DFN1010D-3 (SOT1215) Surface-Mounted Device (SMD) plastic package with visible and solderable side pads.

- Low leakage current: $I_R \leq 0.5$ μ A
- Reverse voltage $V_R \leq 100$ V
- Low capacitance $C_d \leq 1.5$ pF

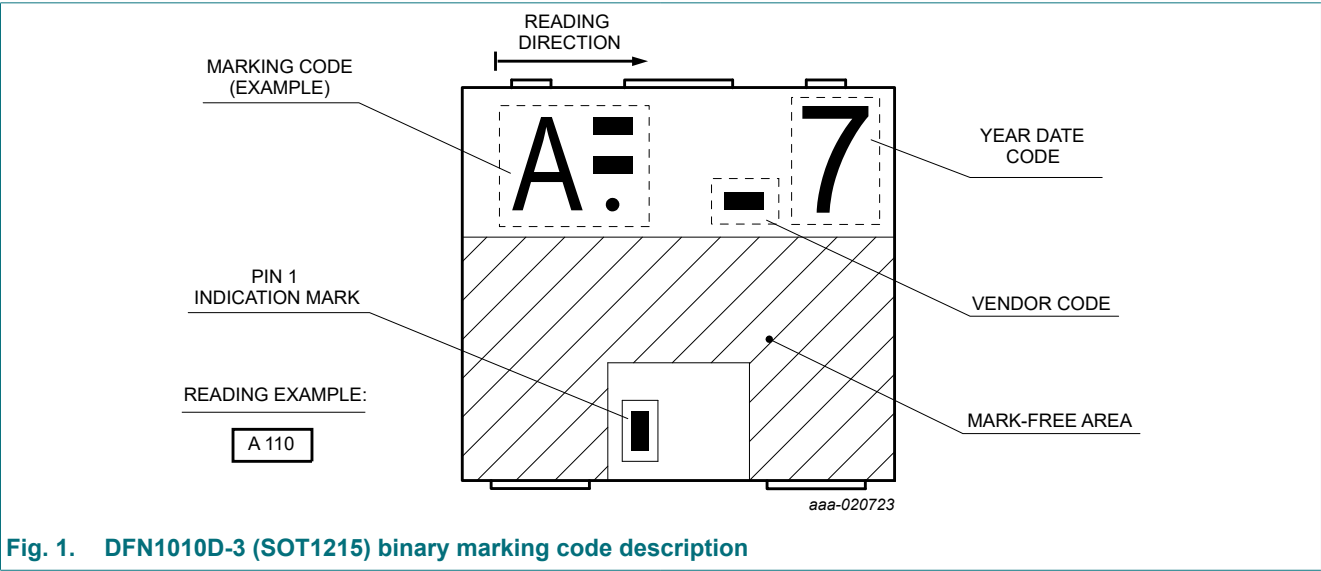


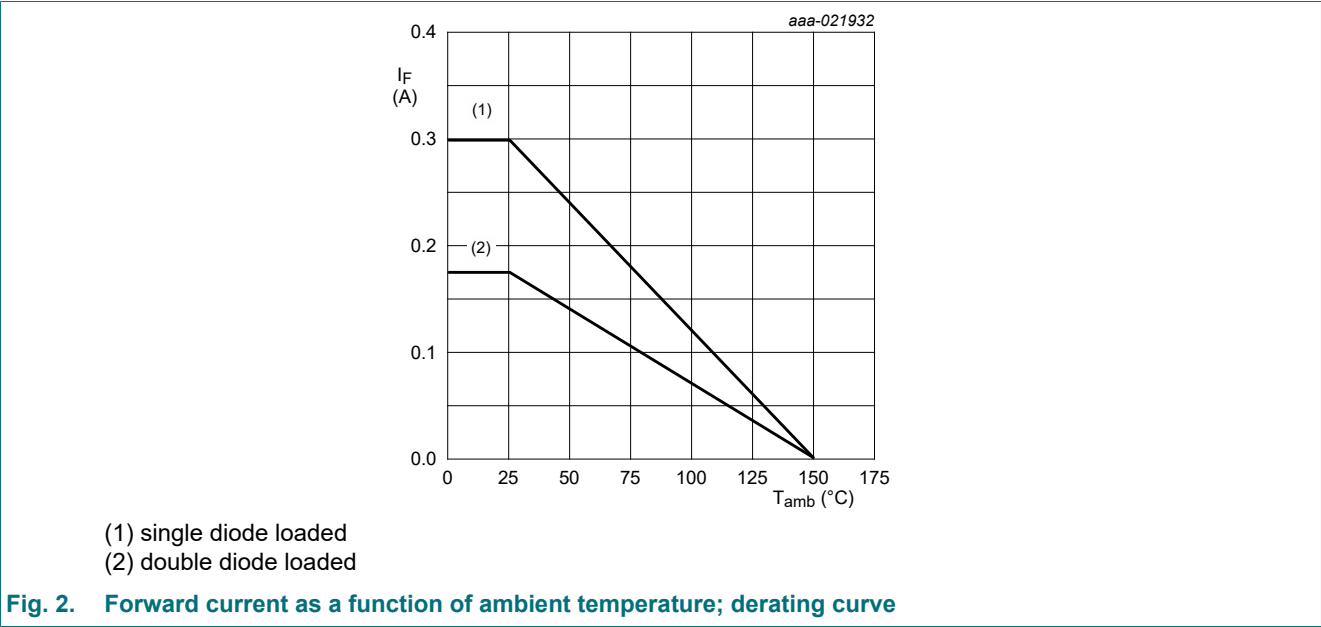
Fig. 1. DFN1010D-3 (SOT1215) binary marking code description

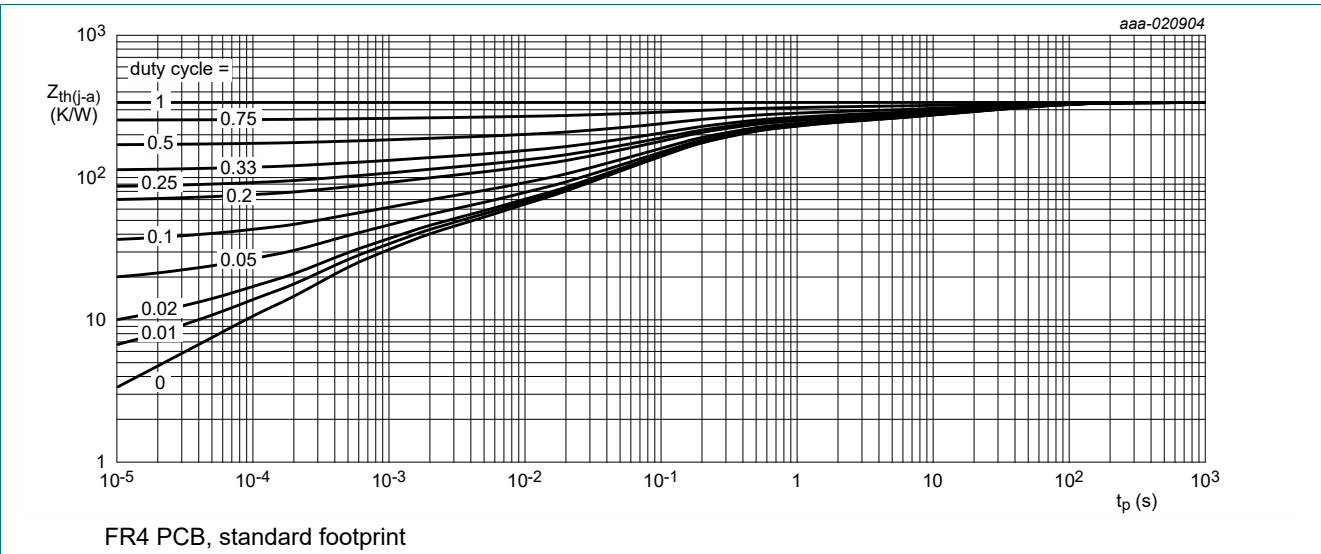


Fig. 3. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

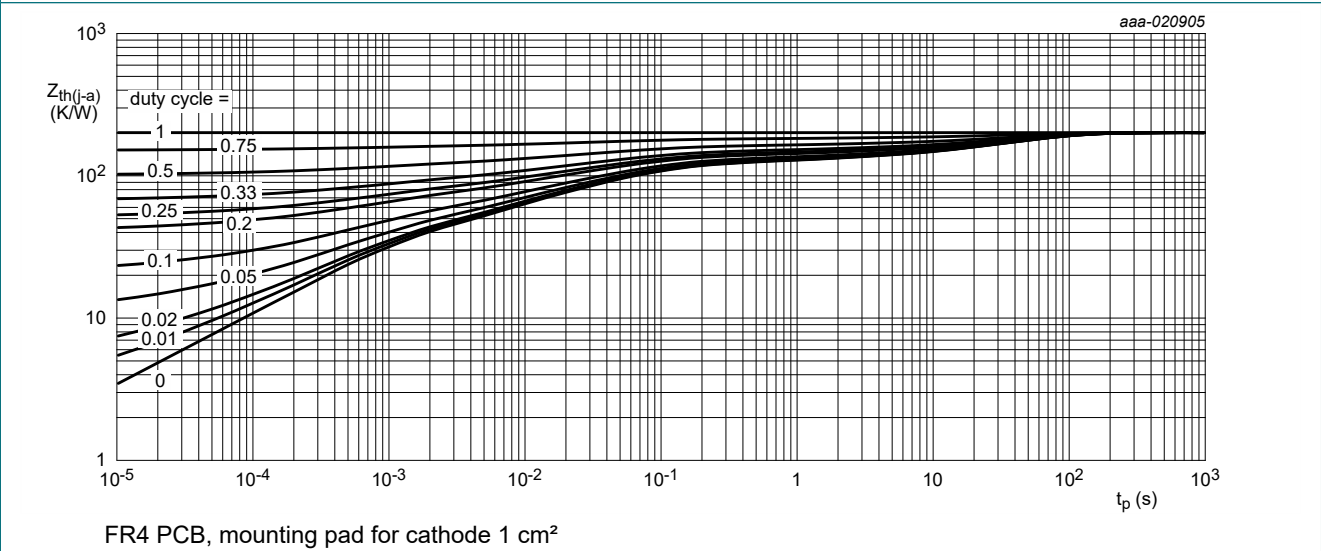


Fig. 4. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

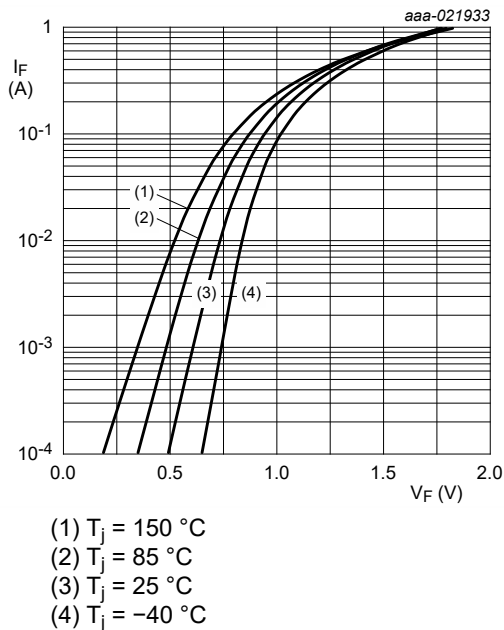


Fig. 5. Forward current as a function of forward voltage; typical values

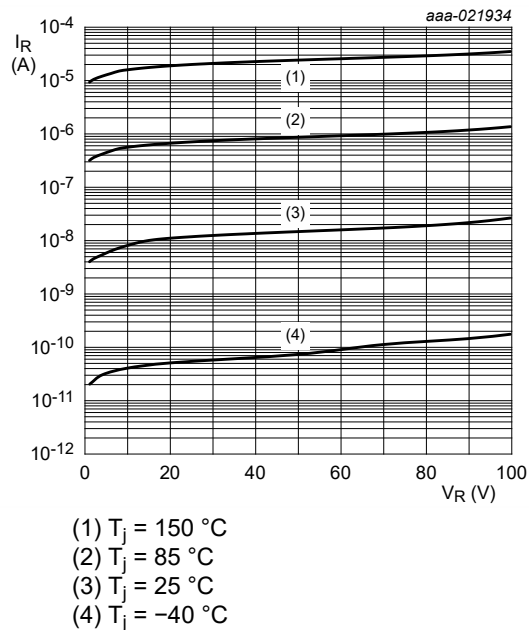
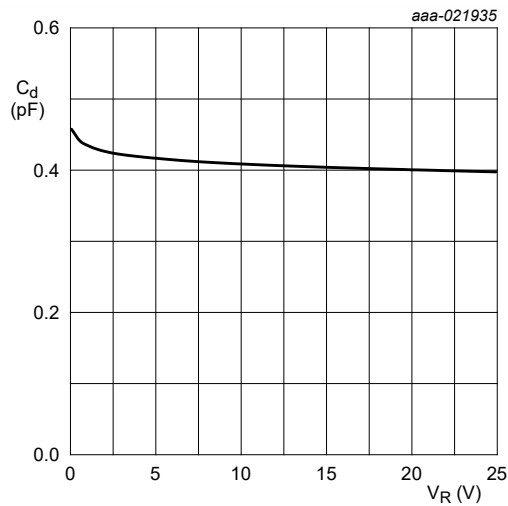
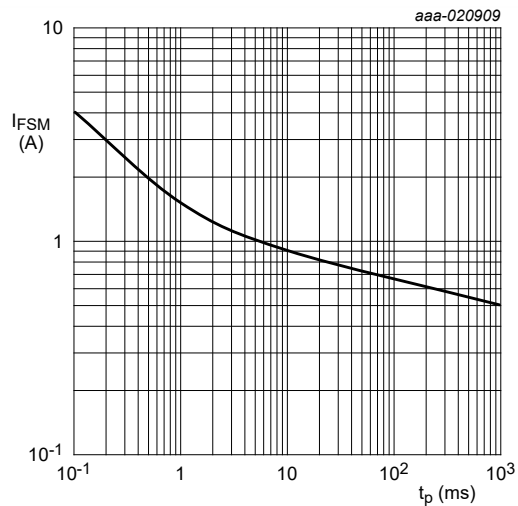


Fig. 6. Reverse current as a function of reverse voltage; typical values

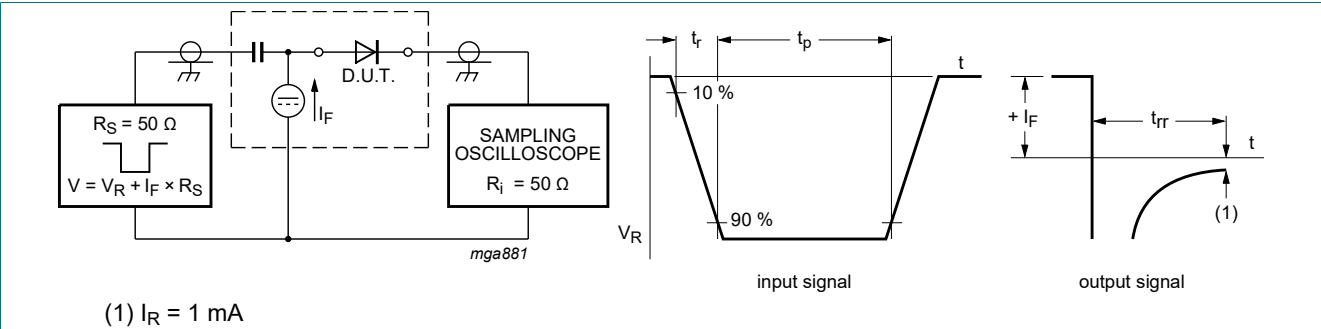


Fig. 9. Reverse recovery time test circuit and waveforms

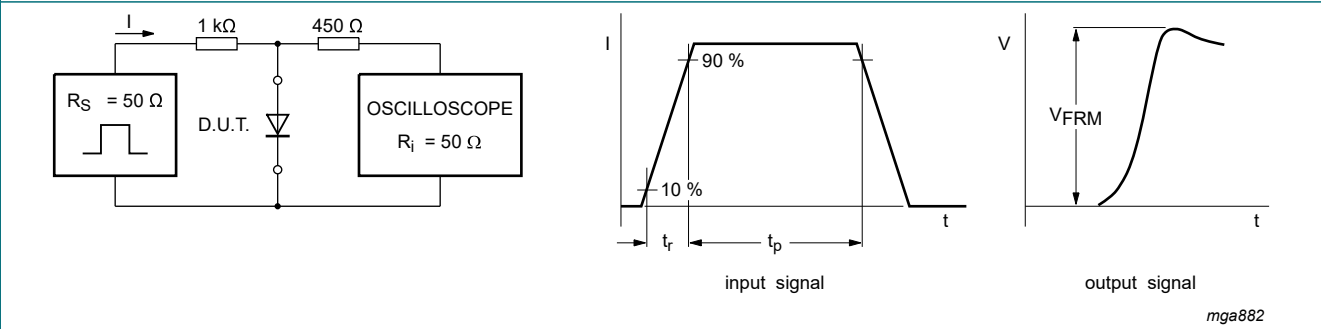


Fig. 10. Forward recovery voltage test circuit and waveforms

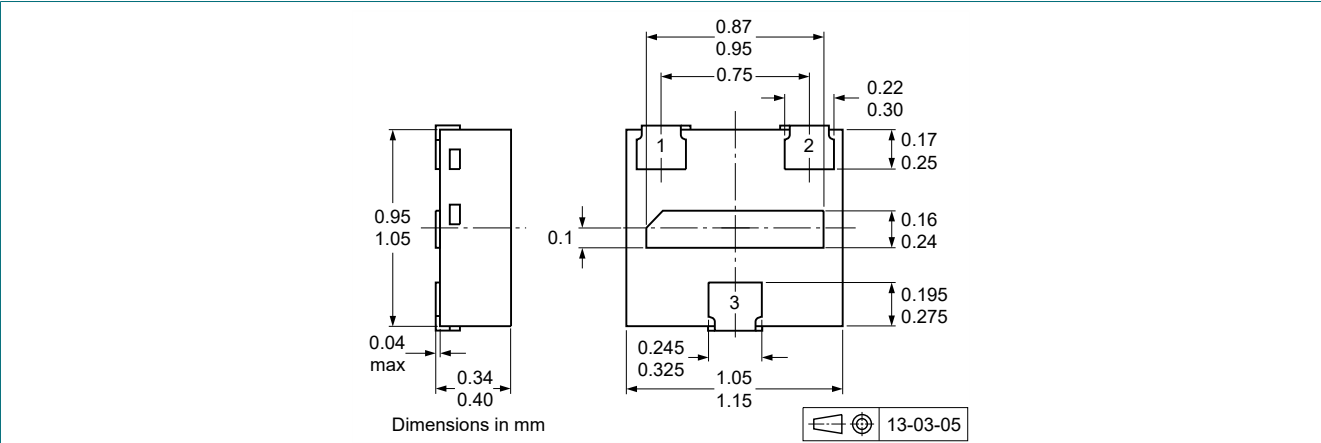
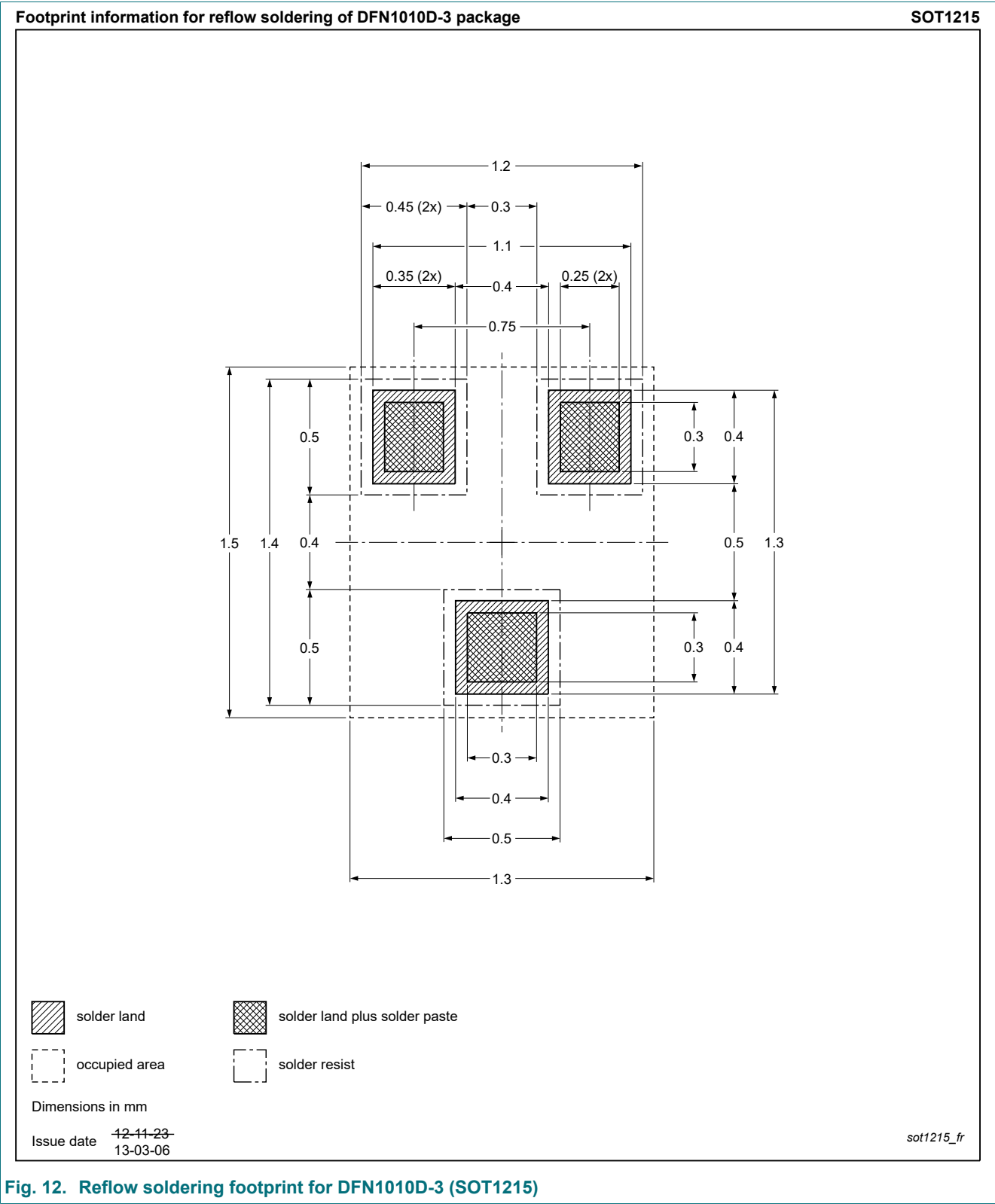


Fig. 11. Package outline DFN1010D-3 (SOT1215)
