









Fig. 4. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values




FR4 PCB; 4-layer copper, standard footprint





DC current gain as a function of collector Fig. 7. current; typical values







Fig. 10. Collector-emitter saturation voltage as a function of collector current; typical values




