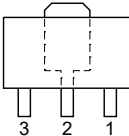


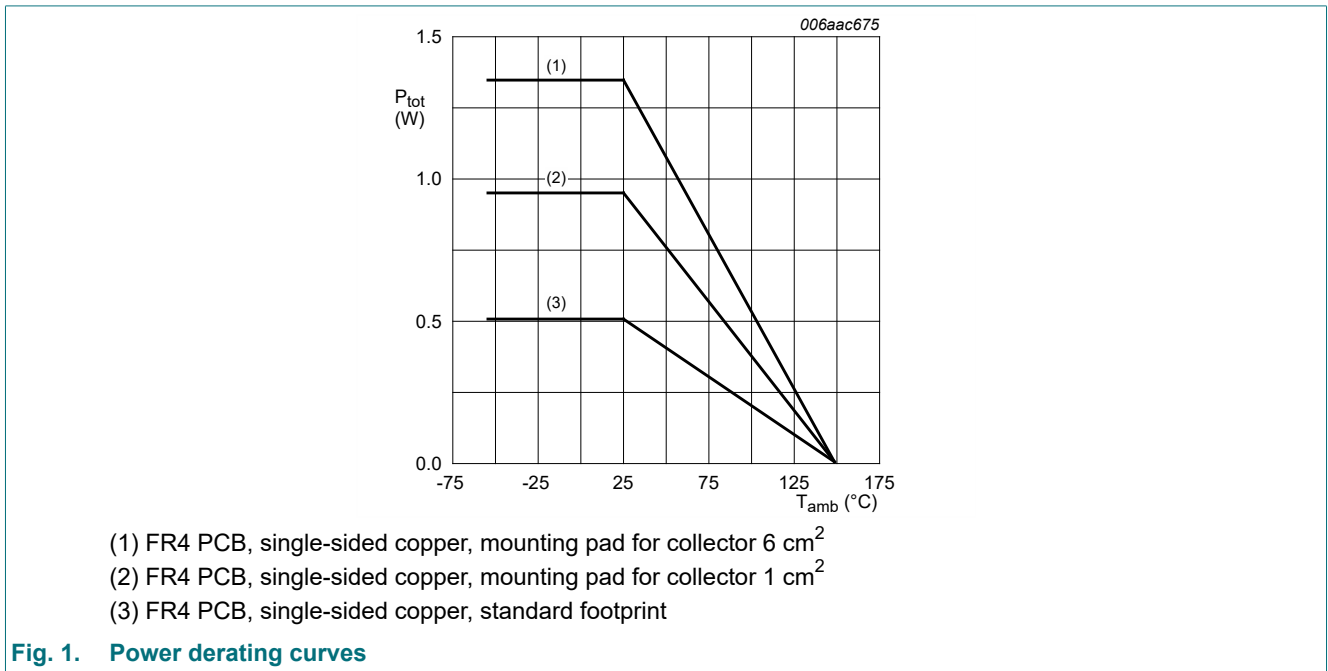

**Fig. 1. Power derating curves**

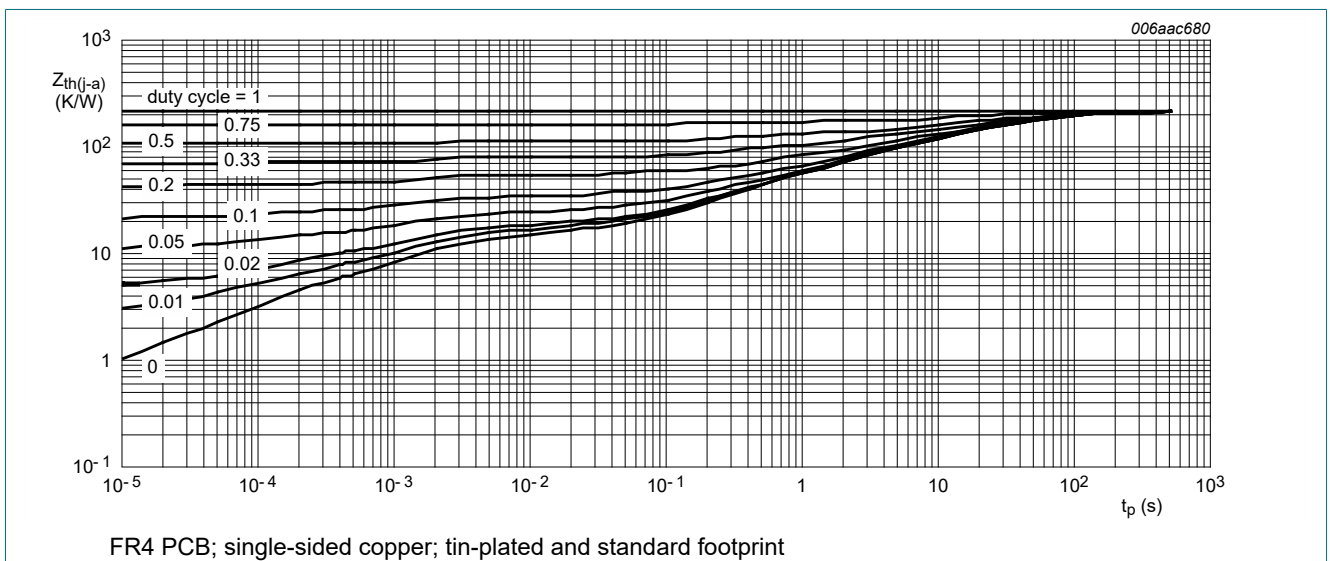

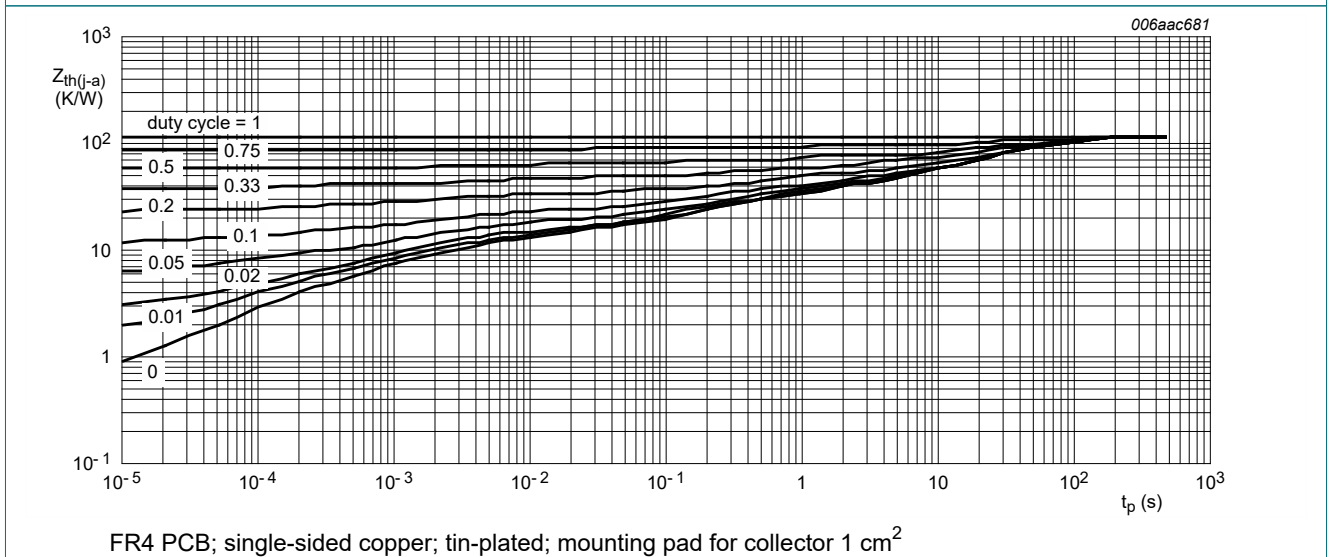

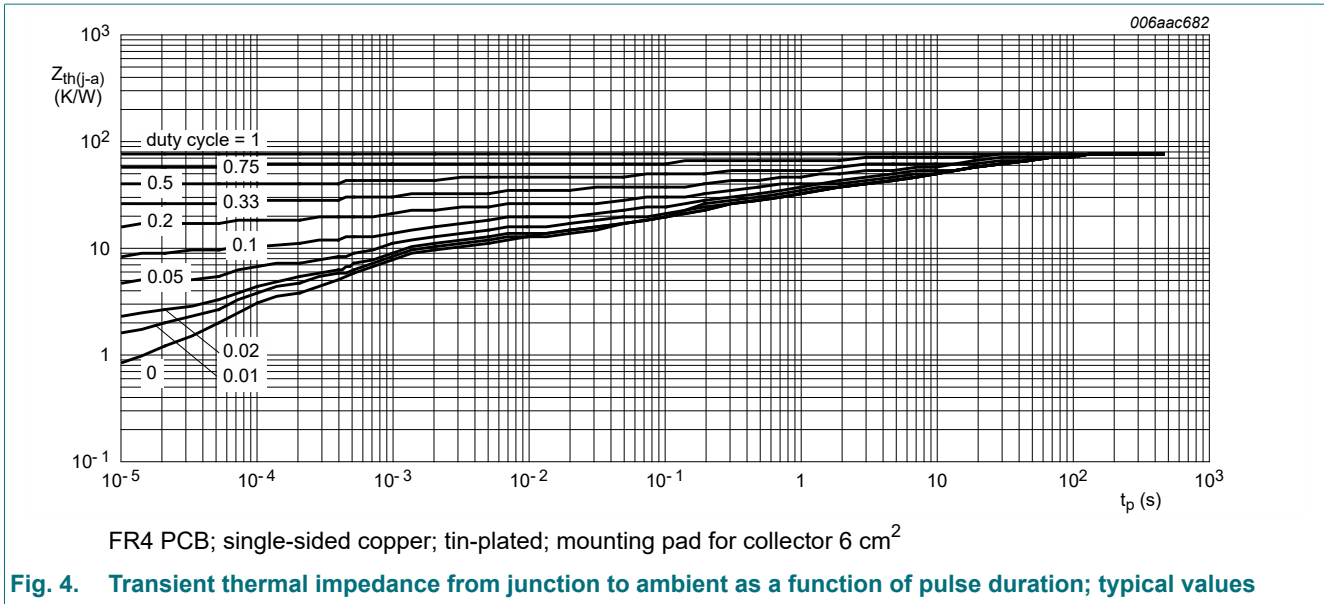

**Fig. 3. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values**

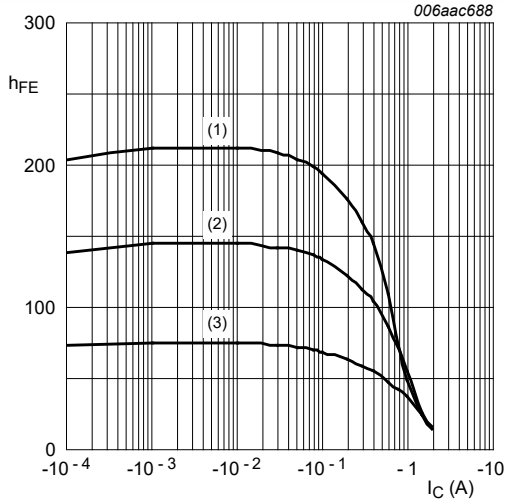

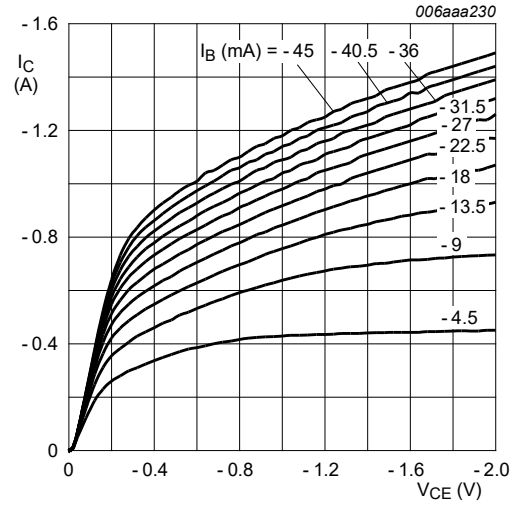

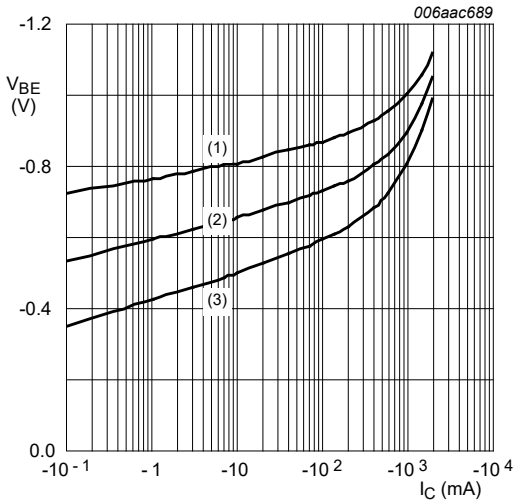

Fig. 5. DC current gain as a function of collector current; typical values



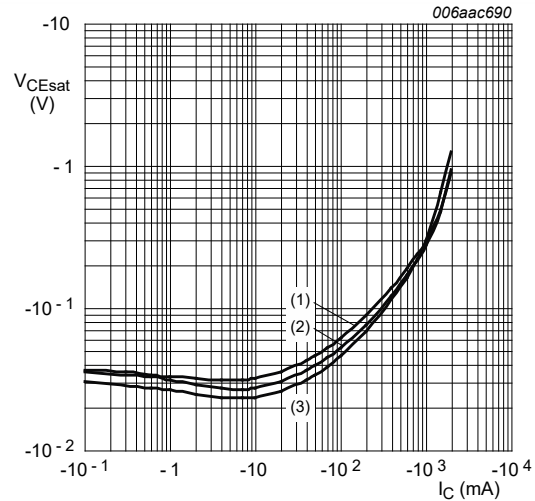

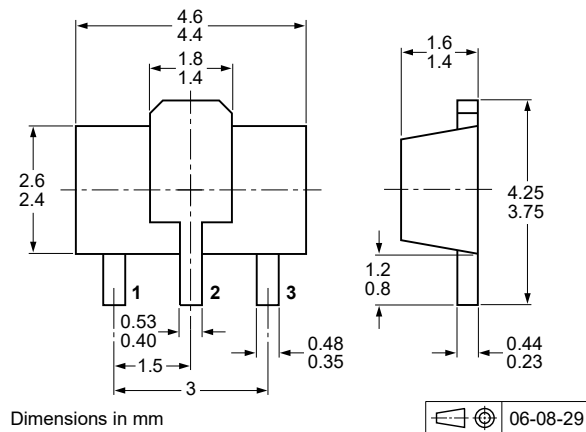


Fig. 9. Package outline SOT89

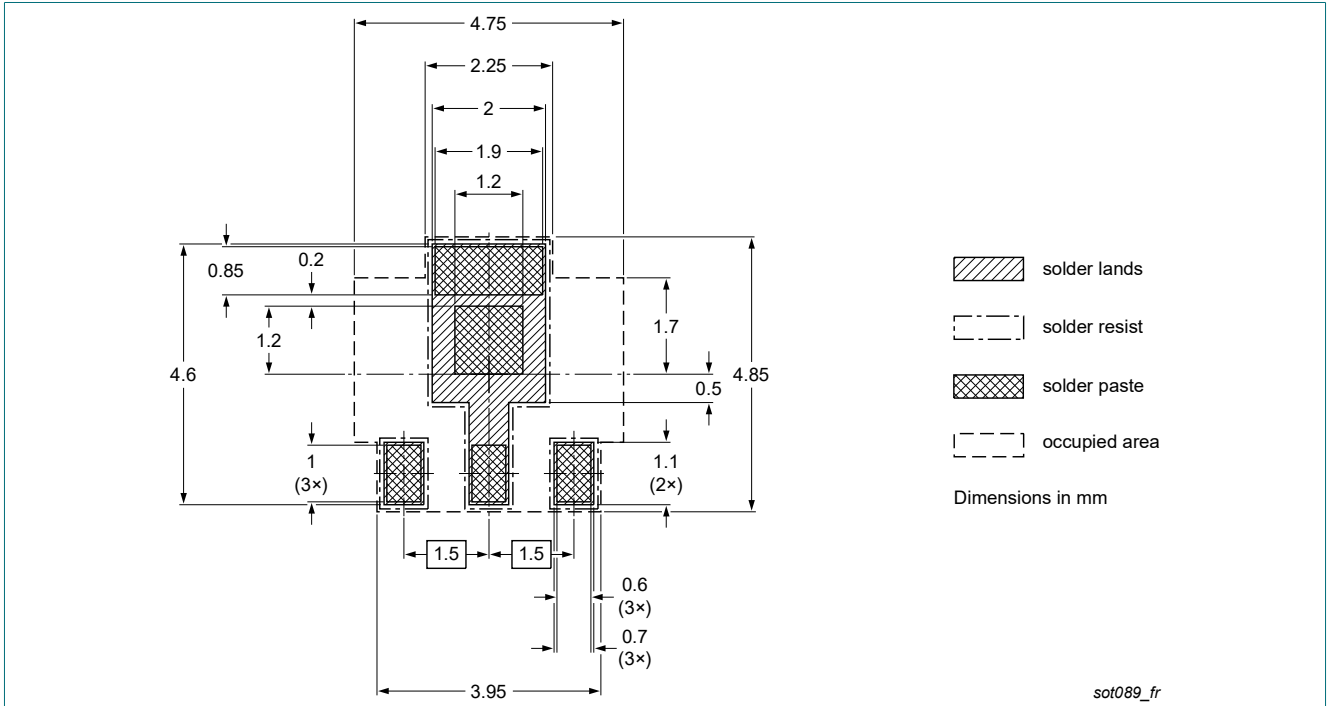


Fig. 10. Reflow soldering footprint for SOT89

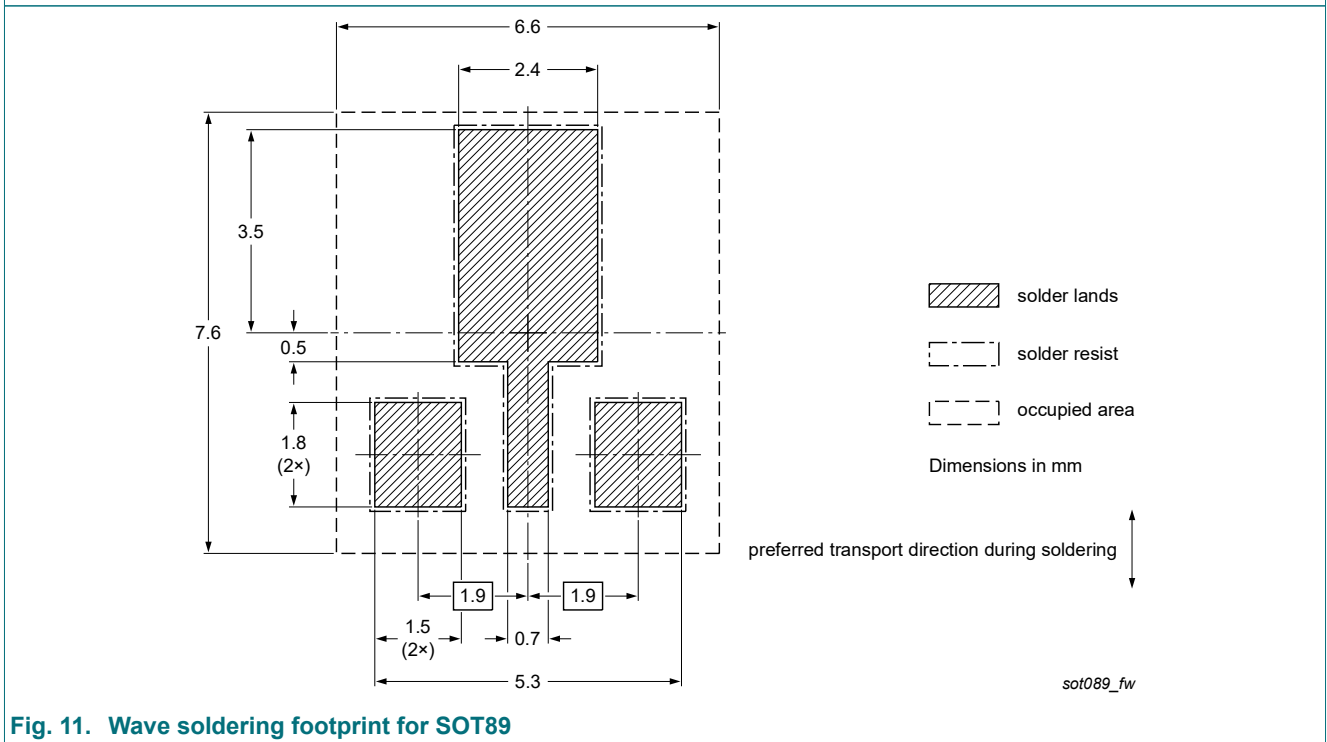


Fig. 11. Wave soldering footprint for SOT89
