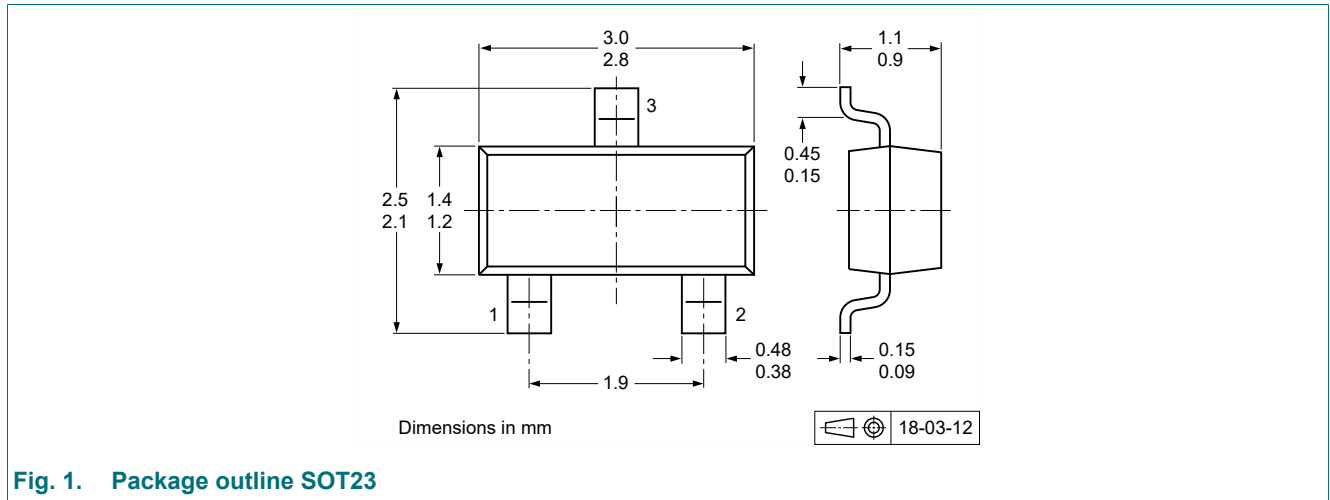


Fig. 1. Package outline SOT23

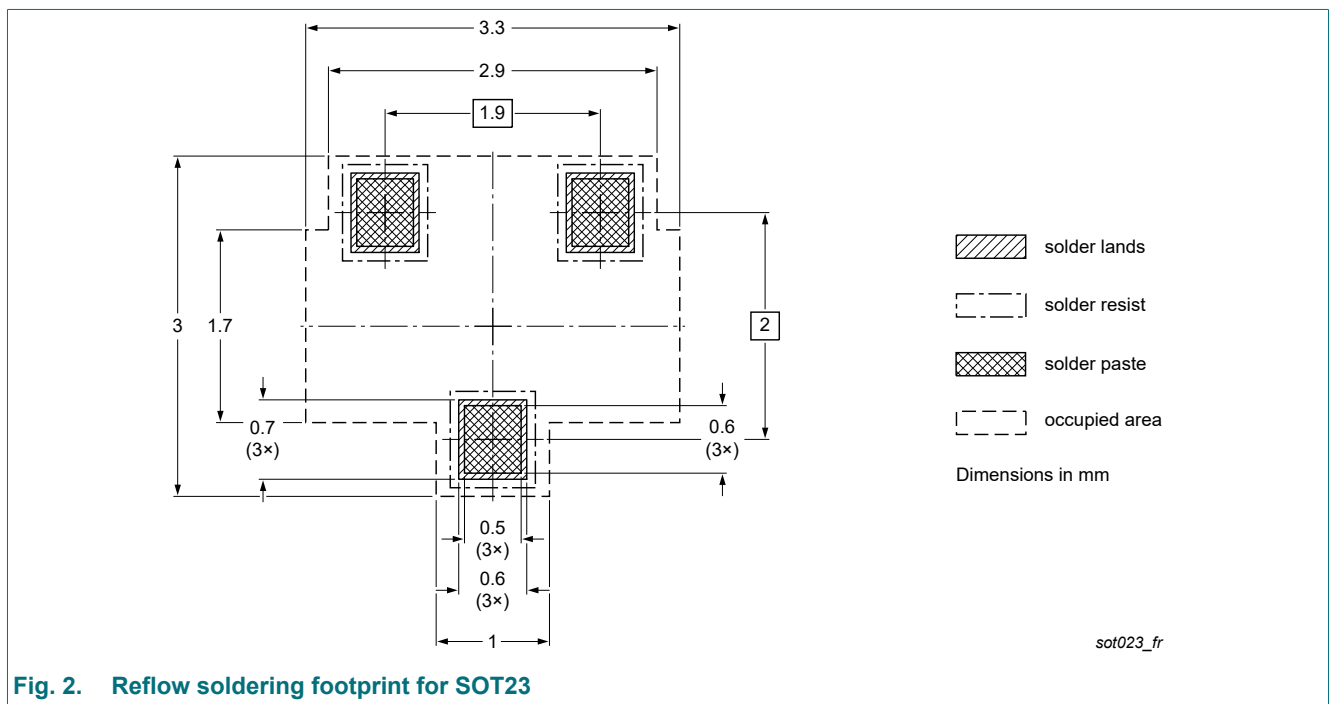


Fig. 2. Reflow soldering footprint for SOT23

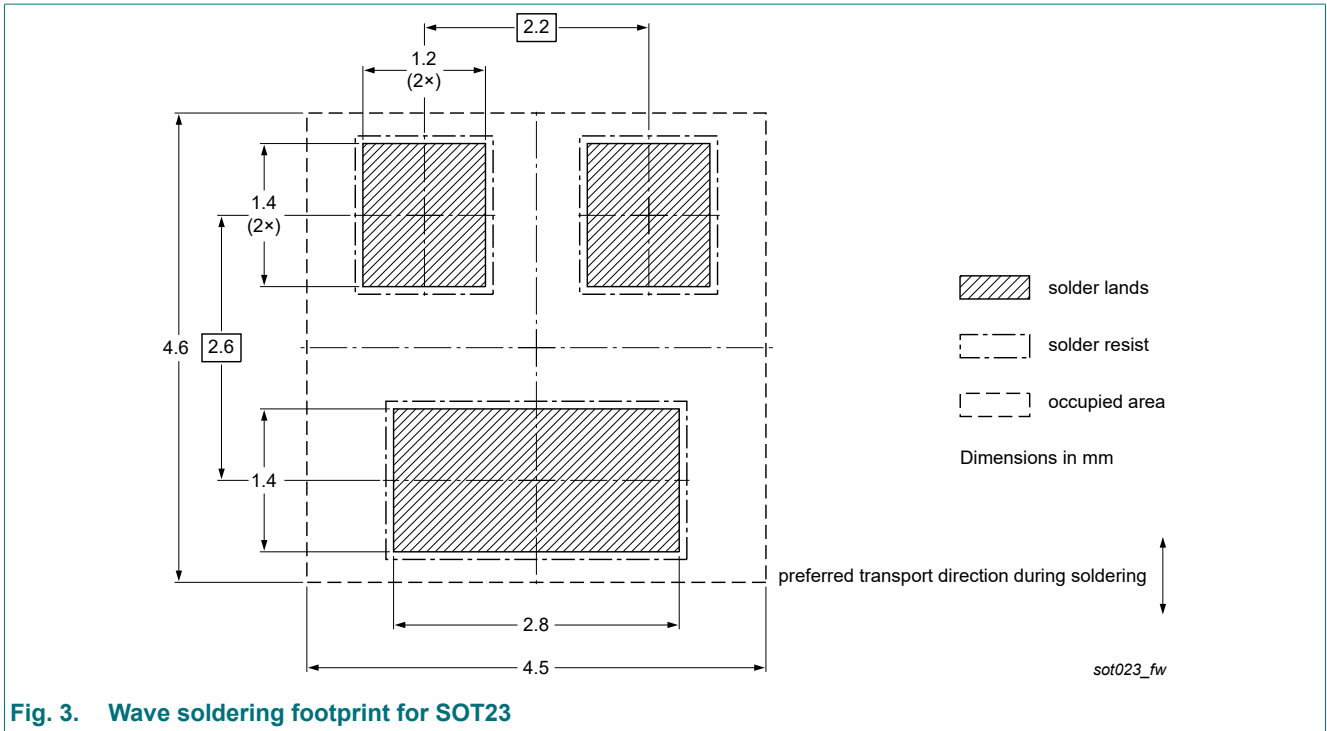


Fig. 3. Wave soldering footprint for SOT23
