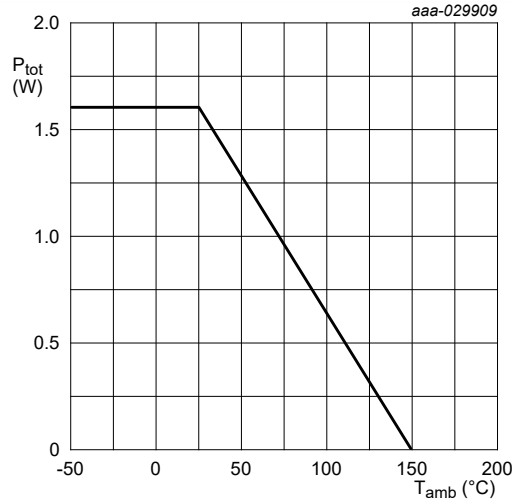

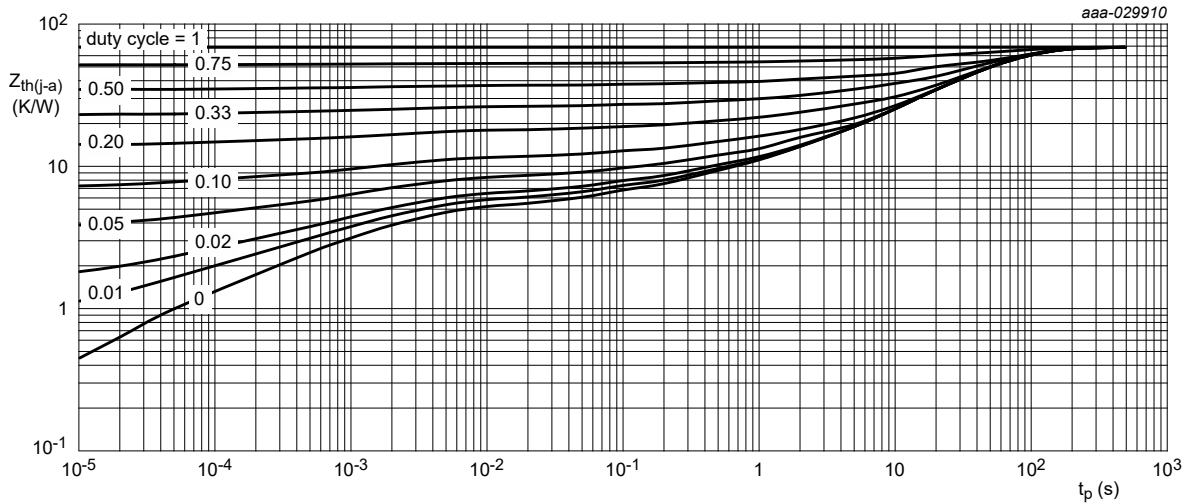
Fig. 1. Power derating curves SOT428C

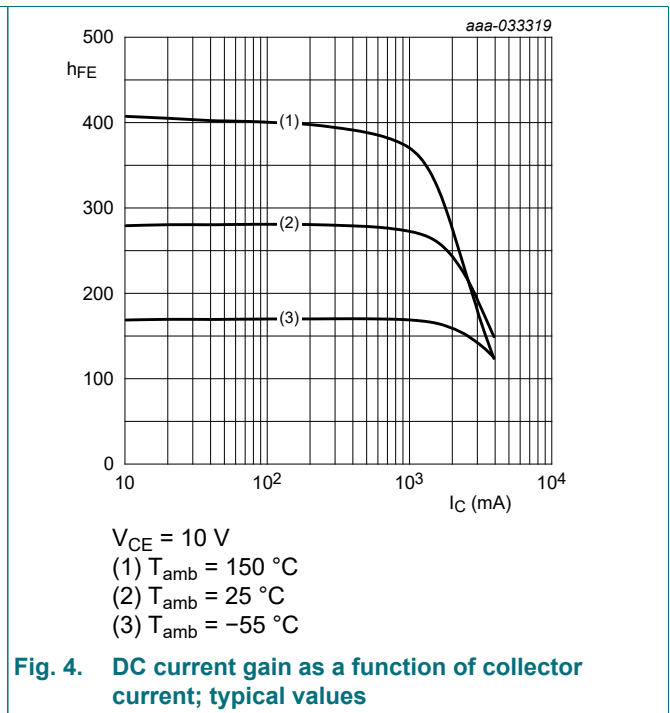
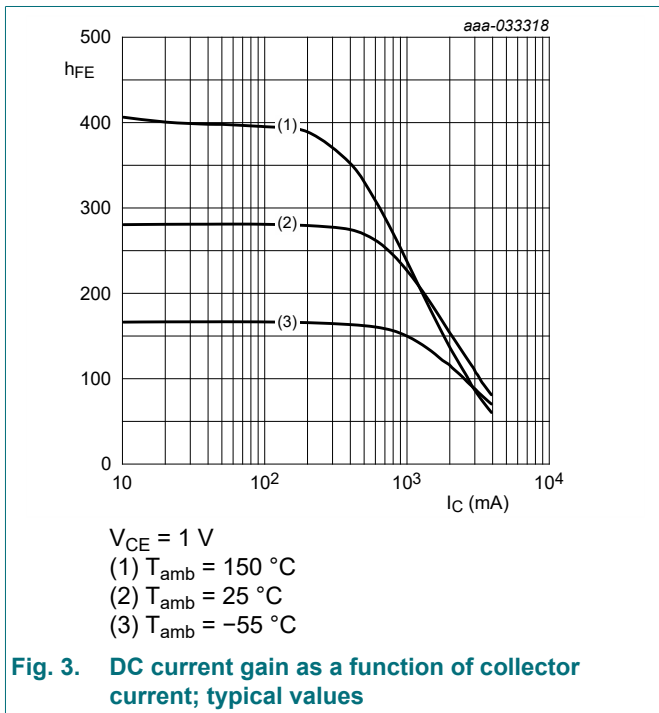
FR4 PCB, single-sided 70 μm copper, tin-plated, mounting pad for collector 1 cm².

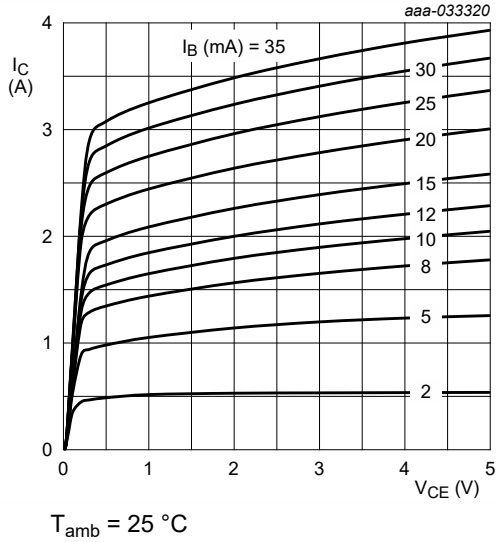


Fig. 5. Collector current as a function of collector-emitter voltage; typical values

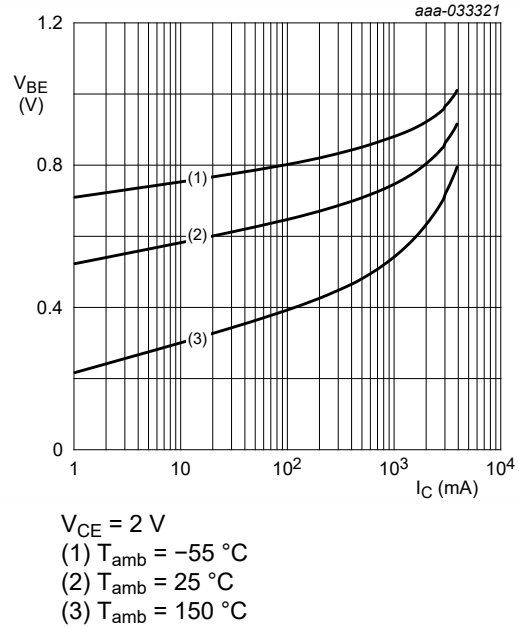


Fig. 6. Base-emitter voltage as a function of collector current; typical values

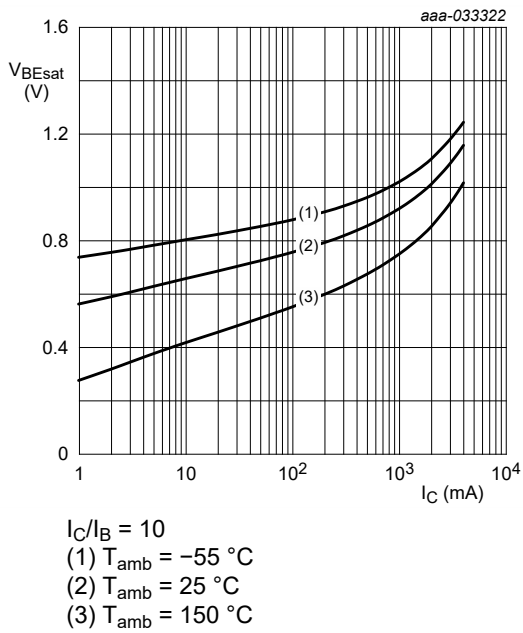


Fig. 7. Base-emitter saturation voltage as a function of collector current; typical values

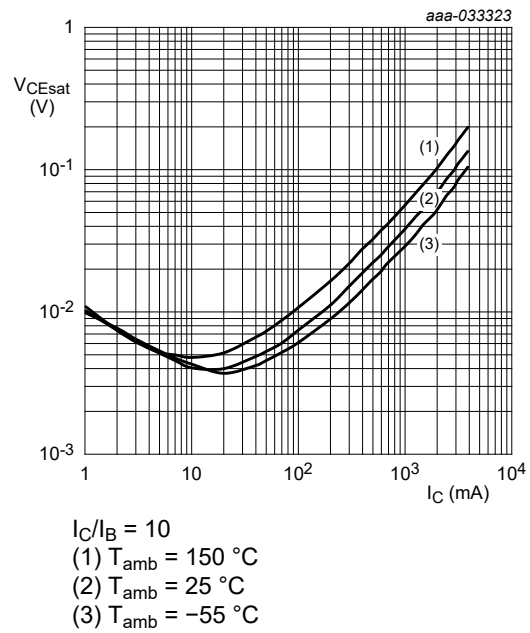
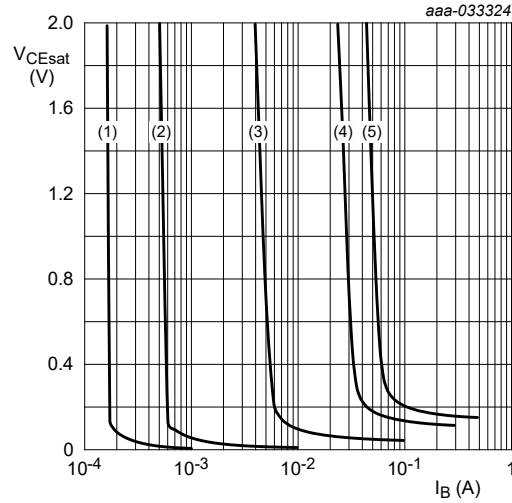


Fig. 8. Collector-emitter saturation voltage as a function of collector current; typical values

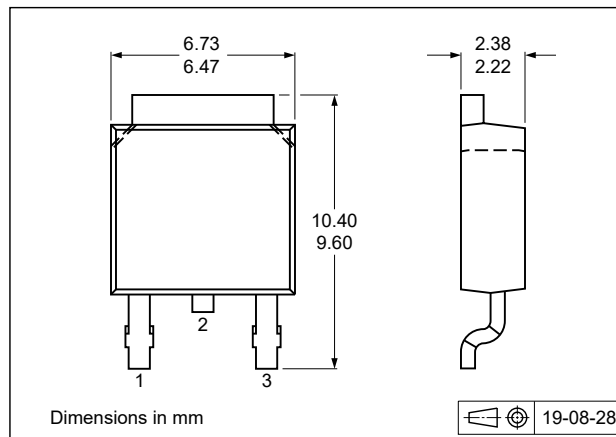


Fig. 10. Package outline DPAK (SOT428C)

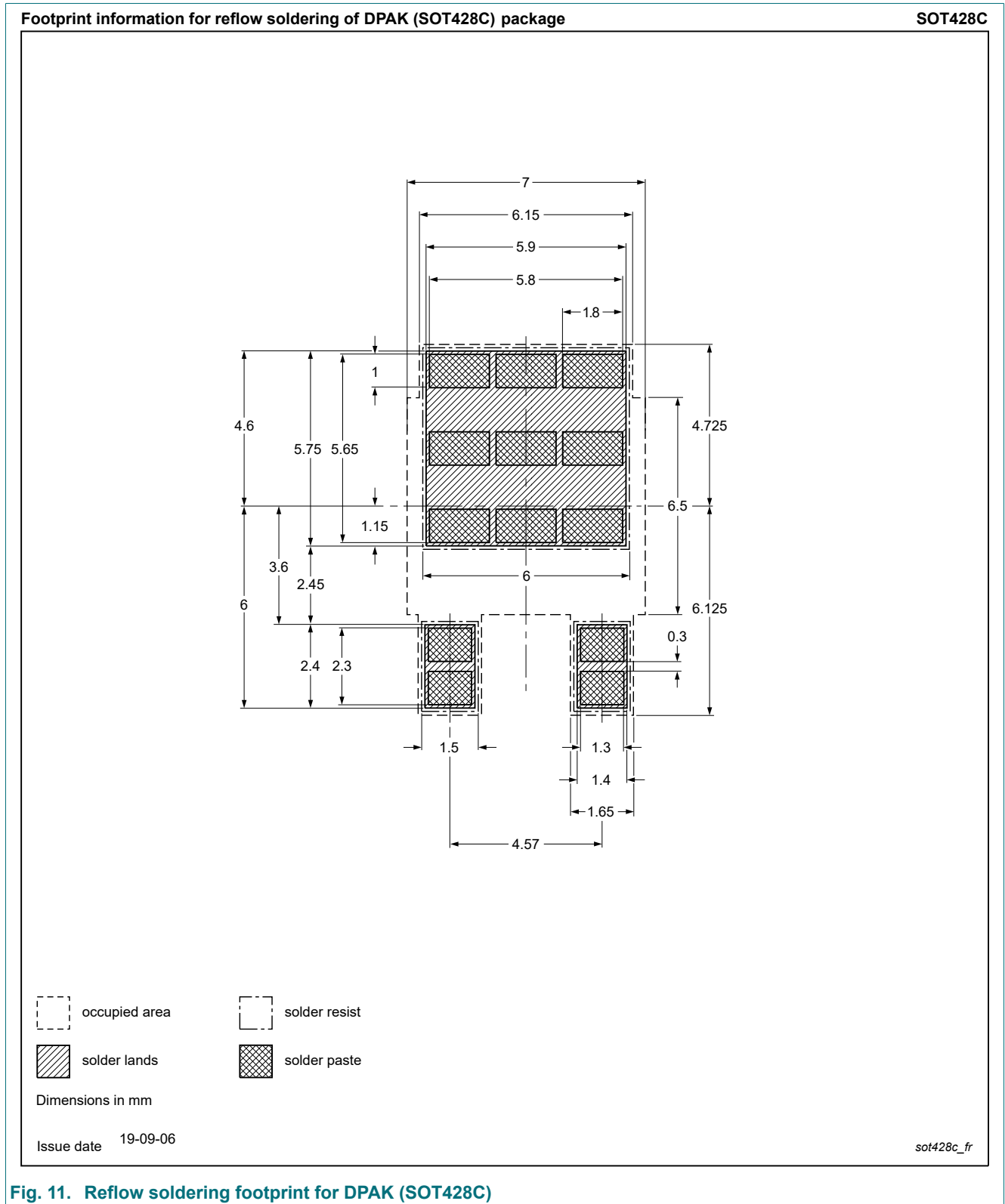


Fig. 11. Reflow soldering footprint for DPAK (SOT428C)
