## 1. General description

ESD protection device in a leadless ultra small DFN1006BD-2 (SOD882BD) Surface-Mounted Device (SMD) plastic package with side-wettable flanks, designed to protect one line from the damage caused by ElectroStatic Discharge (ESD) and other transients.

- Reverse stand-off voltage:  $V_{RWM} = 27\text{ V}$
- Low clamping voltage:  $V_{CL} = 36\text{ V}$  at  $I_{PP} = 3\text{ A}$
- ESD protection up to 30 kV (IEC 61000-4-2)
- Low capacitance:  $C_d = 14\text{ pF}$
- High temperature capability:  $T_j = 150\text{ °C}$

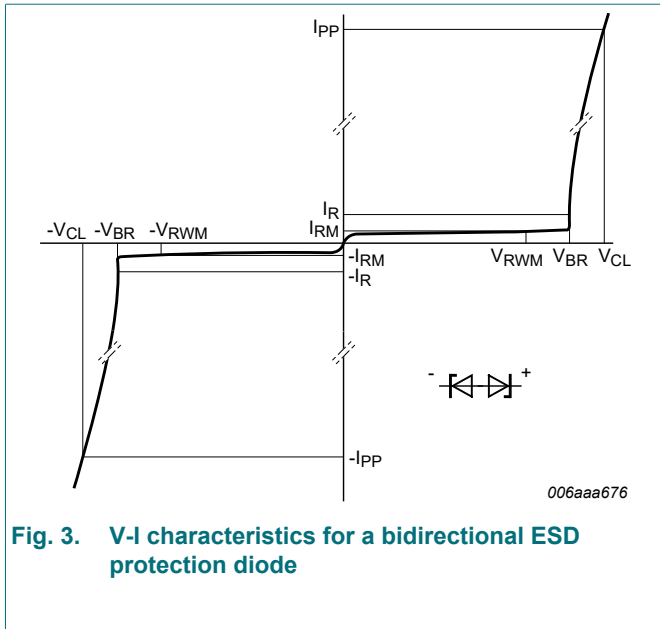


Fig. 3. V-I characteristics for a bidirectional ESD protection diode

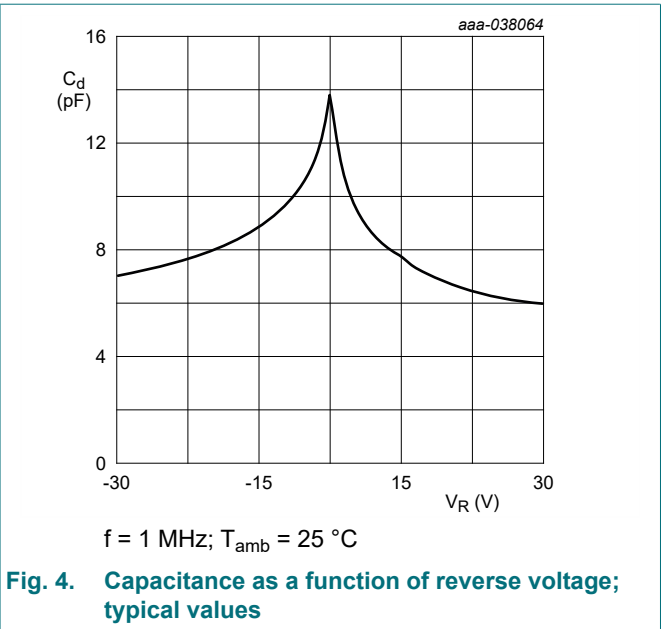
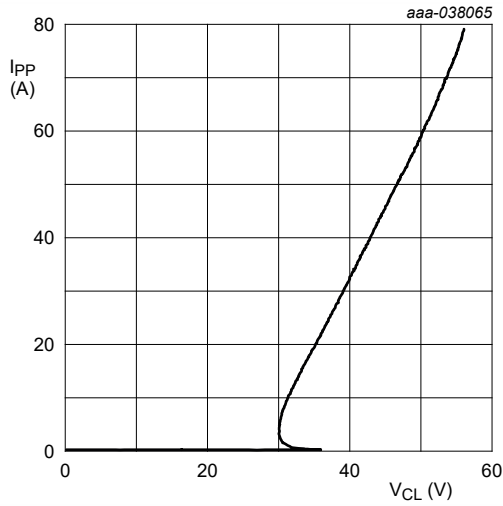


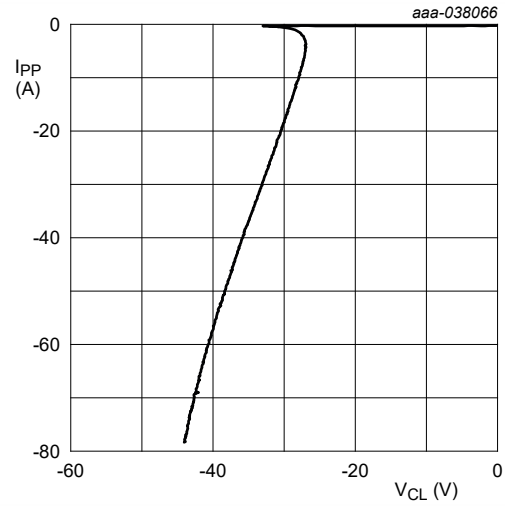
Fig. 4. Capacitance as a function of reverse voltage; typical values

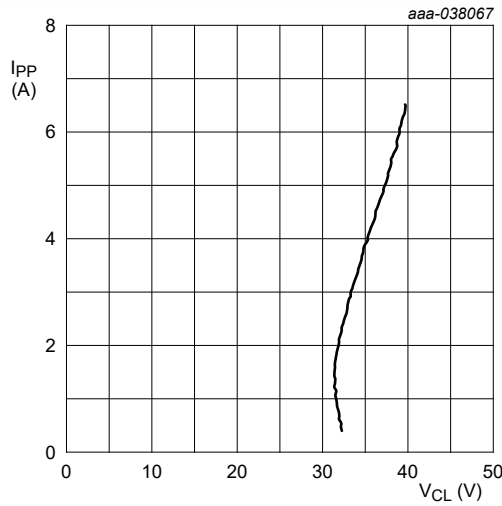
Transmission Line Pulse (TLP);

**Fig. 6. Dynamic resistance with negative clamping; typical values**

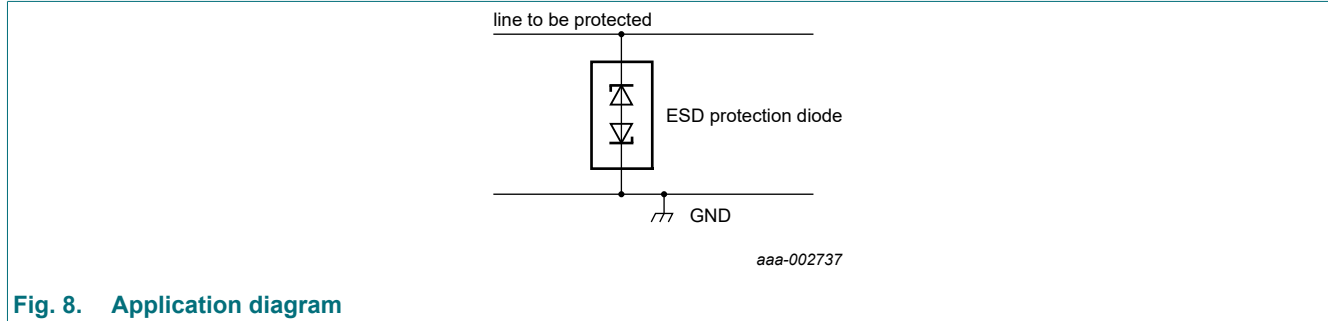


IEC 61000-4-5;  $t_p = 8/20 \text{ }\mu\text{s}$ ; positive pulse

## 10. Application information

The device is designed for the protection of one bidirectional data line from surge pulses and ESD damage. The device is suitable on lines where the signal polarities are both positive and negative with respect to ground.

### Circuit board layout and protection device placement

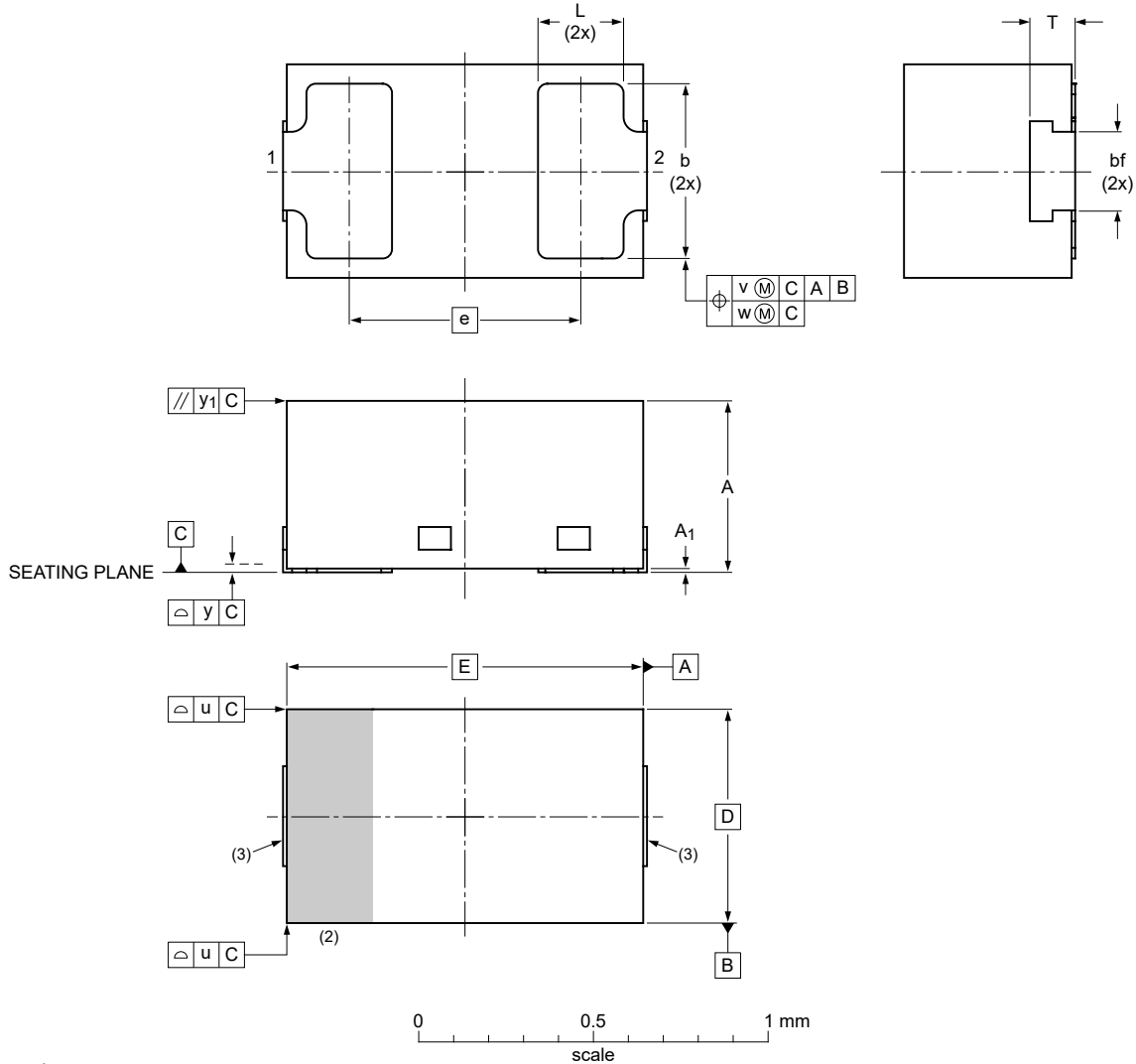
Circuit board layout is critical for the suppression of ESD, Electrical Fast Transient (EFT) and surge transients. The following guidelines are recommended:

1. Place the device as close to the input terminal or connector as possible.
2. Minimize the path length between the device and the protected line.
3. Keep parallel signal paths to a minimum.
4. Avoid running protected conductors in parallel with unprotected conductors.
5. Minimize all Printed-Circuit Board (PCB) conductive loops including power and ground loops.
6. Minimize the length of the transient return path to ground.
7. Avoid using shared transient return paths to a common ground point.
8. Use ground planes whenever possible. For multilayer PCBs, use ground vias.

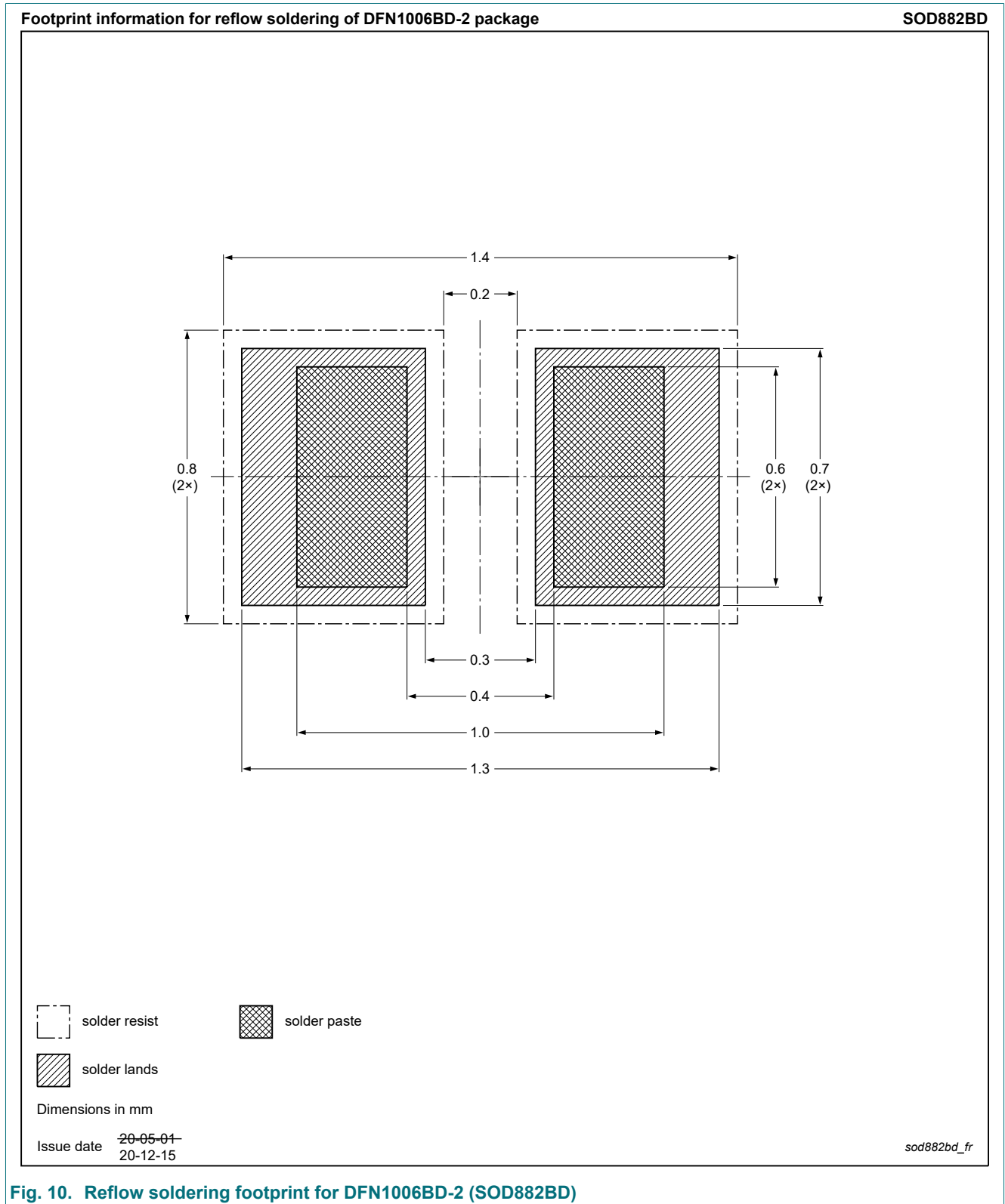


Fig. 10. Reflow soldering footprint for DFN1006BD-2 (SOD882BD)
