Low capacitance unidirectional double ESD protection diode

## 1. General description

Unidirectional double ElectroStatic Discharge (ESD) protection diode in a common anode configuration, encapsulated in a SOT23 (TO-236AB) small Surface-Mounted Device (SMD) plastic package. The device is designed for ESD and transient overvoltage protection of up to two signal lines.

## 2. Features and benefits

- Unidirectional ESD protection of two lines
- Bidirectional ESD protection of one line
- Reverse stand-off voltage:  $V_{RWM} = 4.5\text{ V}$
- Low clamping voltage:  $V_{CL} = 13.6\text{ V typ. at } I_{PP} = 15\text{ A}$
- ESD protection up to 30 kV (IEC 61000-4-2)
- Ultra low leakage current:  $I_{RM} < 10\text{ nA}$
- Qualified according to AEC-Q101 and recommended for use in automotive applications

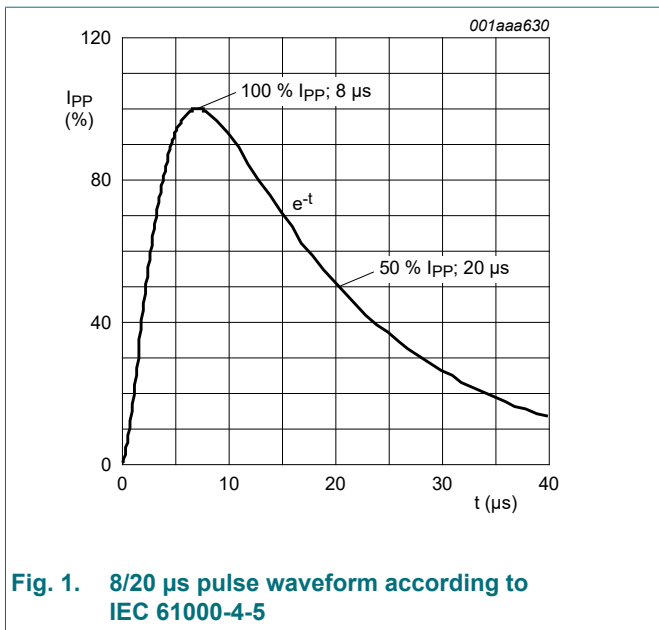

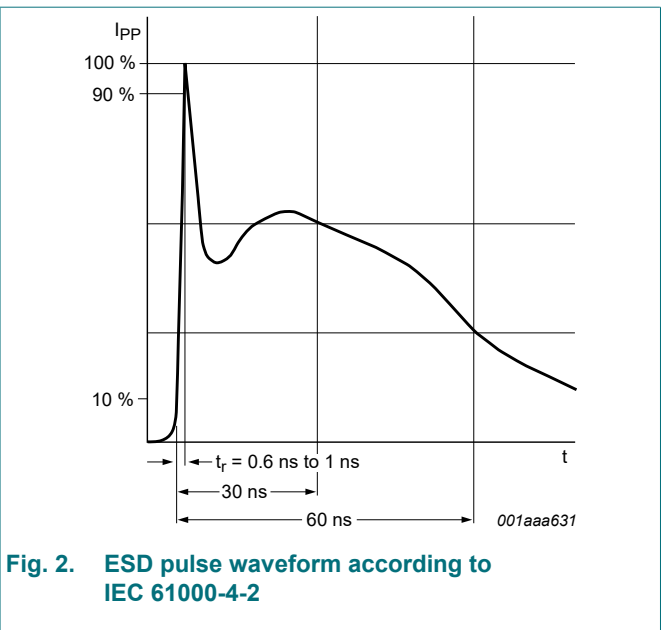

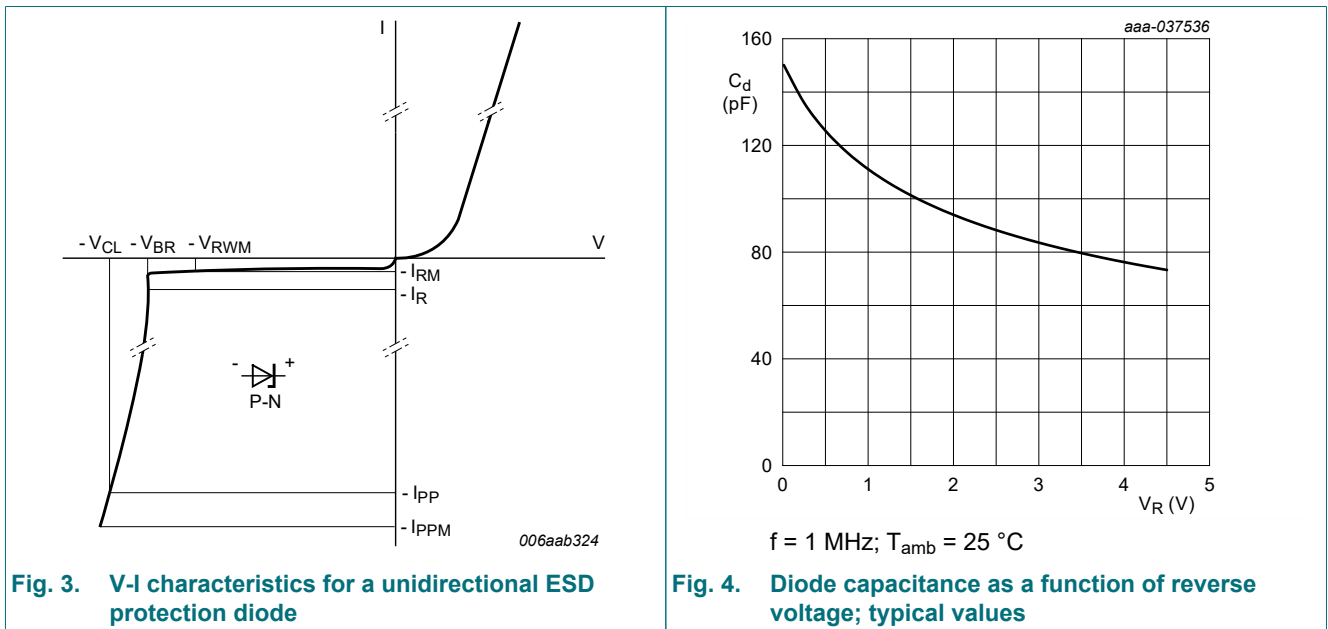


Fig. 3. V-I characteristics for a unidirectional ESD protection diode

Fig. 4. Diode capacitance as a function of reverse voltage; typical values

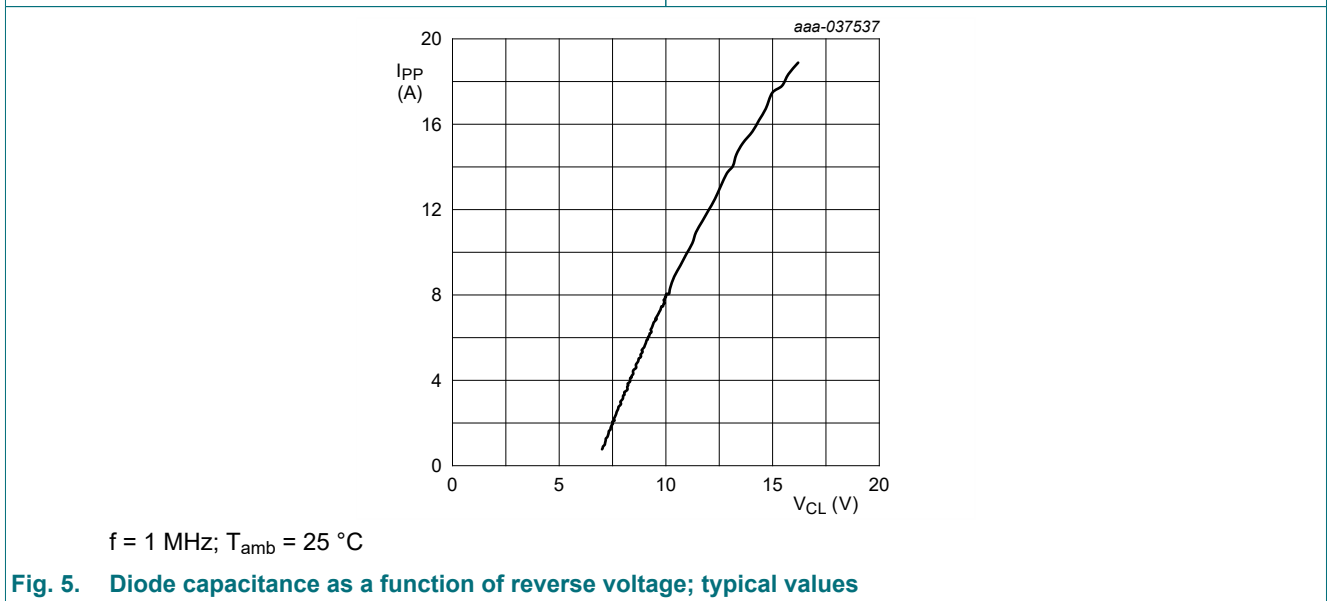
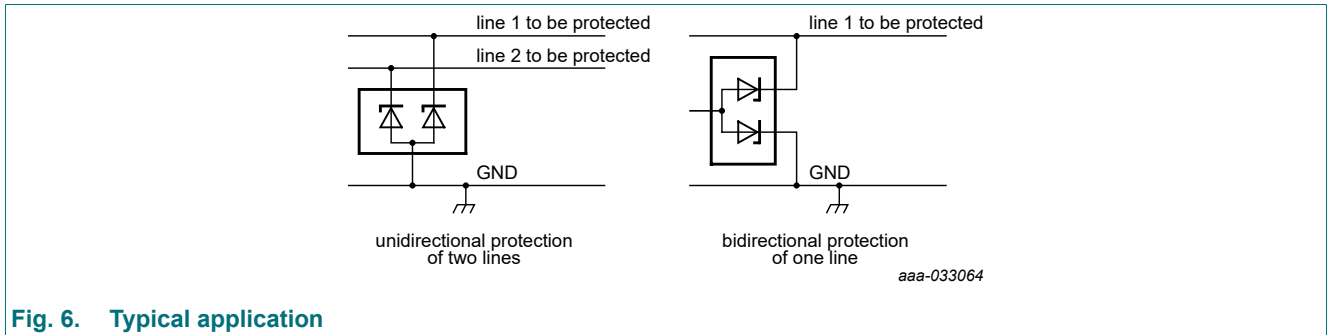


Fig. 5. Diode capacitance as a function of reverse voltage; typical values

## 11. Application information

The device is designed for the protection of two lines from the damage caused by ESD and surge pulses.



### Circuit board layout and protection device placement

Circuit board layout is critical for the suppression of ESD, Electrical Fast Transient (EFT) and surge transients. The following guidelines are recommended:

1. Place the device as close to the input terminal or connector as possible.
2. Minimize the path length between the device and the protected line.
3. Keep parallel signal paths to a minimum.
4. Avoid running protected conductors in parallel with unprotected conductors.
5. Minimize all Printed-Circuit Board (PCB) conductive loops including power and ground loops.
6. Minimize the length of the transient return path to ground.
7. Avoid using shared transient return paths to a common ground point.
8. Use ground planes whenever possible. For multilayer PCBs, use ground vias.

## 12. Test information

### Quality information

This product has been qualified in accordance with the Automotive Electronics Council (AEC) standard Q101 - *Stress test qualification for discrete semiconductors*, and is suitable for use in automotive applications.

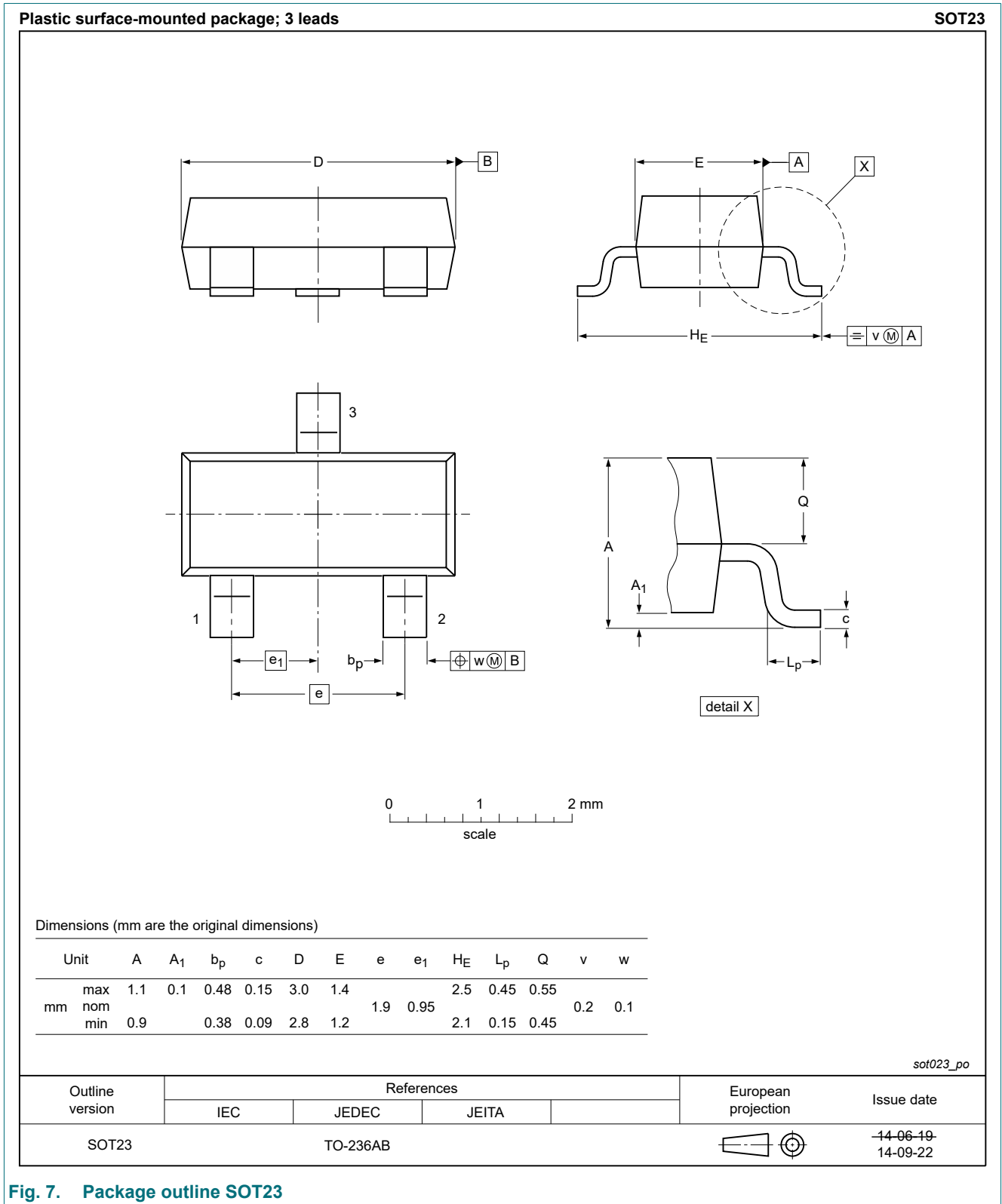


Fig. 7. Package outline SOT23

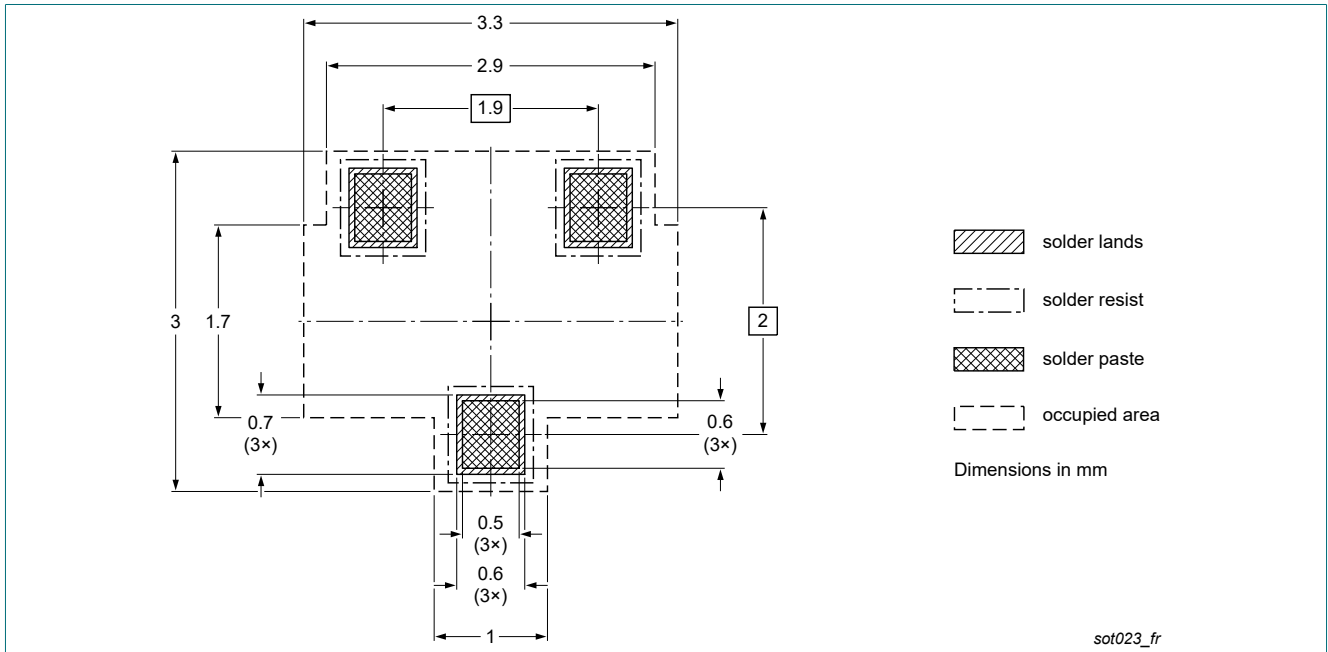


Fig. 8. Reflow soldering footprint for SOT23

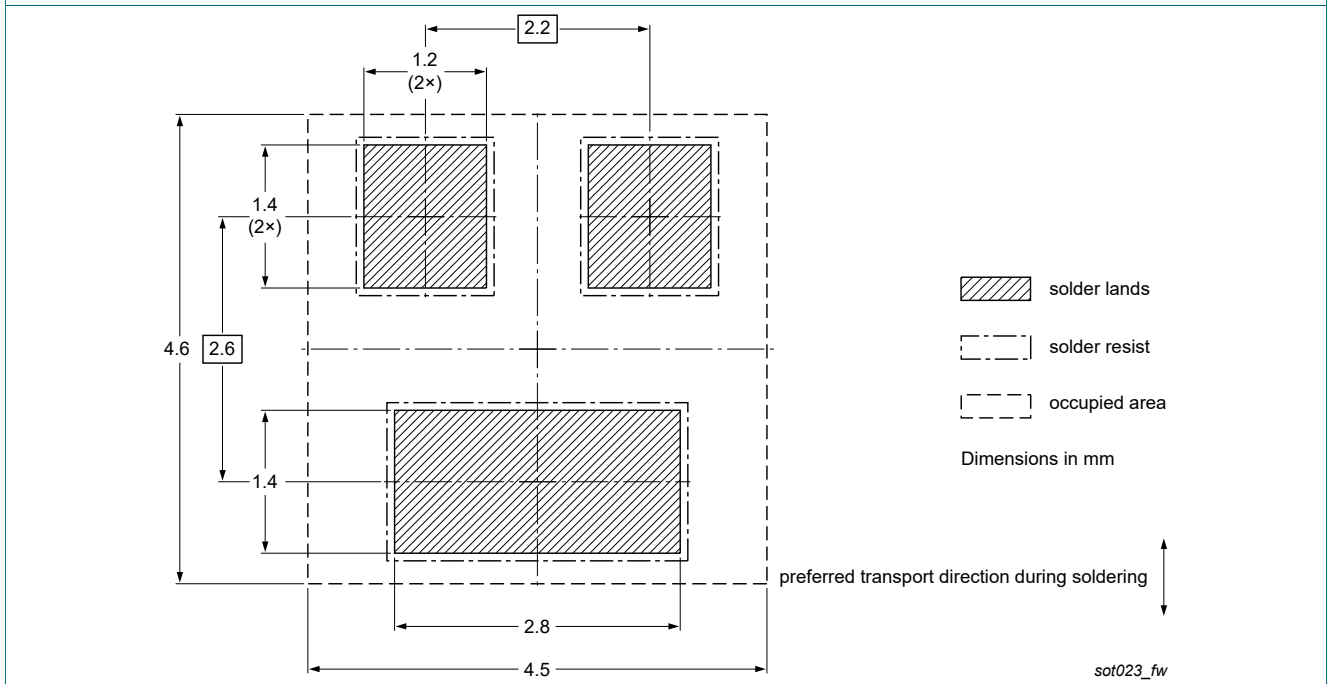


Fig. 9. Wave soldering footprint for SOT23
