


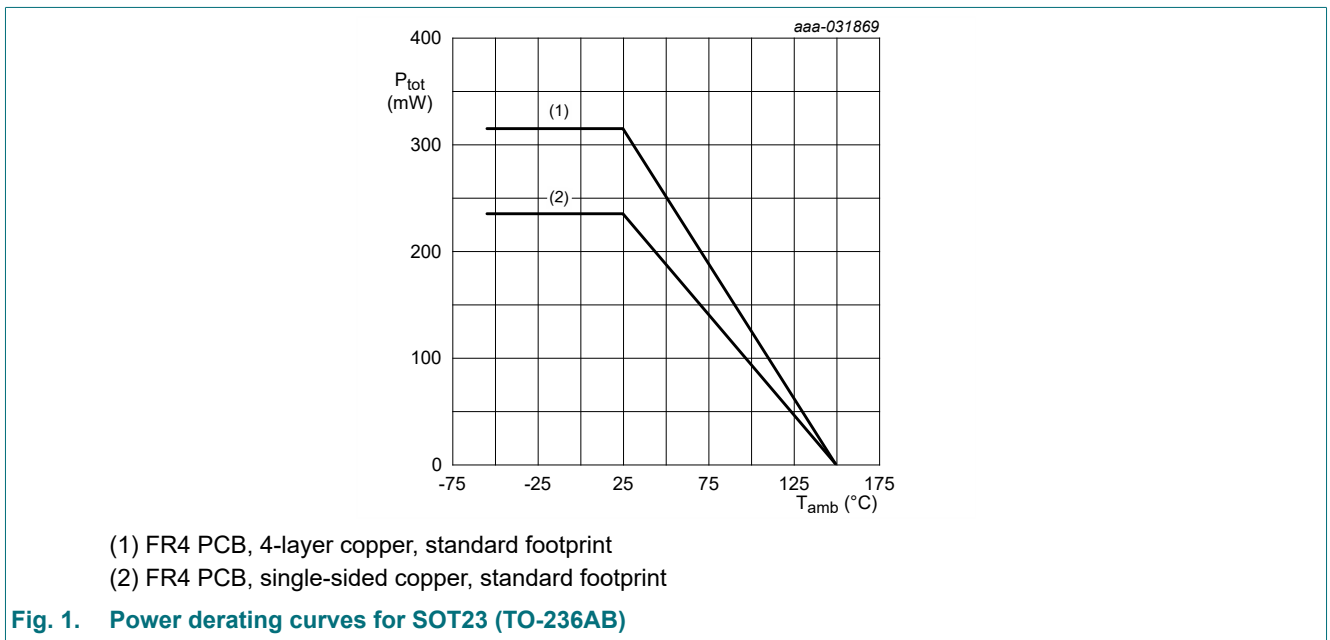


Fig. 1. Power derating curves for SOT23 (TO-236AB)

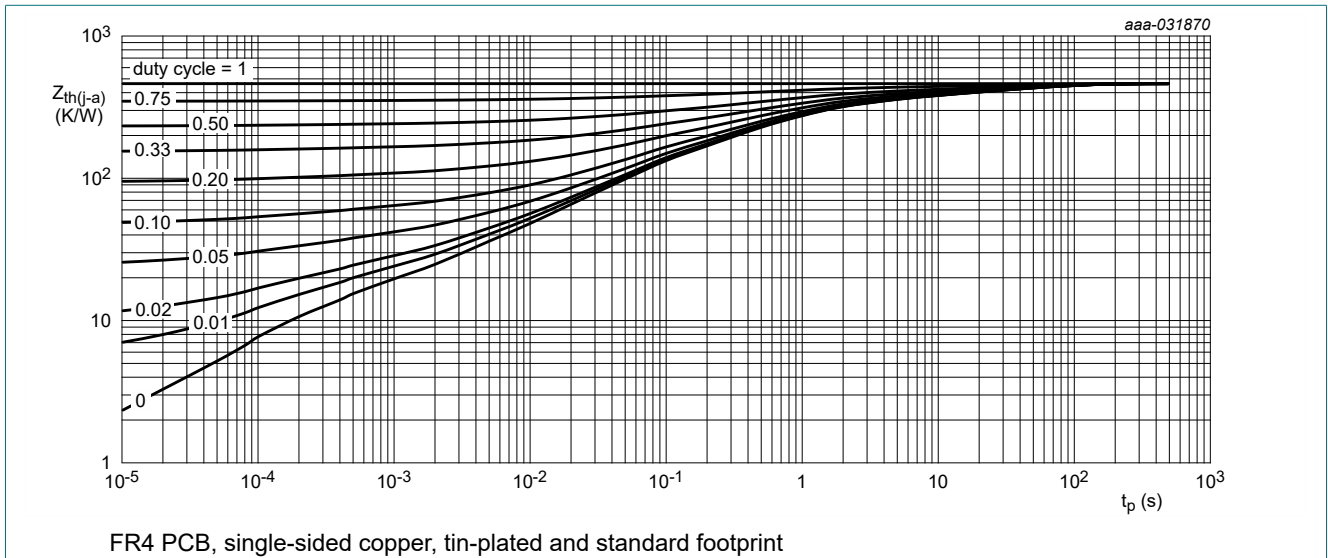


Fig. 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

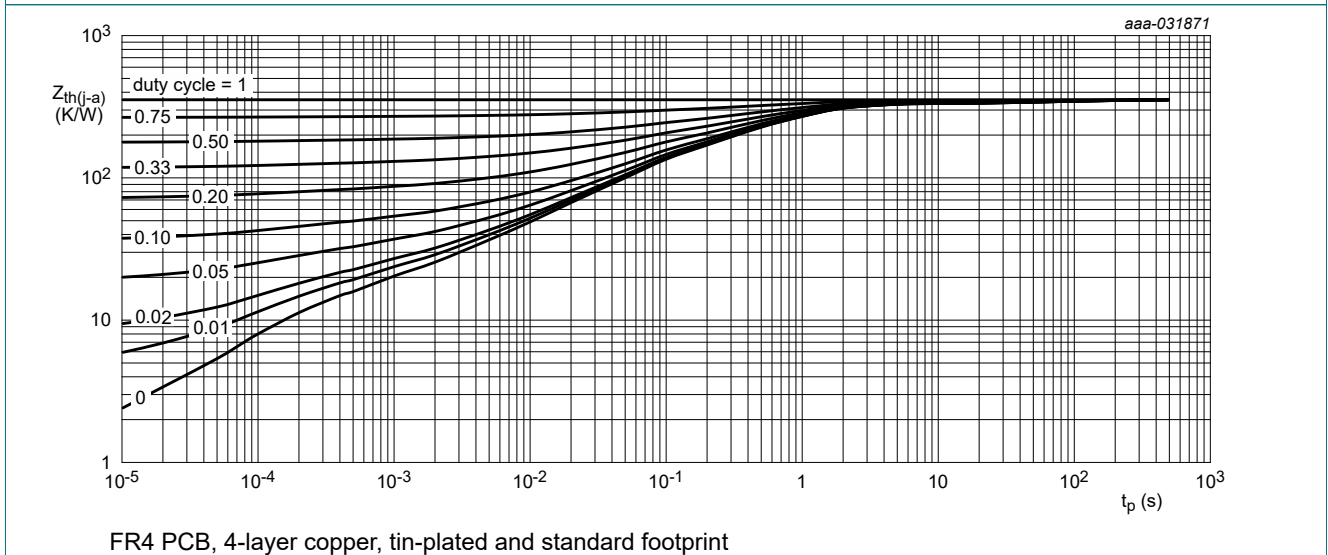


Fig. 3. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

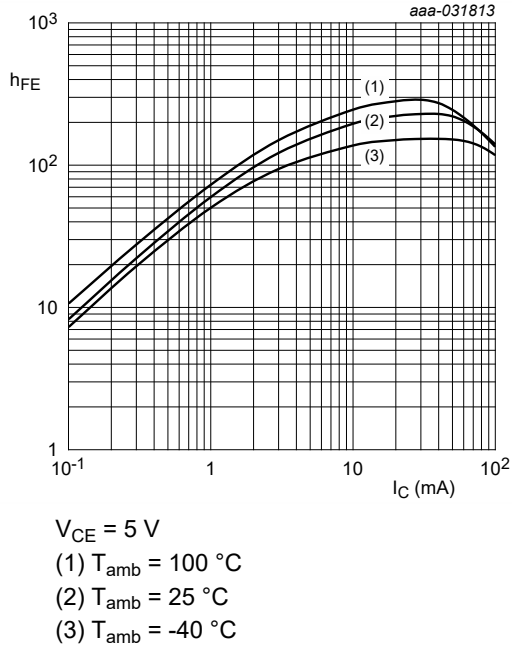


Fig. 4. NHDTC123JU-Q: DC current gain as a function of collector current; typical values

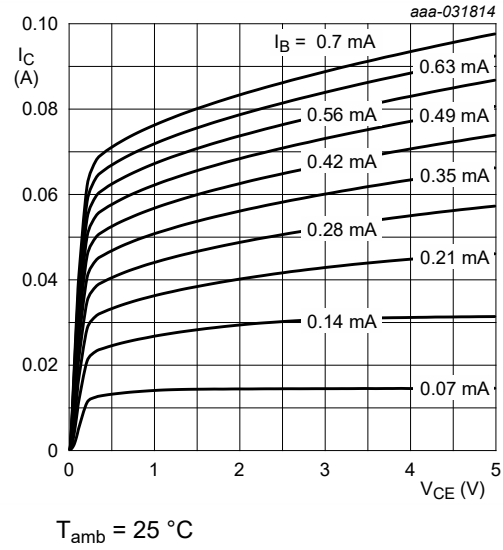


Fig. 5. NHDTC123JU-Q: Collector current as a function of collector-emitter voltage; typical values

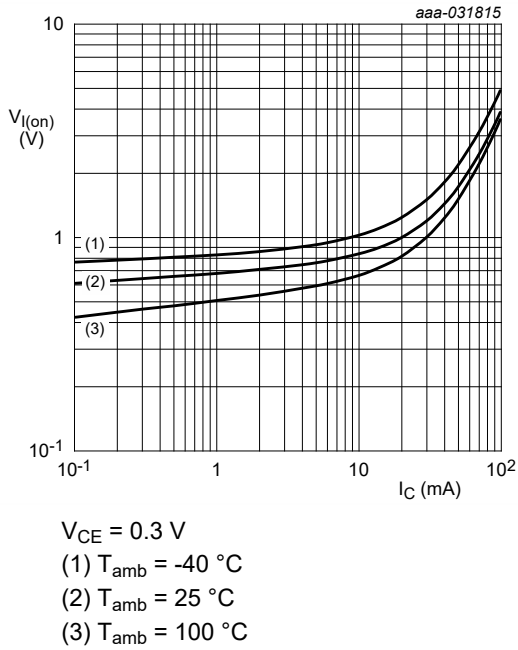


Fig. 6. NHDTC123JU-Q: On-state input voltage as a function of collector current; typical values

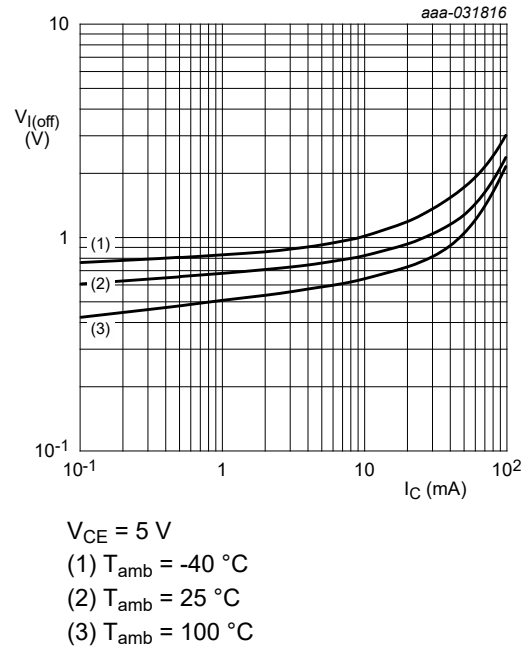
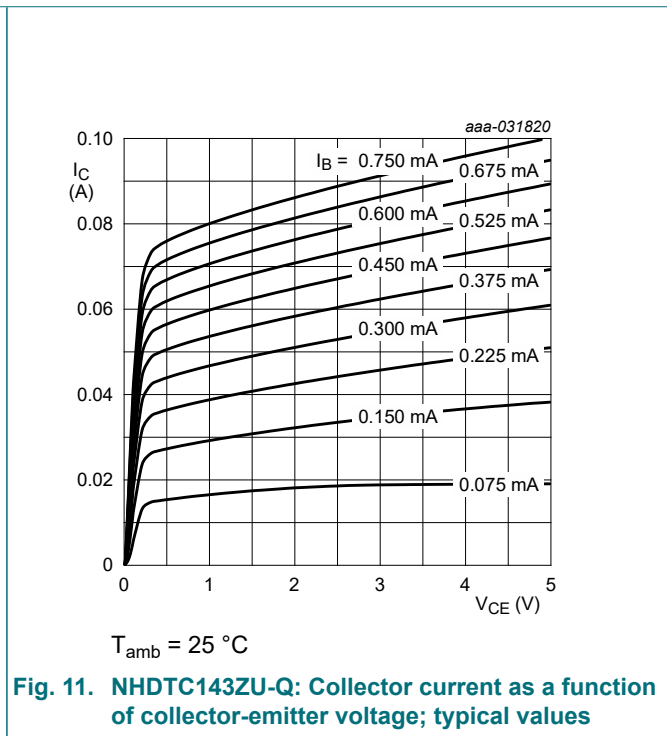
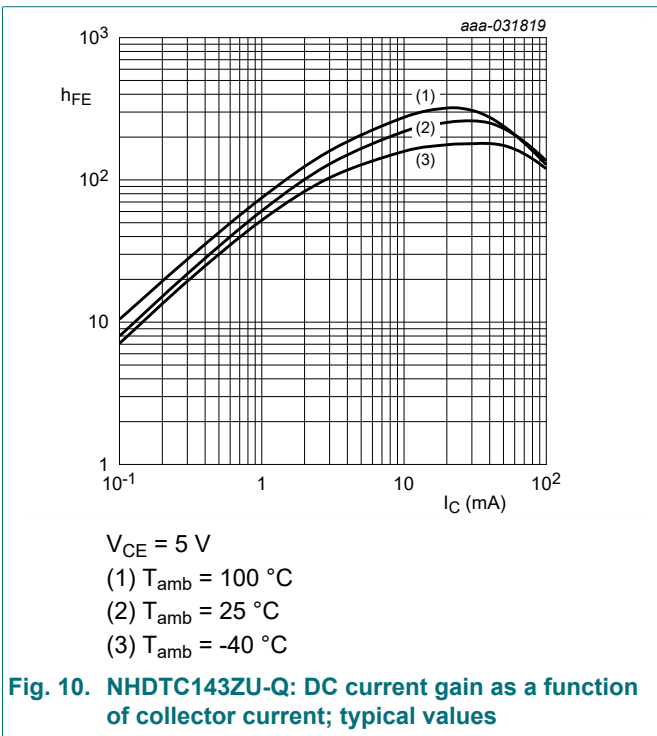
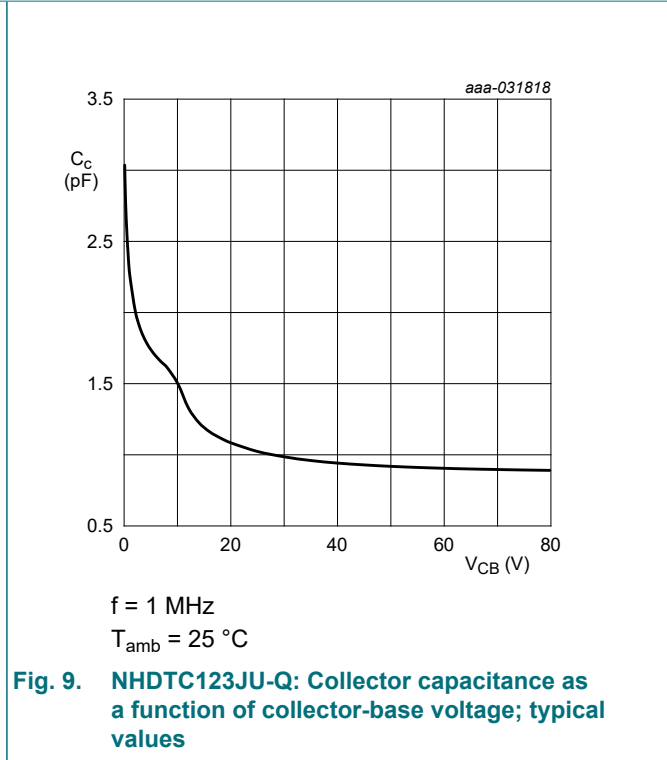
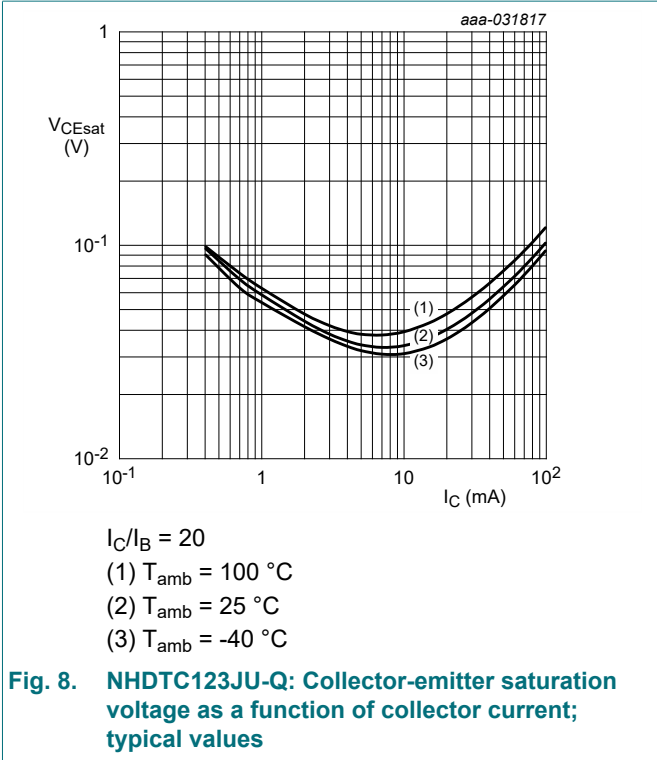
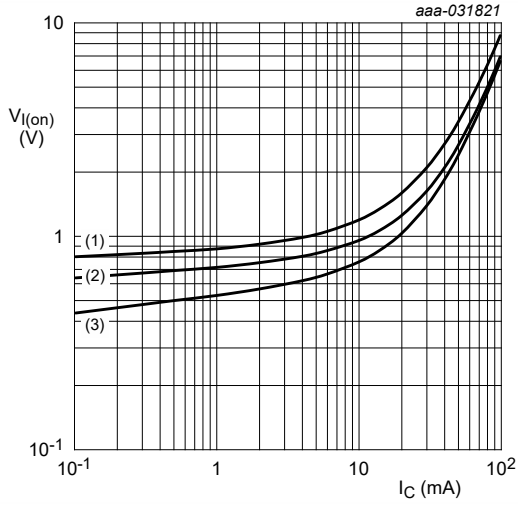


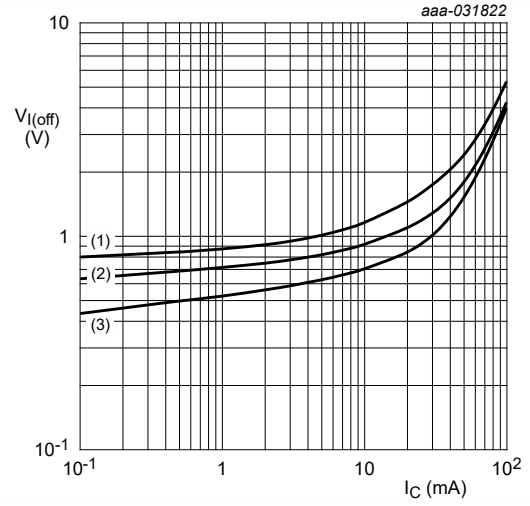
Fig. 7. NHDTC123JU-Q: Off-state input voltage as a function of collector current; typical values





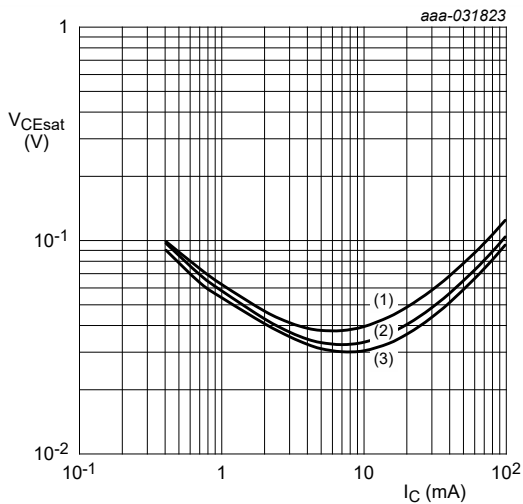

Fig. 12. NHDTC143ZU-Q: On-state input voltage as a function of collector current; typical values



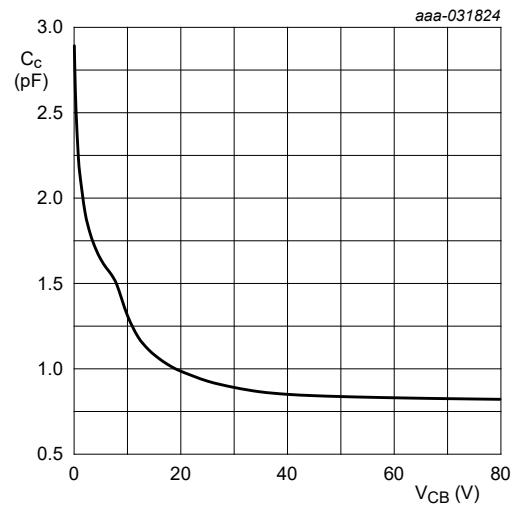

Fig. 15. NHDTC143ZU-Q: Collector capacitance as a function of collector-base voltage; typical values

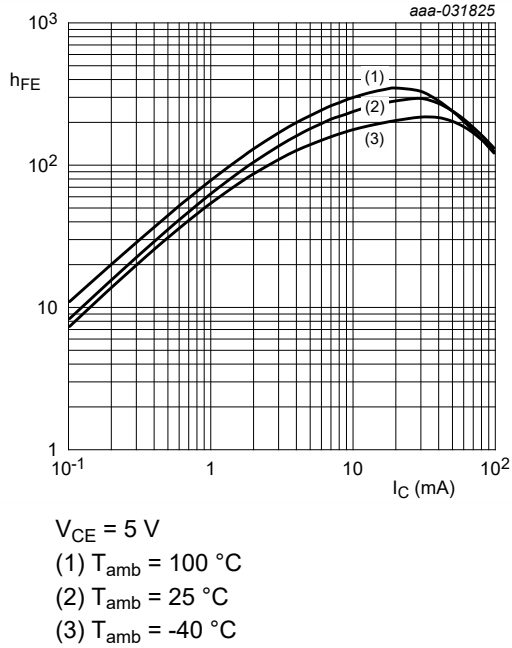


Fig. 16. NHDTC114YU-Q: DC current gain as a function of collector current; typical values

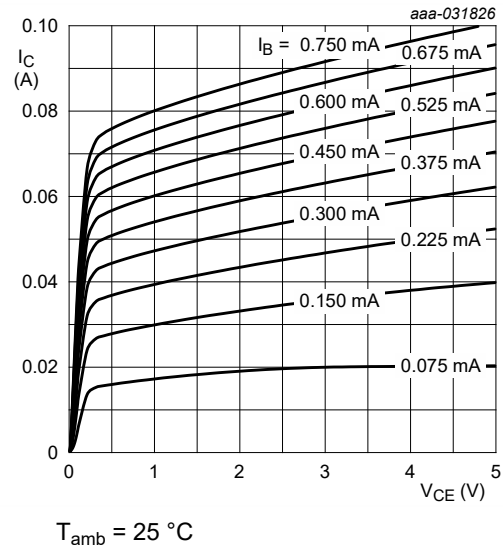


Fig. 17. NHDTC114YU-Q: Collector current as a function of collector-emitter voltage; typical values

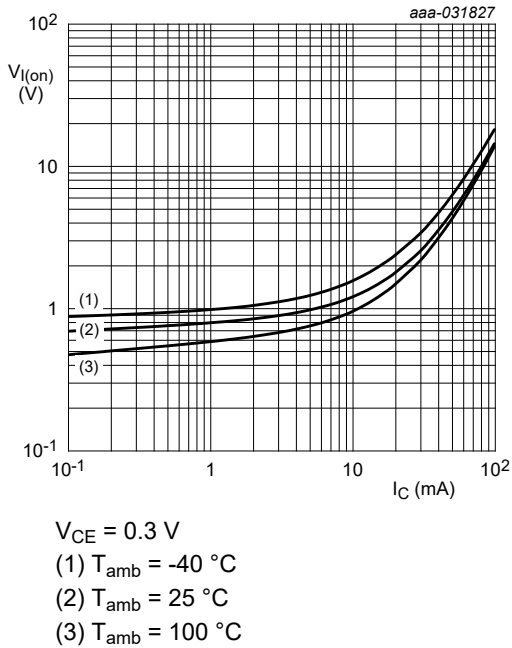


Fig. 18. NHDTC114YU-Q: On-state input voltage as a function of collector current; typical values

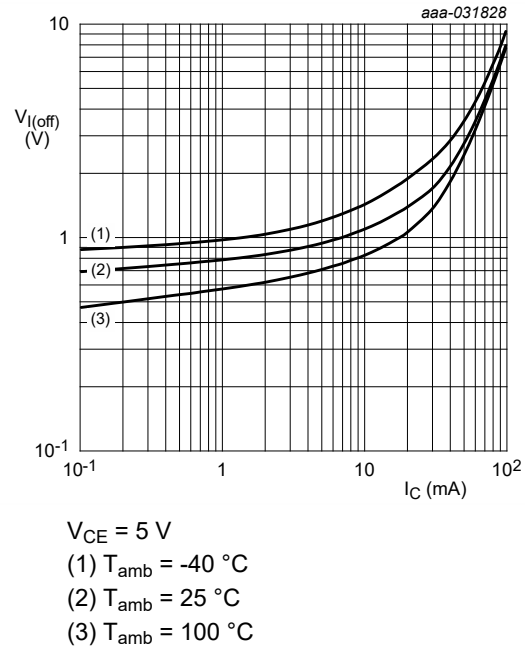
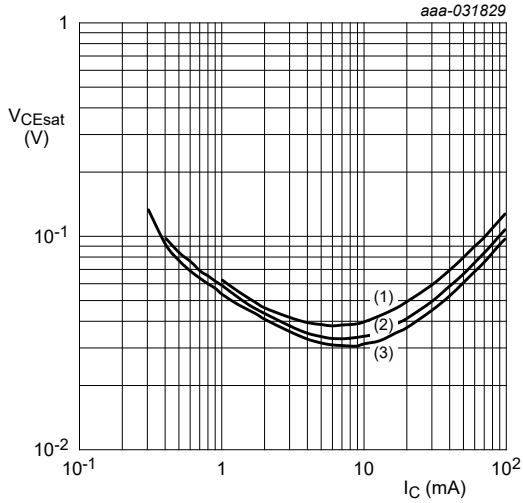


Fig. 19. NHDTC114YU-Q: Off-state input voltage as a function of collector current; typical values



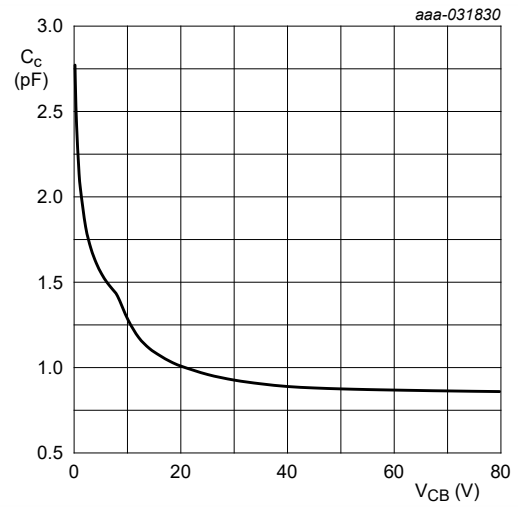

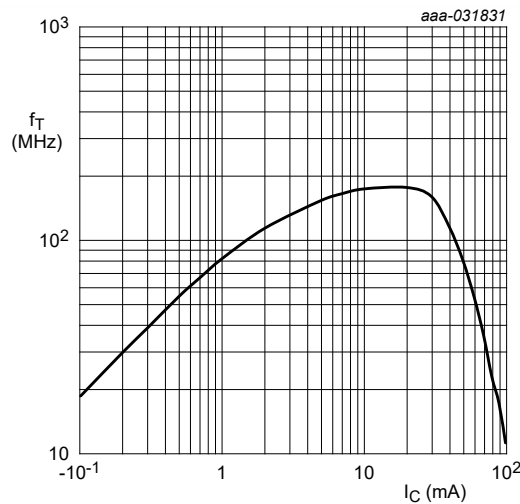
Fig. 20. NHDTC114YU-Q: Collector-emitter saturation voltage as a function of collector current; typical values

$$\frac{R_2}{R_1} = \frac{V(I_4) - V(I_3)}{R_1 \cdot (I_4 - I_3)} - 1$$

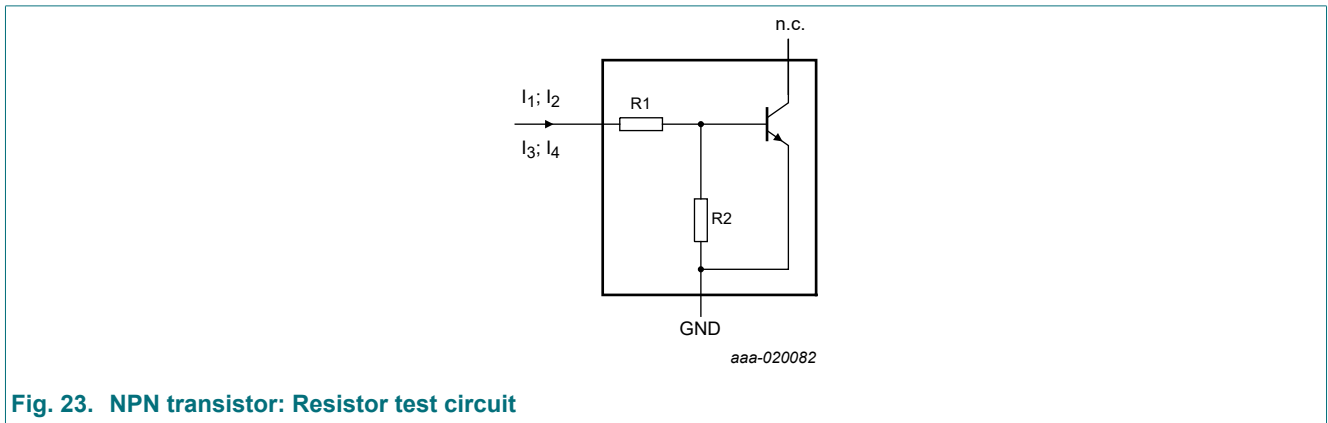


Fig. 23. NPN transistor: Resistor test circuit

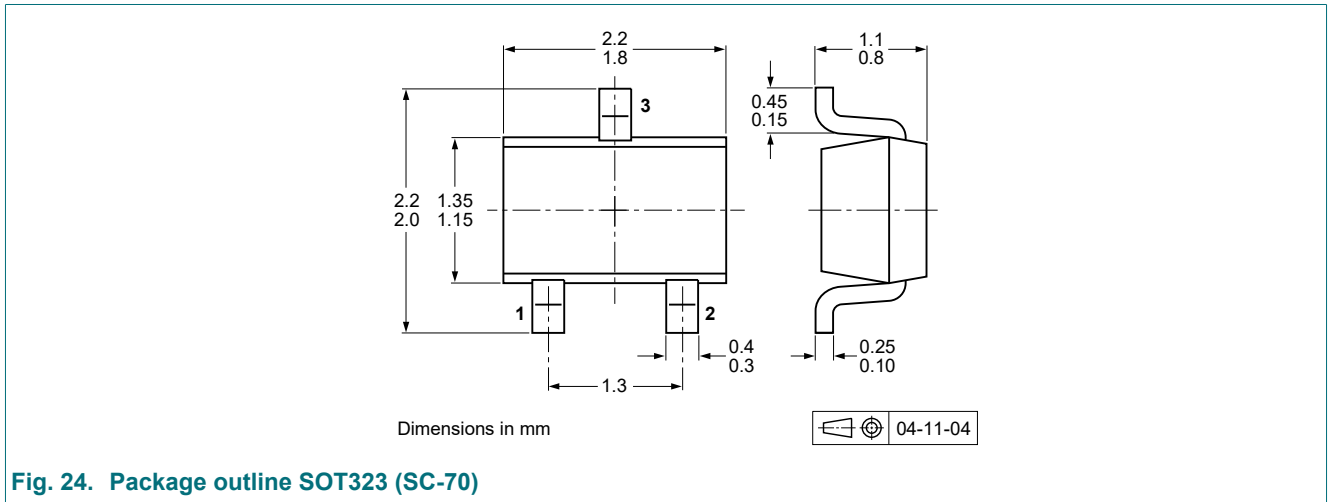


Fig. 24. Package outline SOT323 (SC-70)

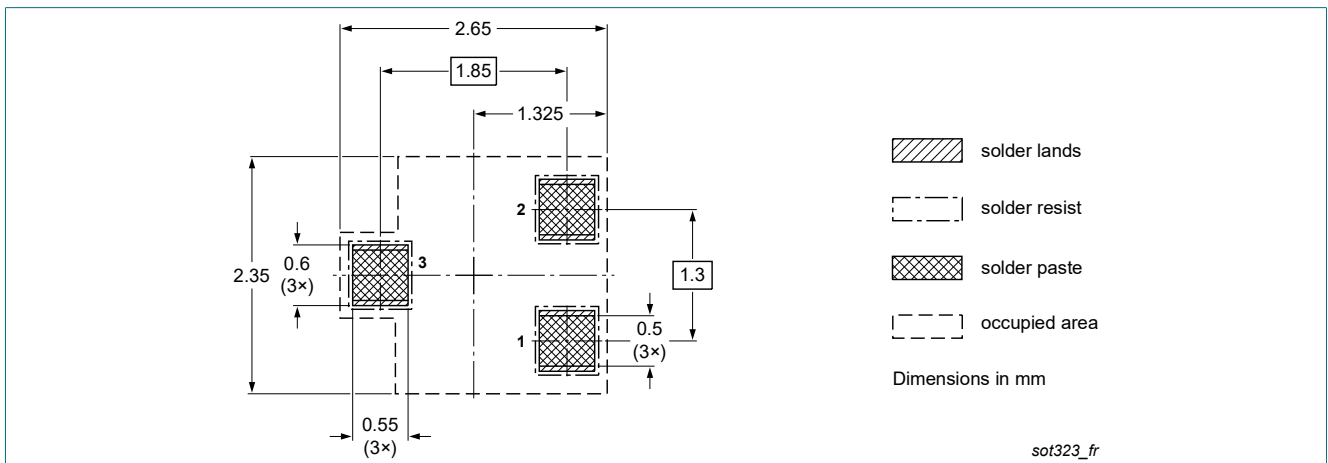


Fig. 25. Reflow soldering footprint for SOT323 (SC-70)

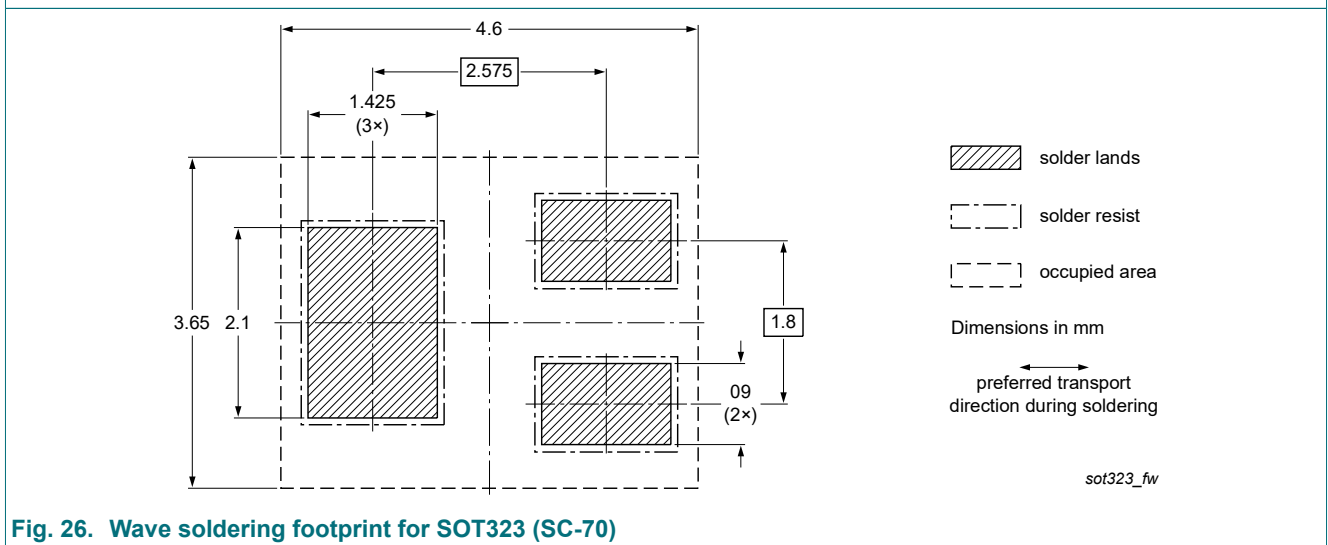


Fig. 26. Wave soldering footprint for SOT323 (SC-70)
