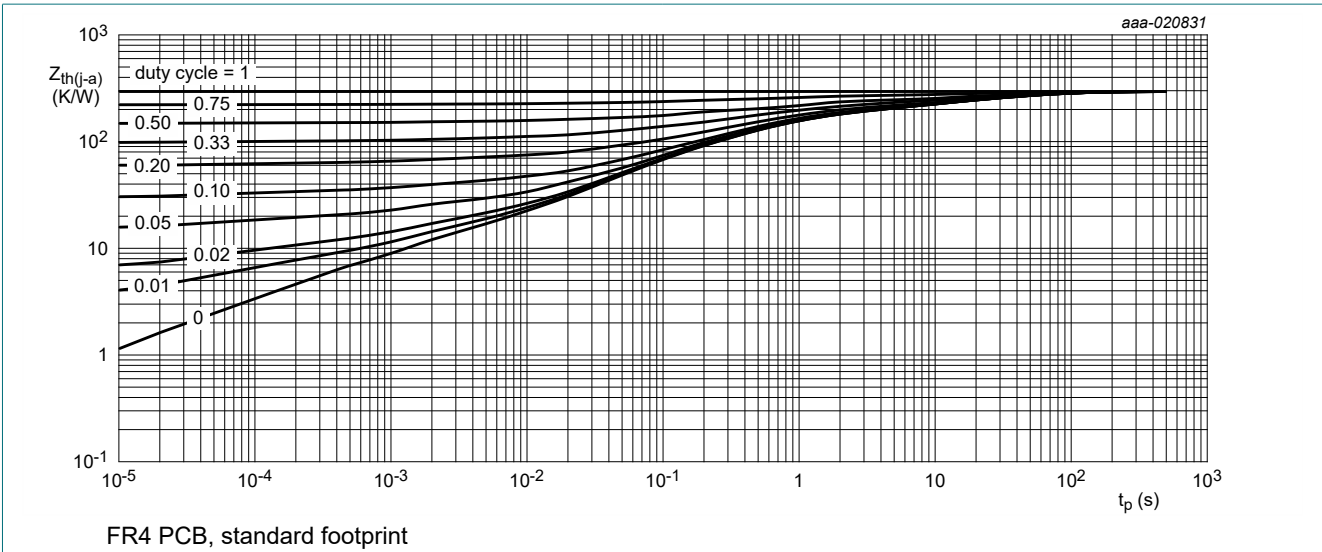


Fig. 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

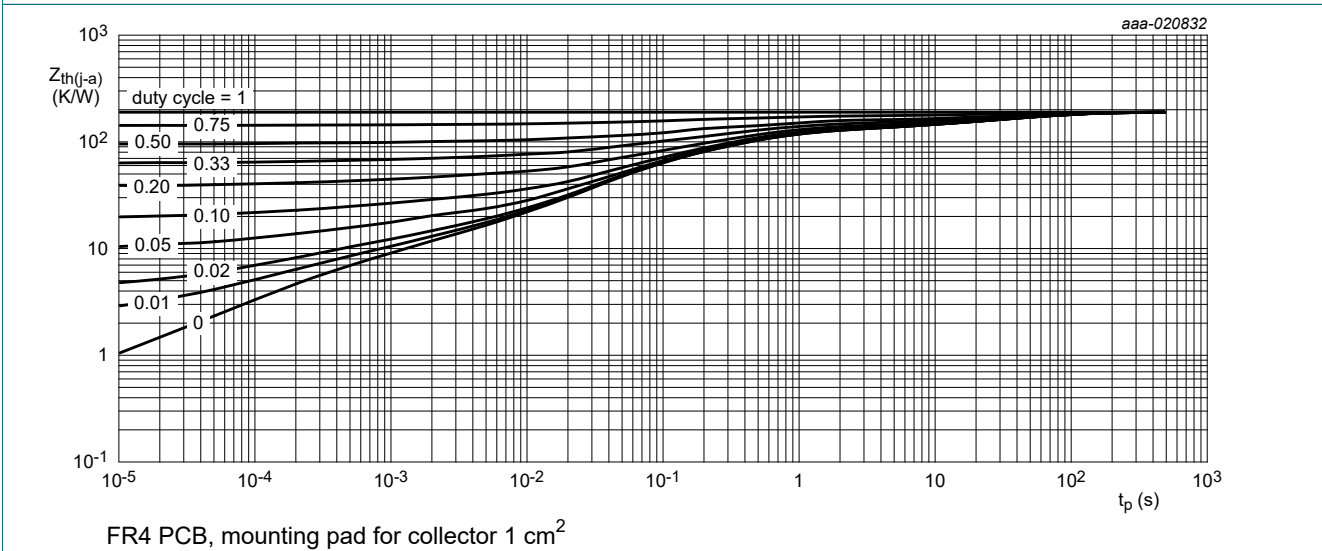


Fig. 3. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

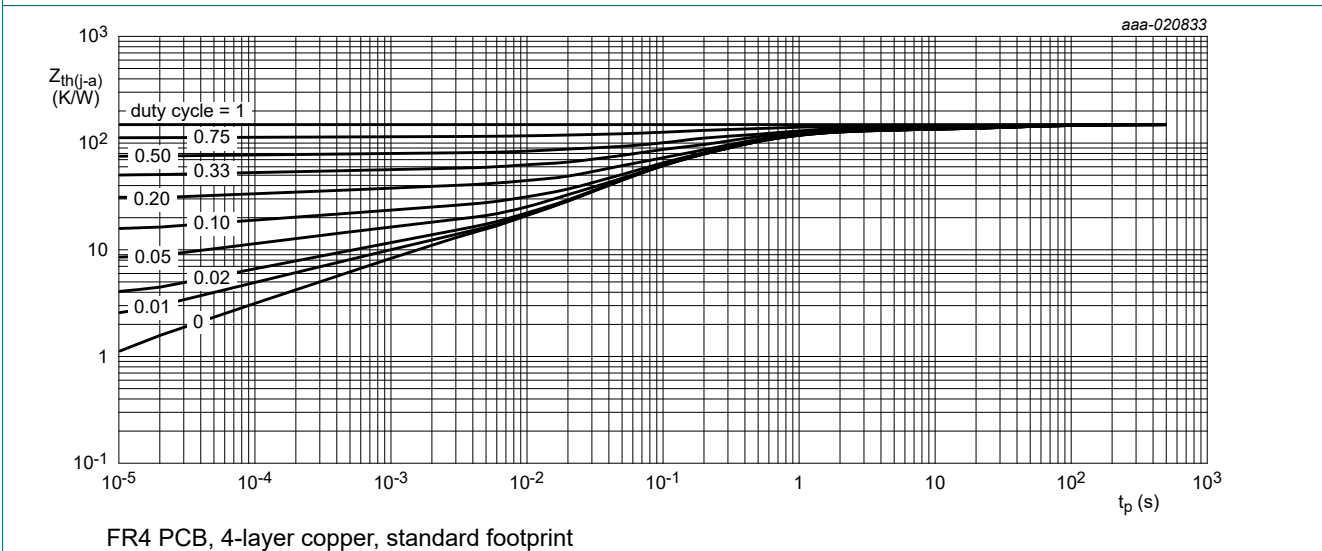


Fig. 4. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

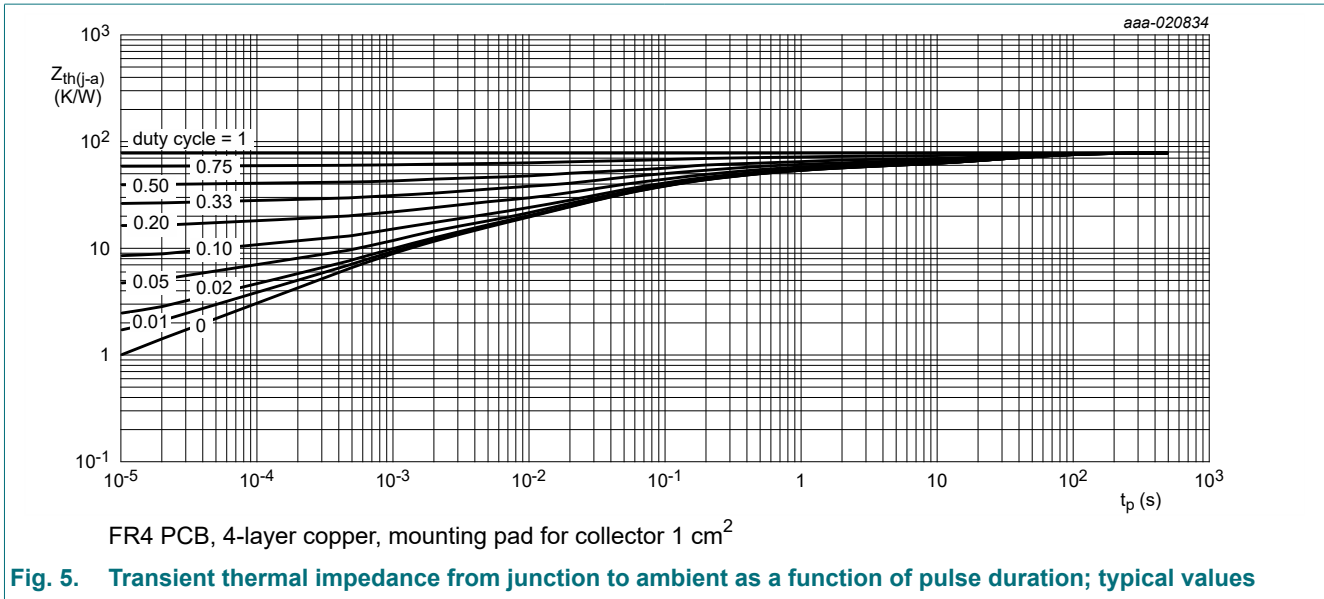
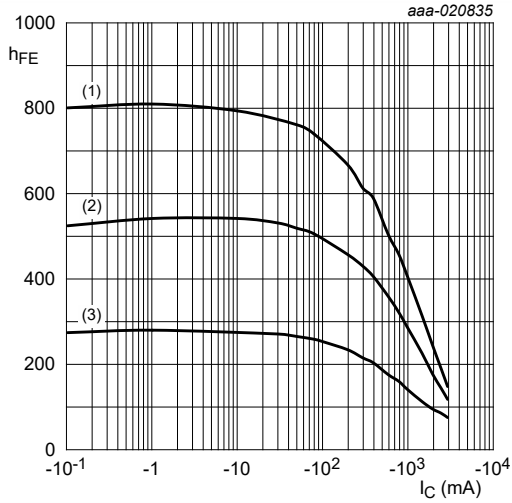


Fig. 5. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

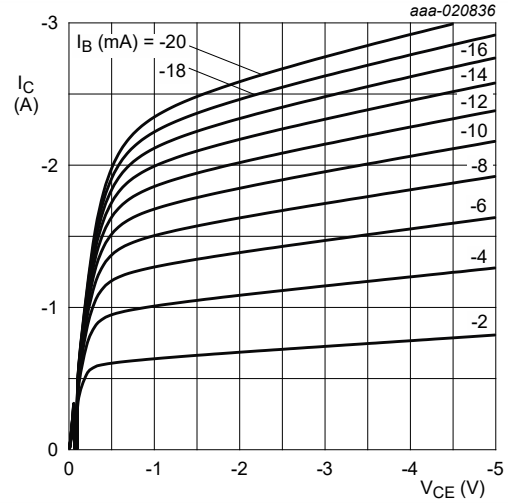

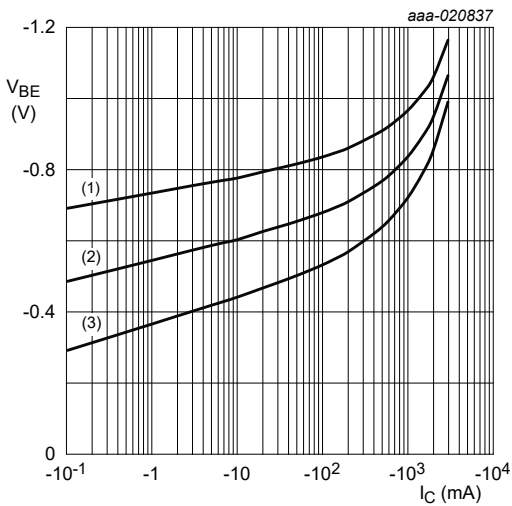

Fig. 6. DC current gain as a function of collector current; typical values



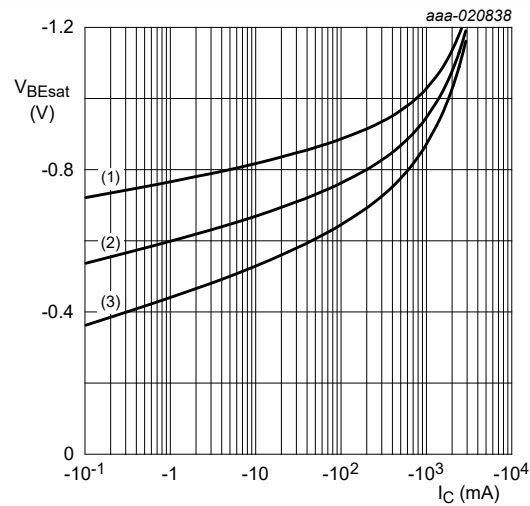

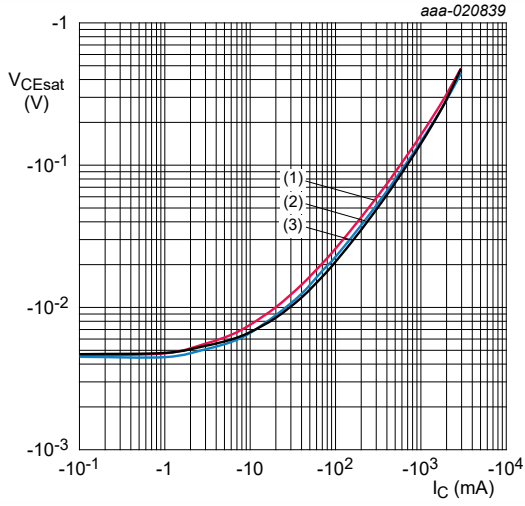
Fig. 8. Base-emitter voltage as a function of collector current; typical values

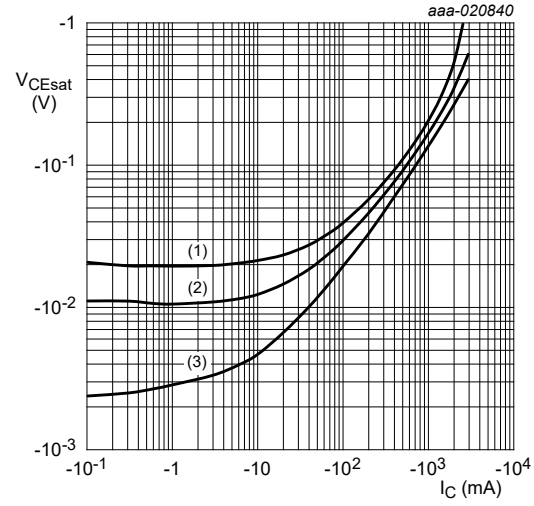
Fig. 9. Base-emitter saturation voltage as a function of collector current; typical values





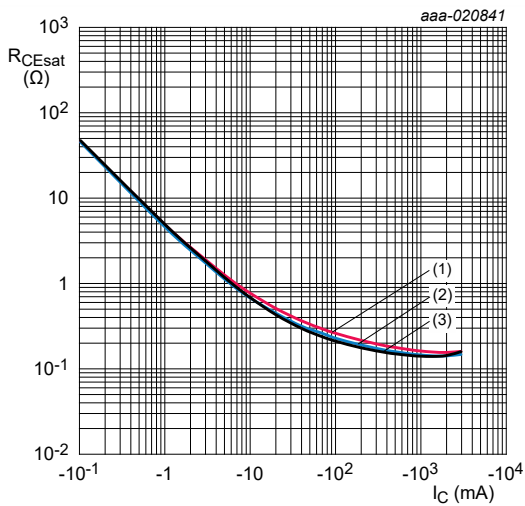

**Fig. 10. Collector-emitter saturation voltage as a function of collector current; typical values**



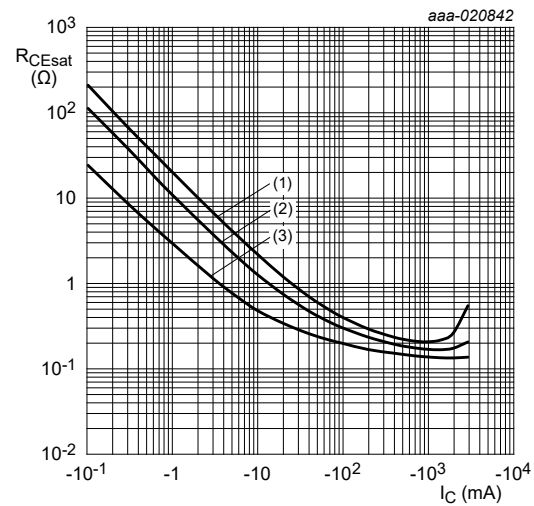

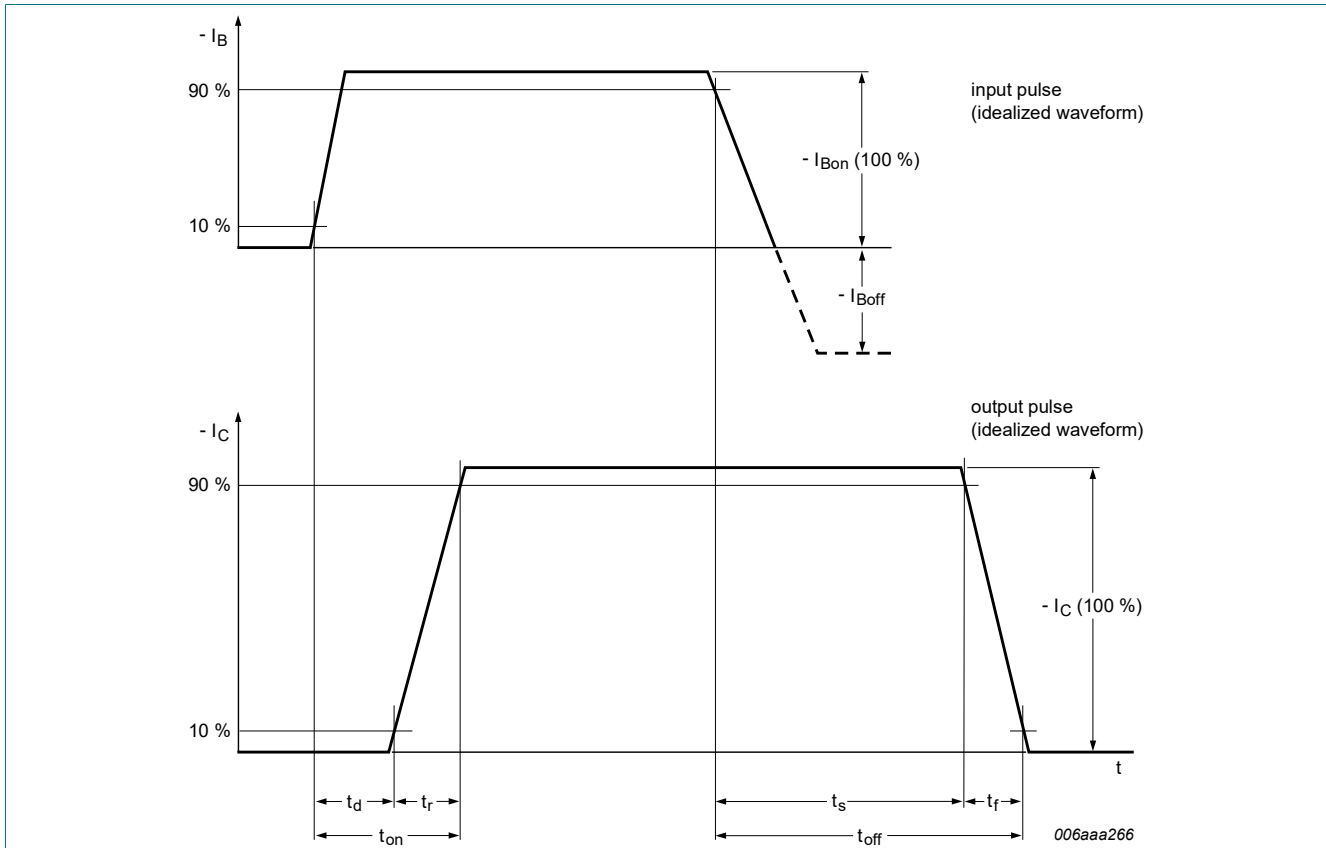


Fig. 14. Transistor switching time definition

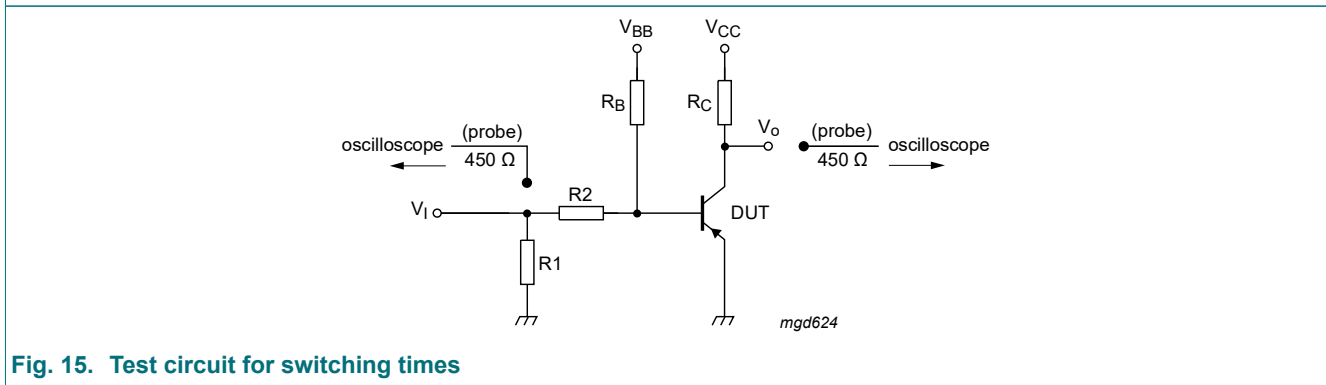


Fig. 15. Test circuit for switching times

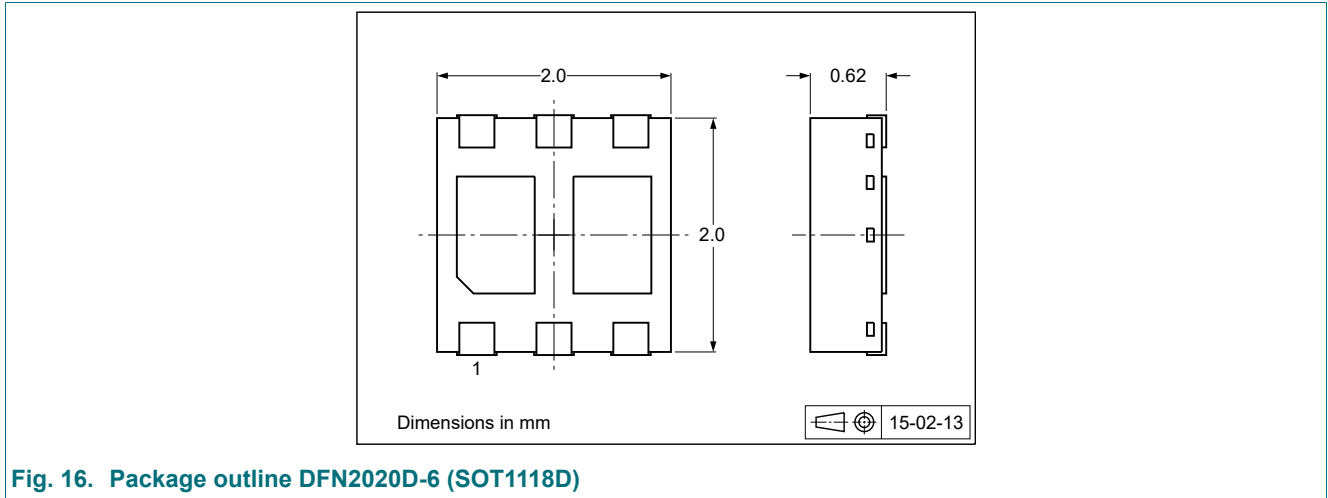


Fig. 16. Package outline DFN2020D-6 (SOT1118D)

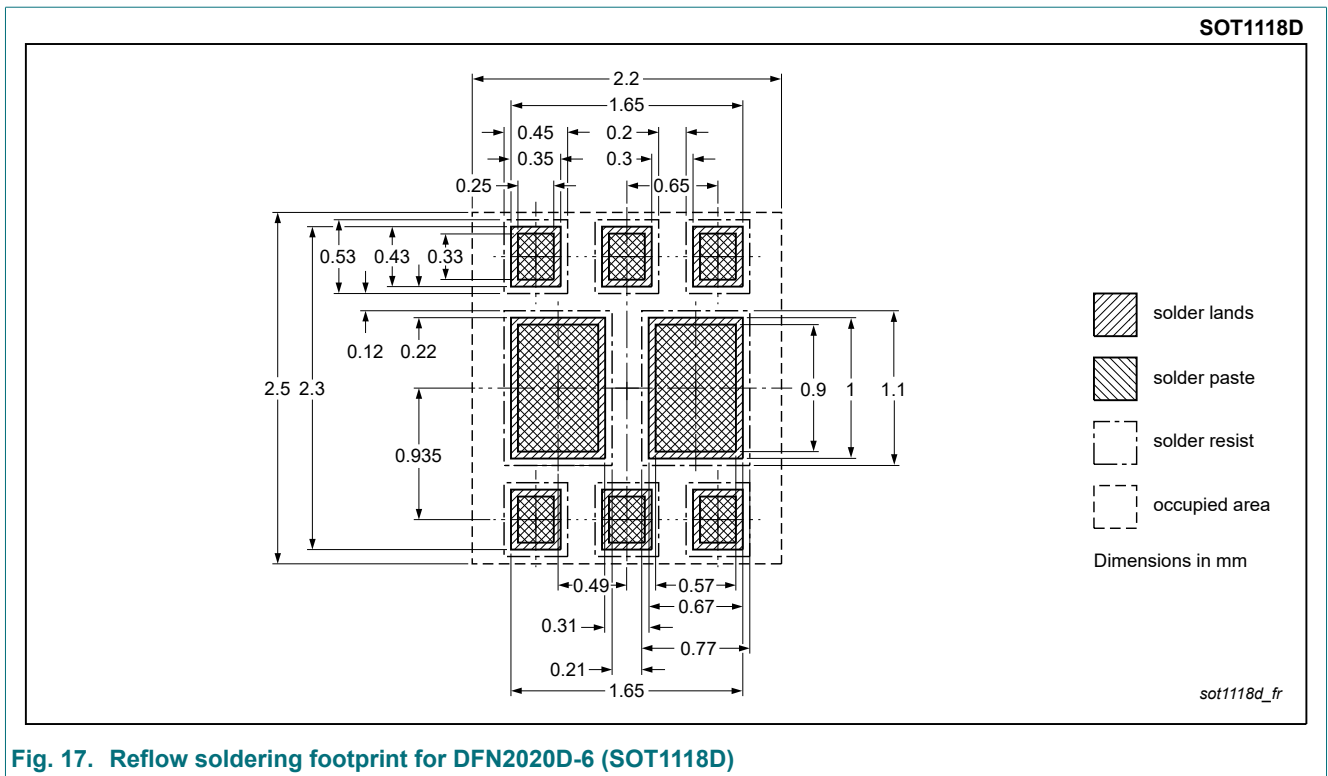


Fig. 17. Reflow soldering footprint for DFN2020D-6 (SOT1118D)
