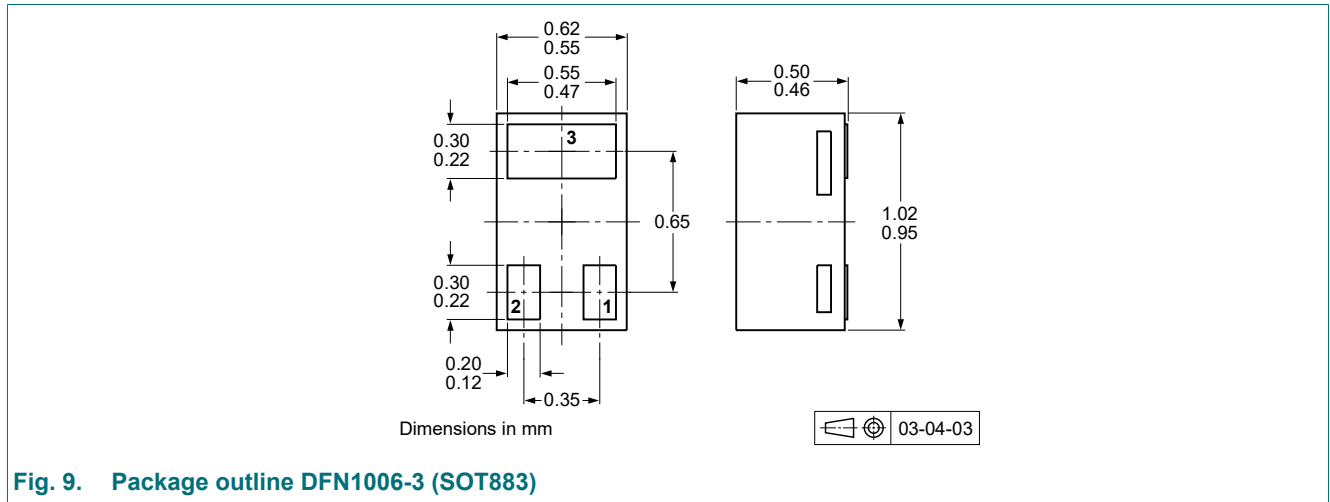


Fig. 9. Package outline DFN1006-3 (SOT883)

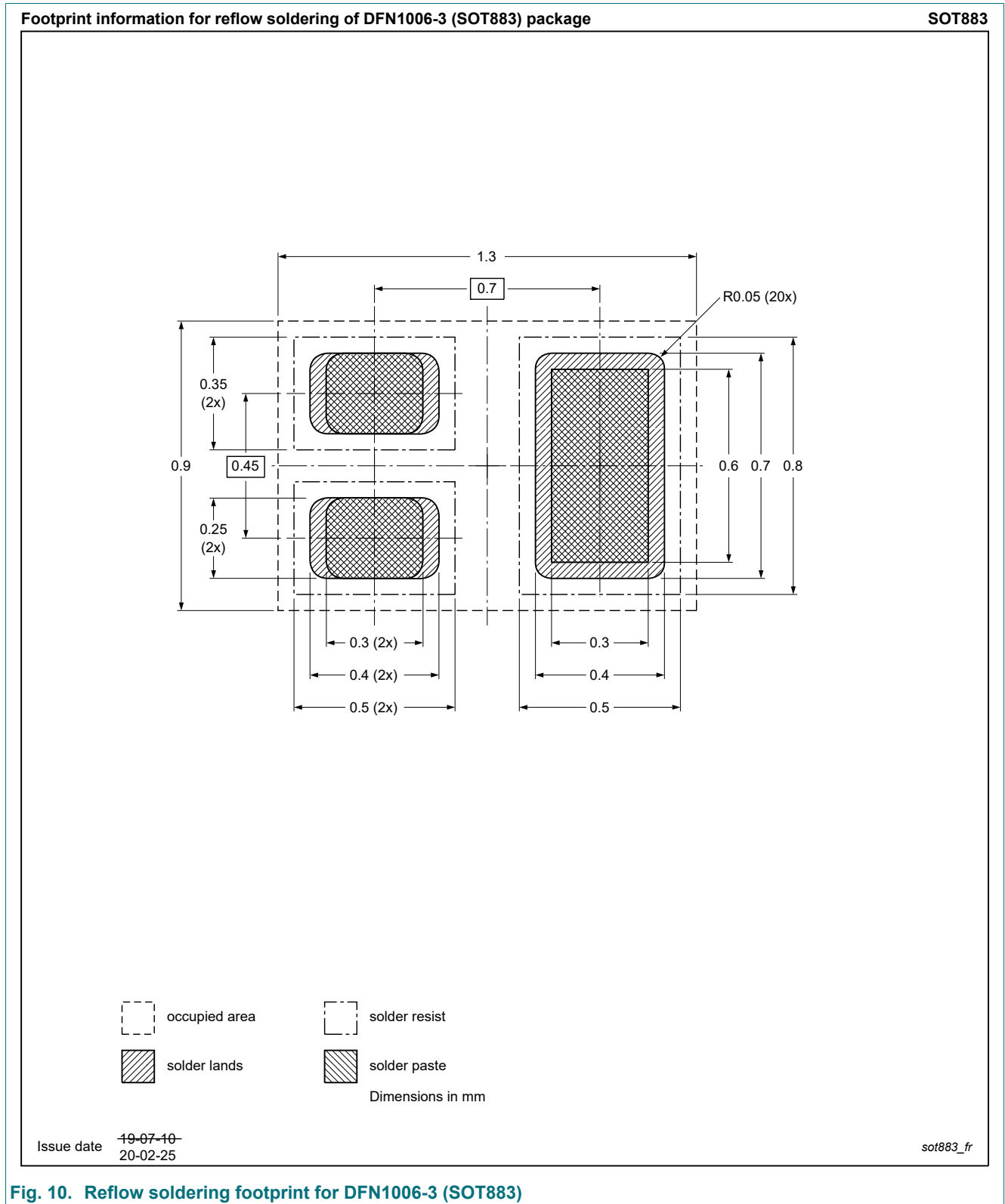


Fig. 10. Reflow soldering footprint for DFN1006-3 (SOT883)
