









Fig 4. DC current gain as a function of collector current; typical values







 $V_{CE} = 5 \text{ V}; T_{amb} = 25 \text{ }^{\circ}\text{C}$


Fig 7. Transition frequency as a function of collector current; typical values of built-in transistor


