

Fig. 1. Power derating curves








Fig. 4. DC current gain as a function of collector current; typical values




Fig. 5. Collector-emitter saturation voltage as a function of collector current; typical values






Fig. 6. On-state input voltage as a function of collector | Fig. 7. current; typical values






Fig. 8. Collector current as a function of collectoremitter voltage; typical values




