$$\frac{R_2}{R_1} = \frac{V(I_3)}{R_1 \cdot I_3} - 1$$

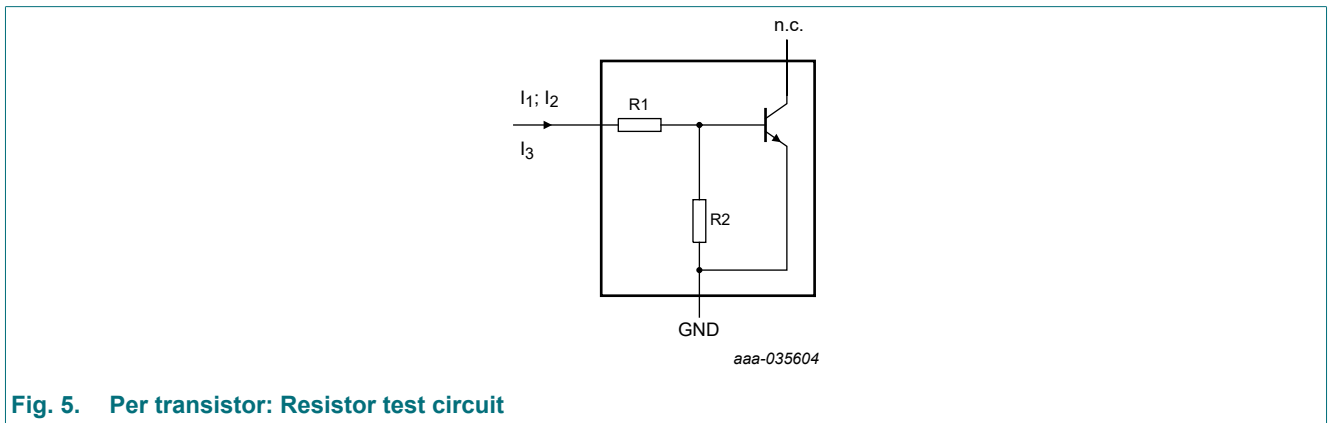


Fig. 5. Per transistor: Resistor test circuit

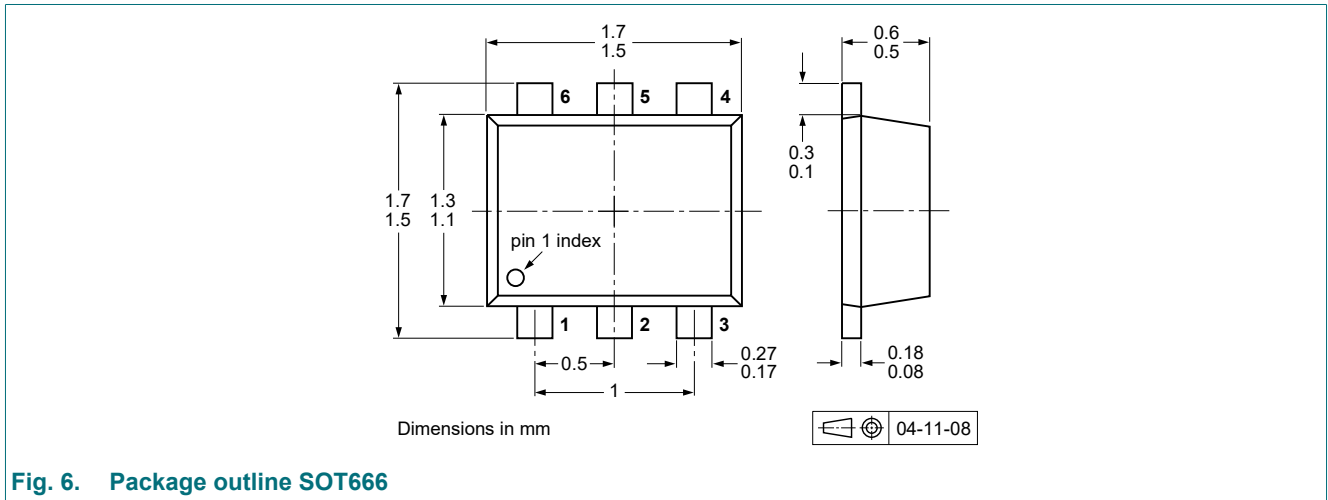


Fig. 6. Package outline SOT666

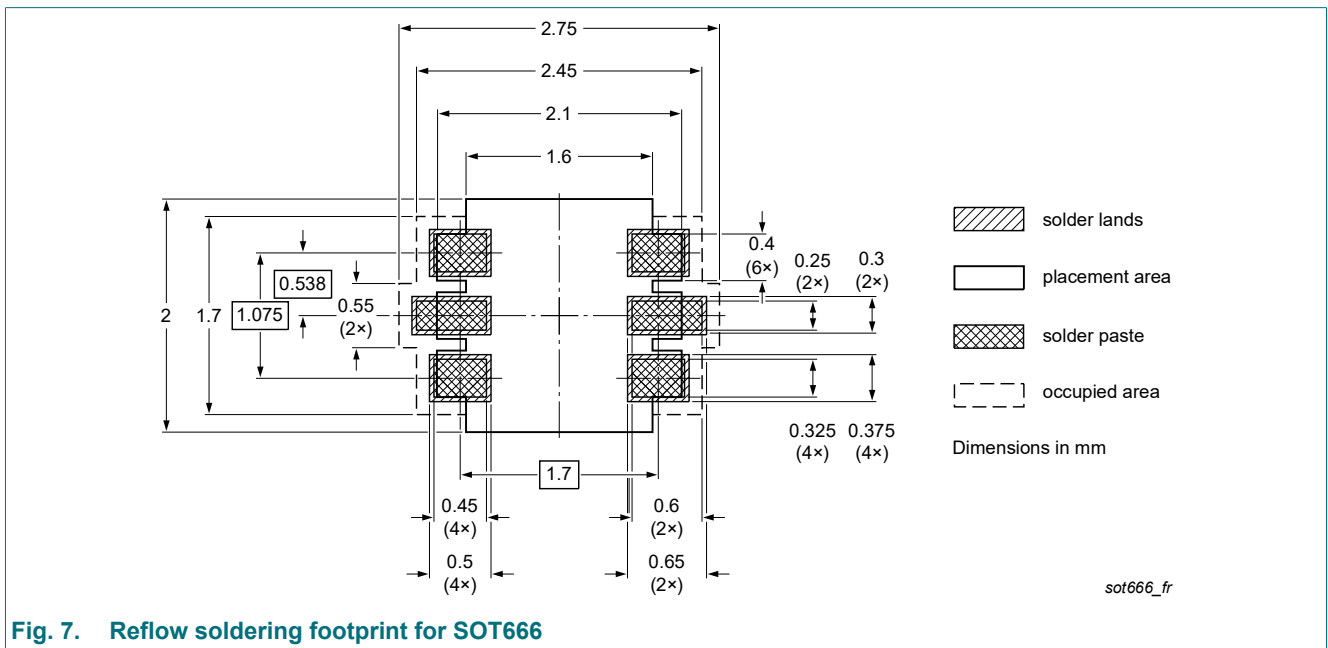


Fig. 7. Reflow soldering footprint for SOT666
