

ESD protection for in-vehicle networks 13 September 2023

### 1. General description

ESD protection device in a small SOT23 (TO-236AB) Surface-Mounted Device (SMD) plastic package, designed to protect two automotive in-vehicle network bus lines from the damage caused by ElectroStatic Discharge (ESD) and other transients.

### 2. Features and benefits

- Reverse stand-off voltage: V<sub>RWM</sub> = 24 V
- Low clamping voltage:  $V_{CL}$ = 33 V at I<sub>PP</sub> = 1 A
- ESD protection up to 15 kV (IEC 61000-4-2)
- Low capacitance: C<sub>d</sub> = 3.5 pF
- ESD protection up to 15 kV (ISO 10605; C = 150 pF; R = 330  $\Omega$ )
- High temperature capability: T<sub>i</sub> = 175 °C
- Qualified according to AEC-Q101 and recommended for use in automotive applications

### **10.** Application information

The device is designed for the protection of two automotive in-vehicle bus lines, e.g. CAN (FD), from the damage caused by ESD and surge pulses.



#### Circuit board layout and protection device placement

Circuit board layout is critical for the suppression of ESD, Electrical Fast Transient (EFT) and surge transients. The following guidelines are recommended:


- **1.** Place the device as close to the input terminal or connector as possible.
- 2. Minimize the path length between the device and the protected line.
- 3. Keep parallel signal paths to a minimum.
- 4. Avoid running protected conductors in parallel with unprotected conductors.
- 5. Minimize all Printed-Circuit Board (PCB) conductive loops including power and ground loops.
- 6. Minimize the length of the transient return path to ground.
- 7. Avoid using shared transient return paths to a common ground point.
- 8. Use ground planes whenever possible. For multilayer PCBs, use ground vias.


