


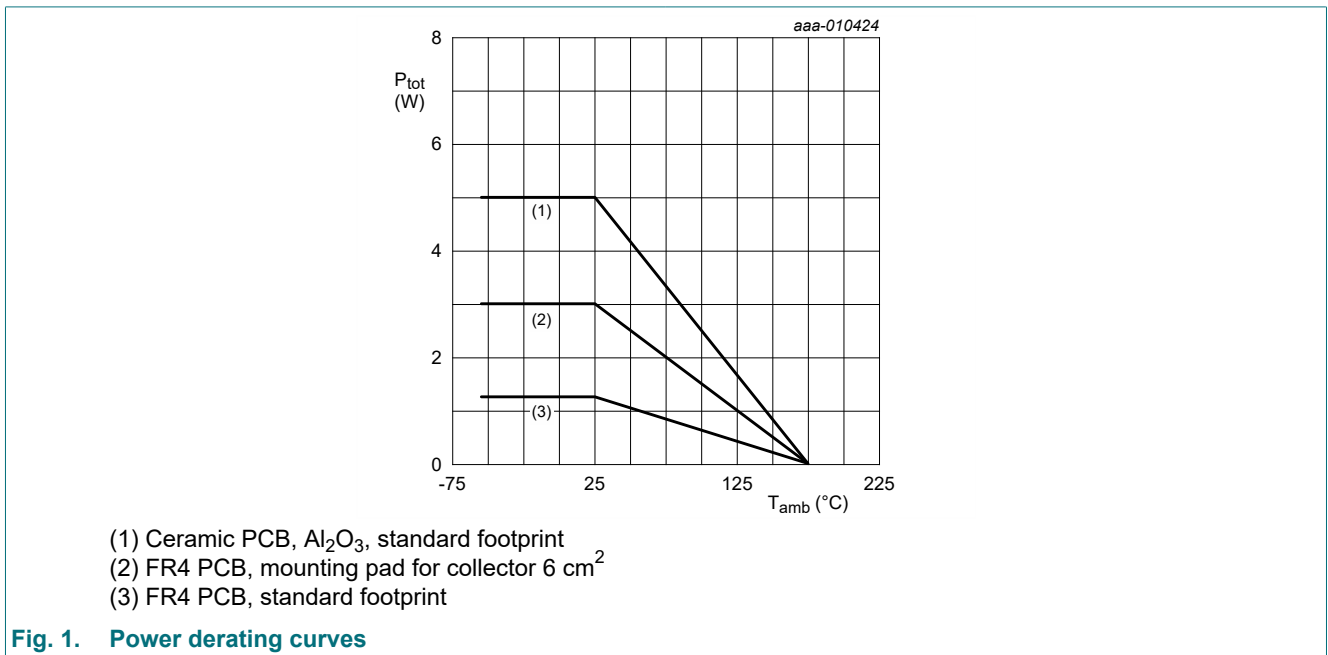


Fig. 1. Power derating curves

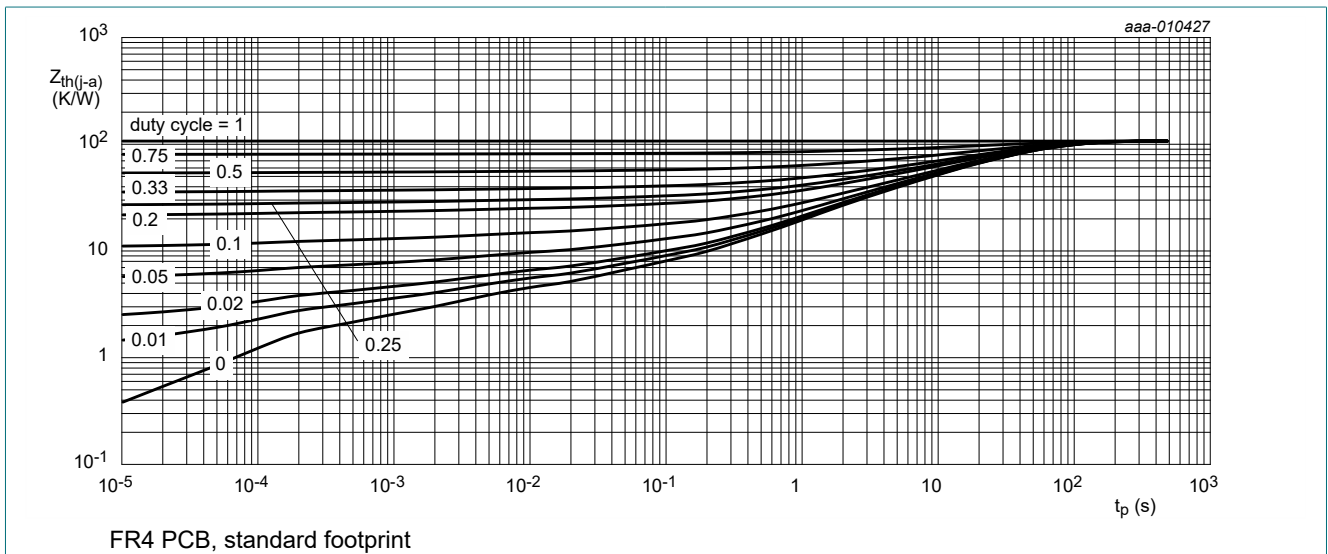


Fig. 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

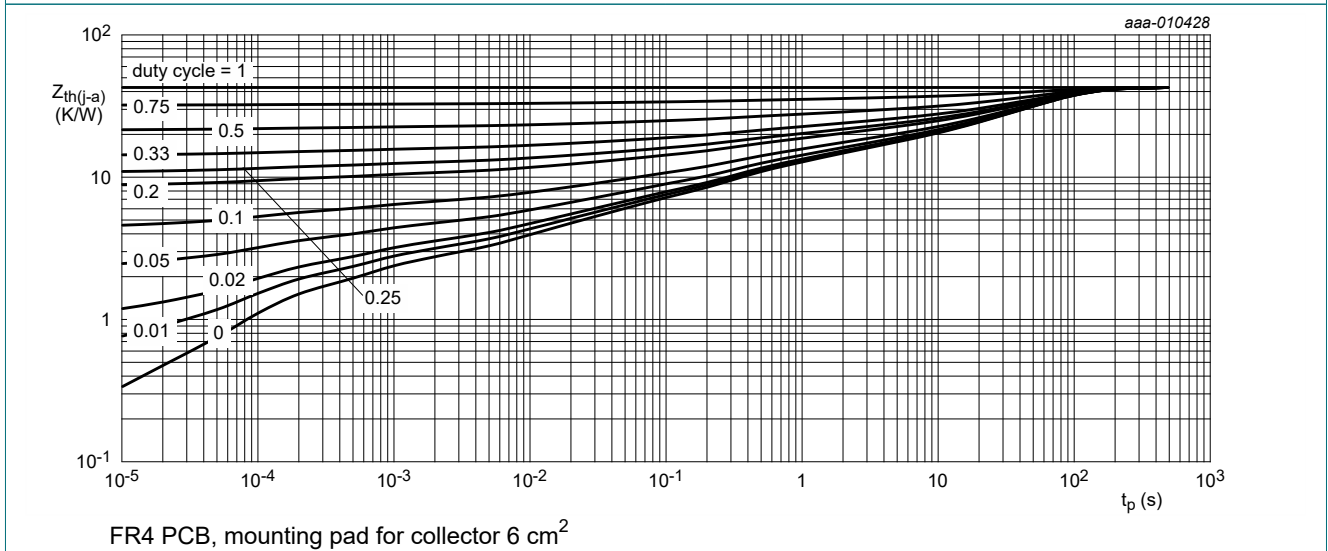
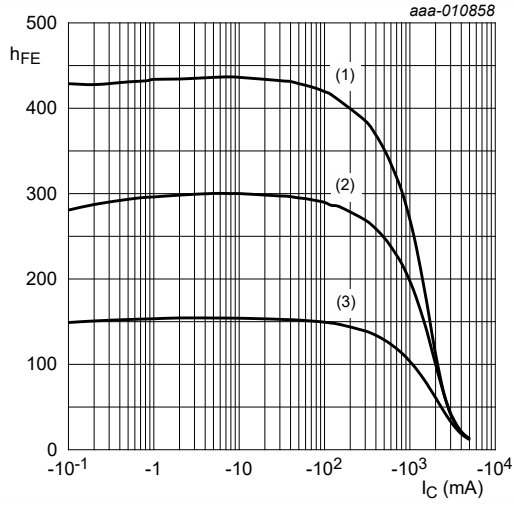


Fig. 3. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values

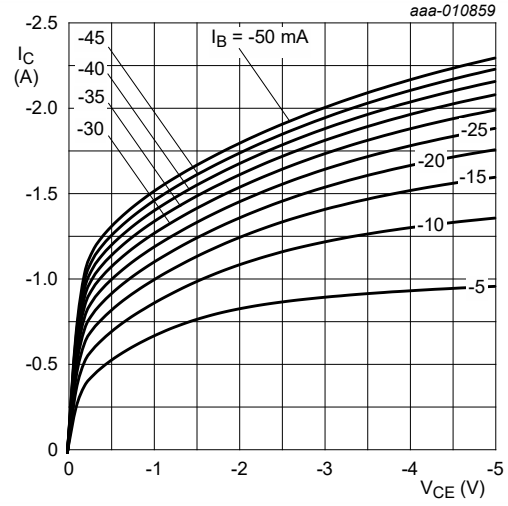

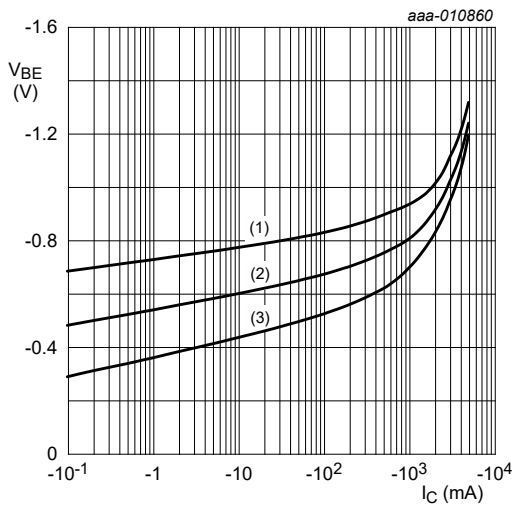

Fig. 4. DC current gain as a function of collector current; typical values



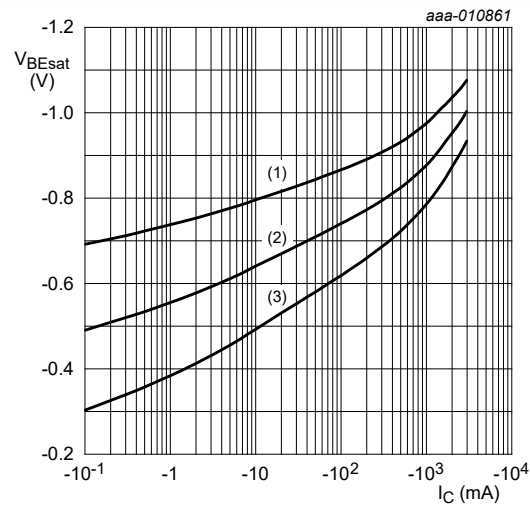

Fig. 5. Collector current as a function of collector-emitter voltage; typical values



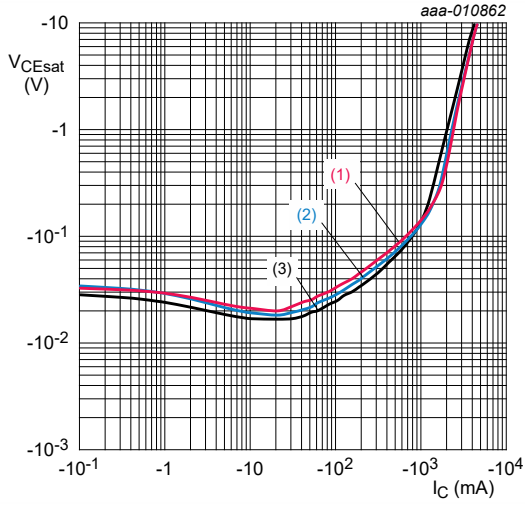

Fig. 6. Base-emitter voltage as a function of collector current; typical values



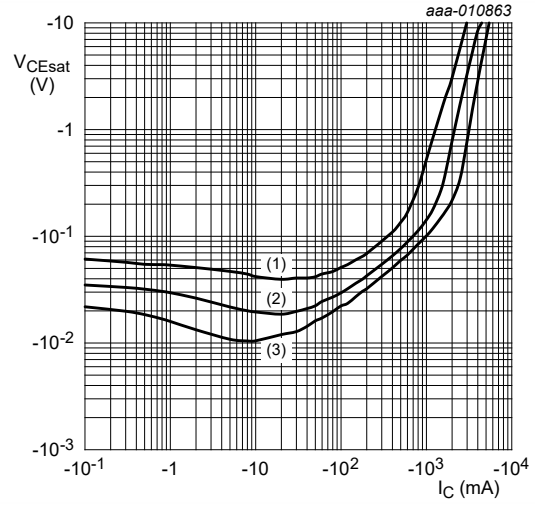

Fig. 7. Base-emitter saturation voltage as a function of collector current; typical values



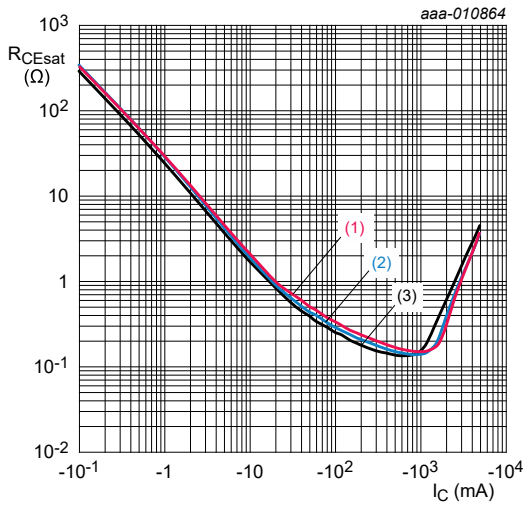

Fig. 8. Collector-emitter saturation voltage as a function of collector current; typical values



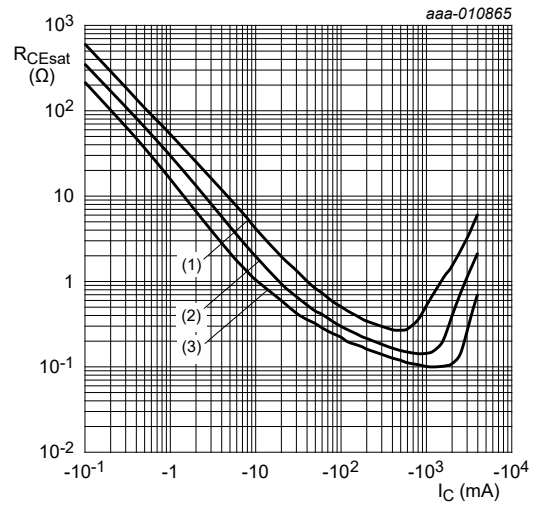

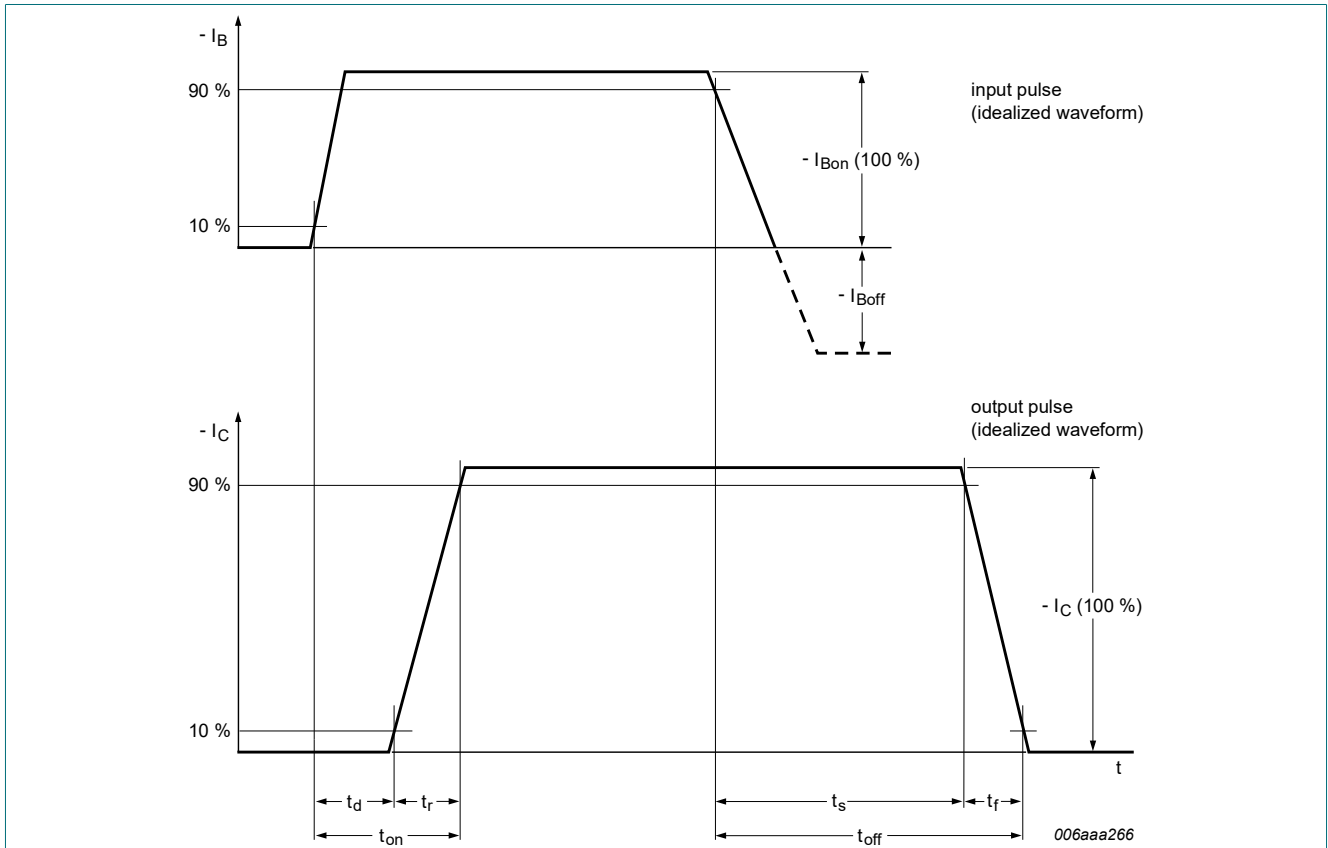


Fig. 12. Transistor switching time definition

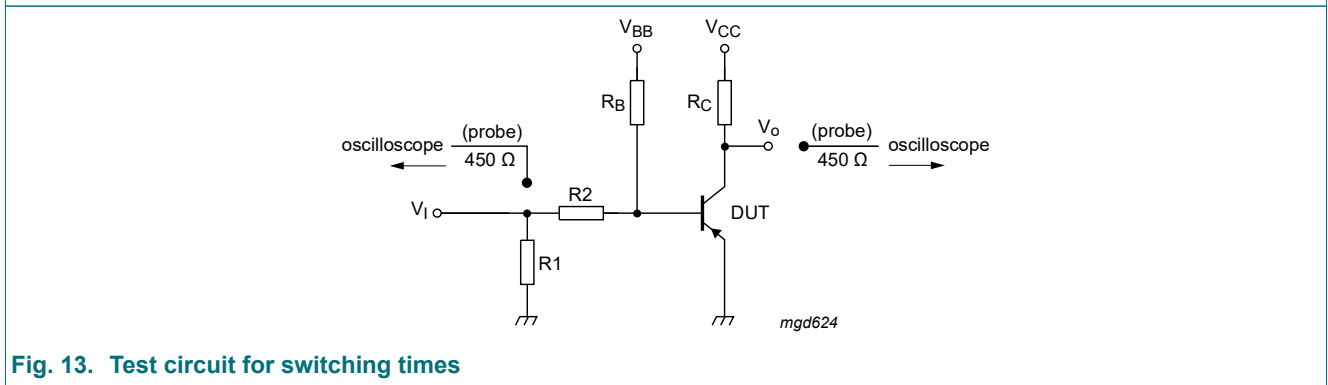


Fig. 13. Test circuit for switching times

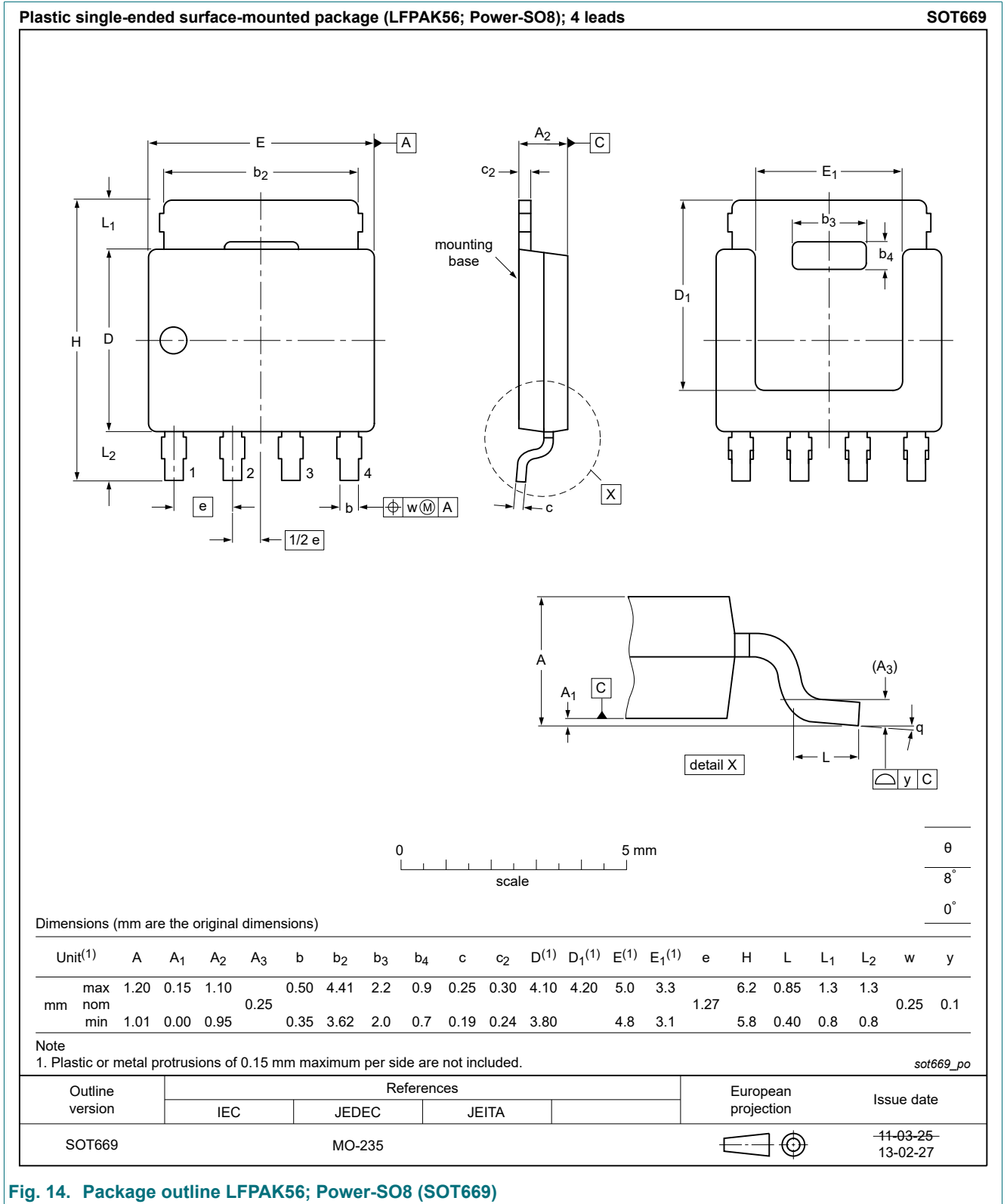


Fig. 14. Package outline LFPAK56; Power-SO8 (SOT669)

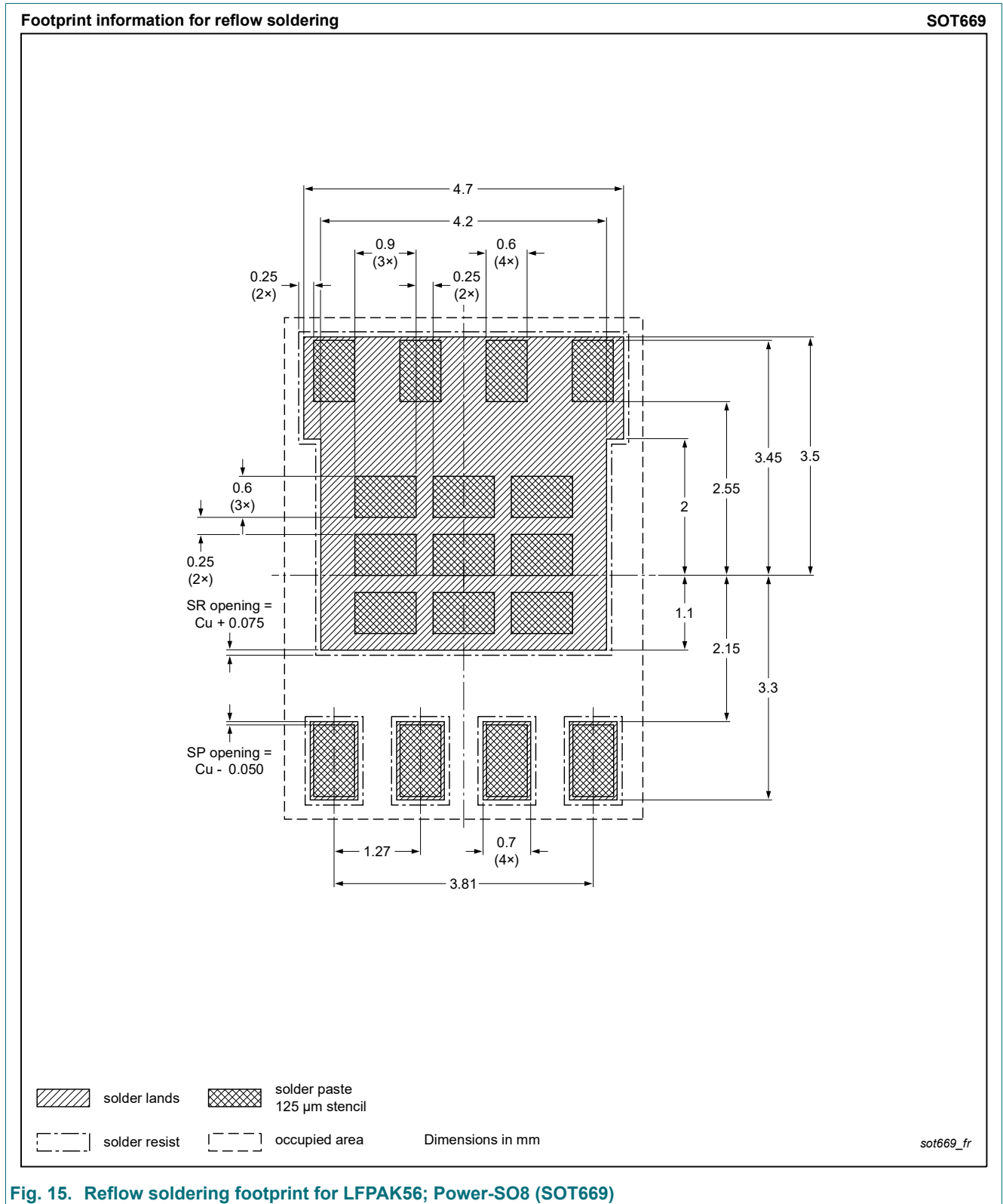


Fig. 15. Reflow soldering footprint for LFPAK56; Power-SO8 (SOT669)

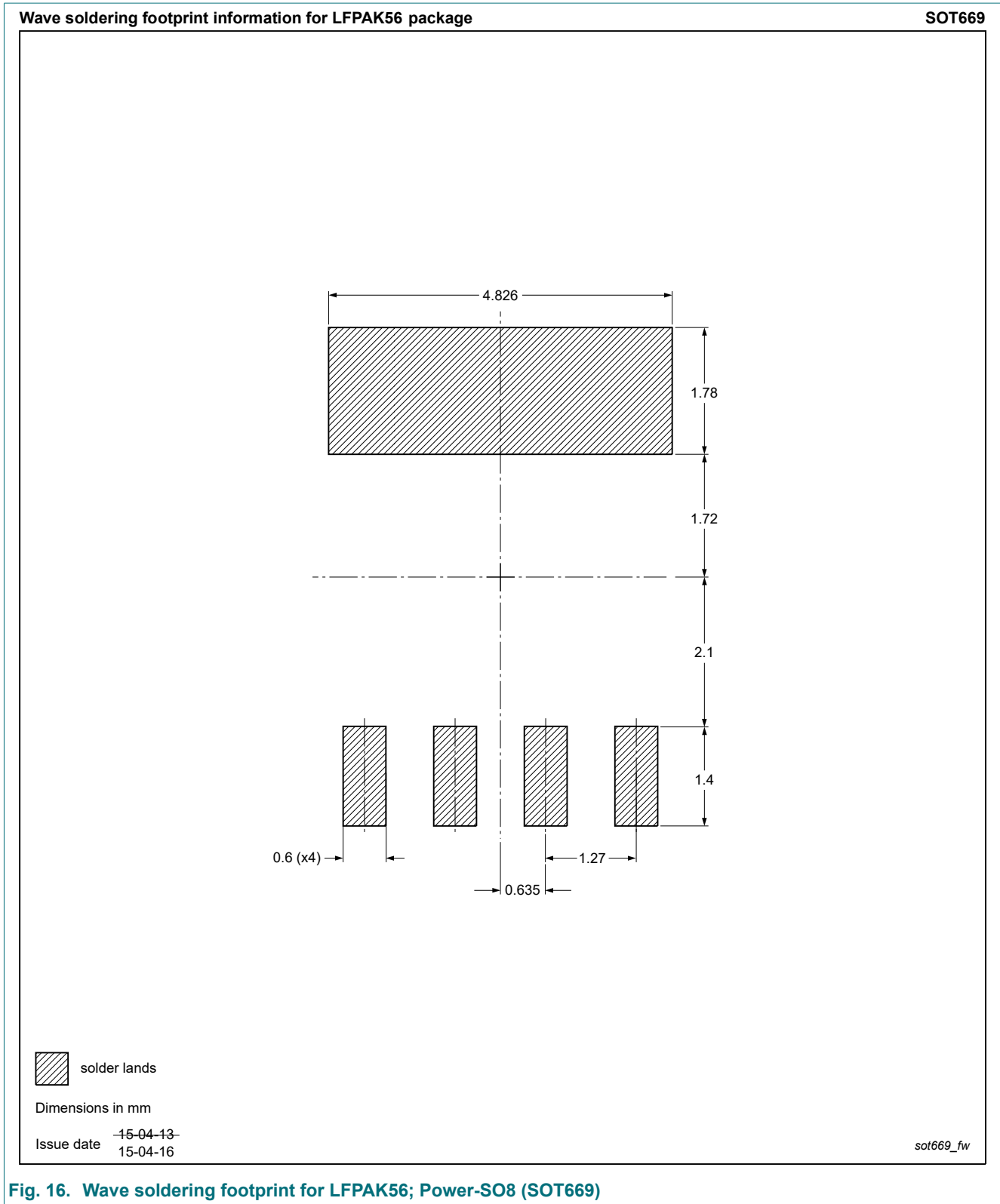


Fig. 16. Wave soldering footprint for LFPAK56; Power-SO8 (SOT669)
