
#### 30 V, 5 A low VF Schottky barrier rectifier





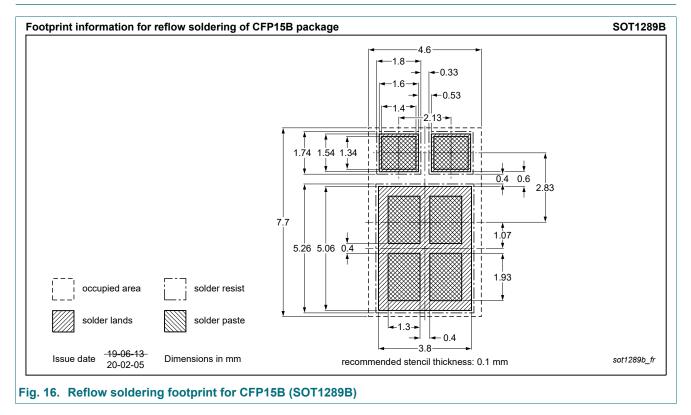
