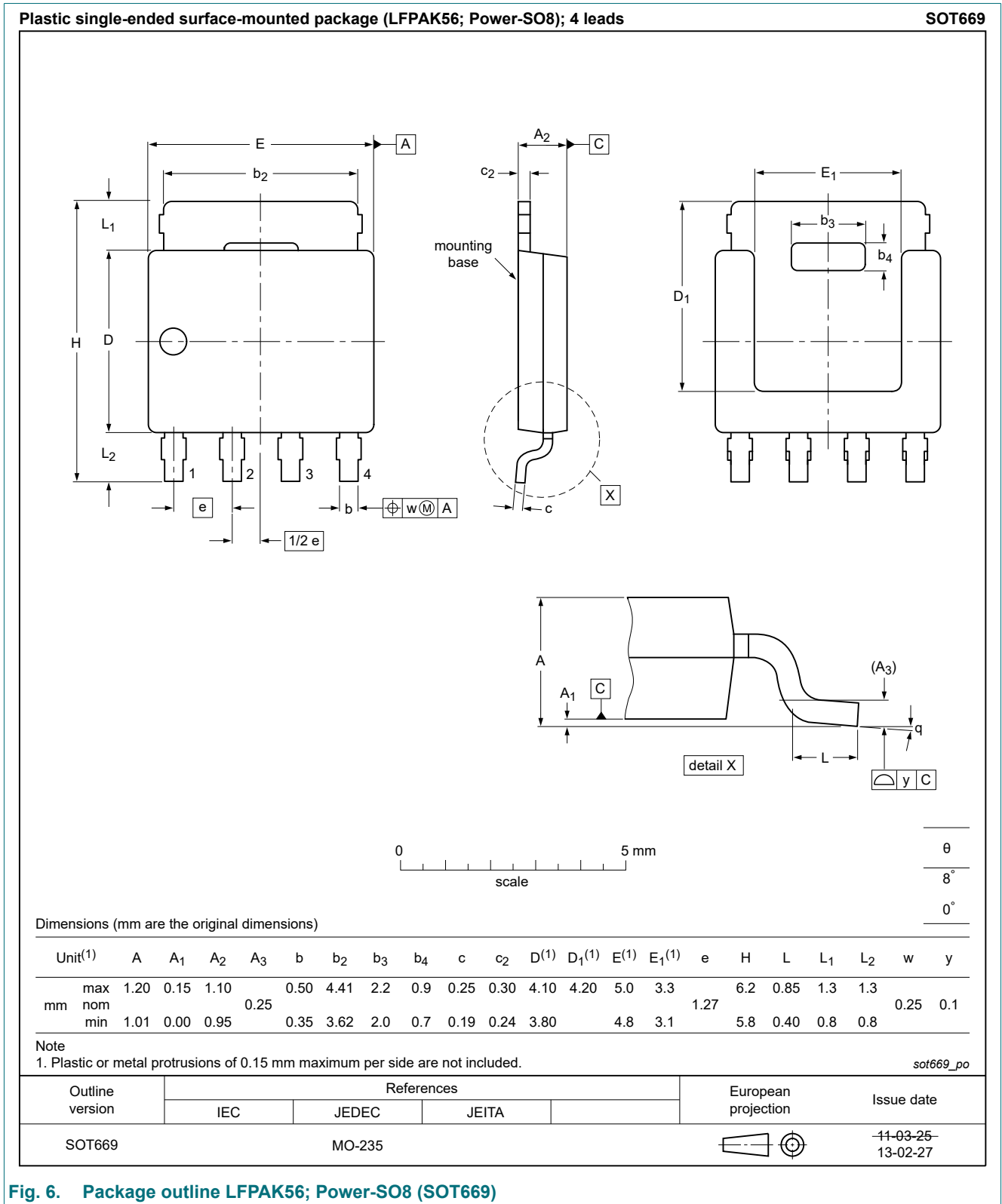


Fig. 6. Package outline LPAK56; Power-SO8 (SOT669)

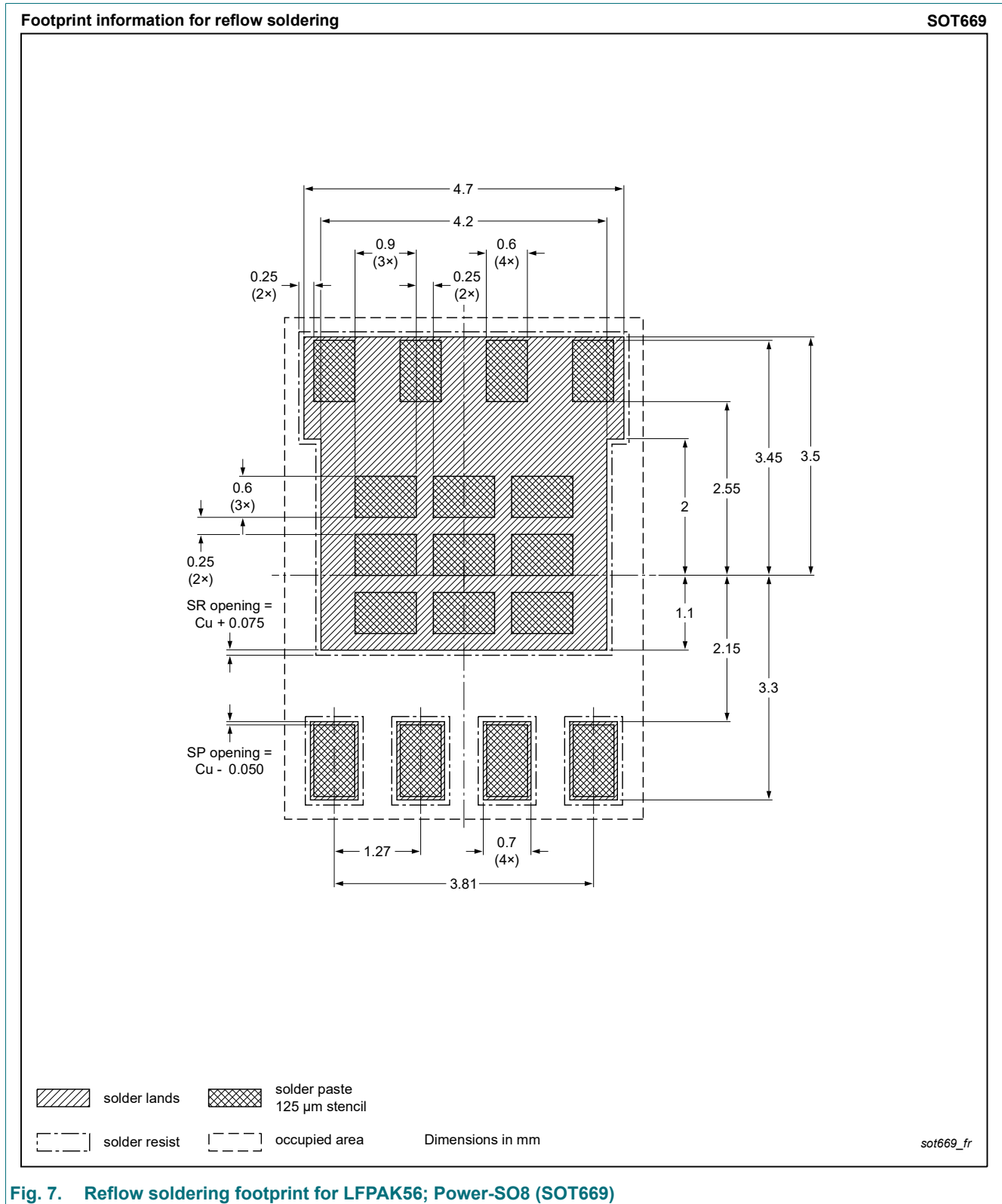
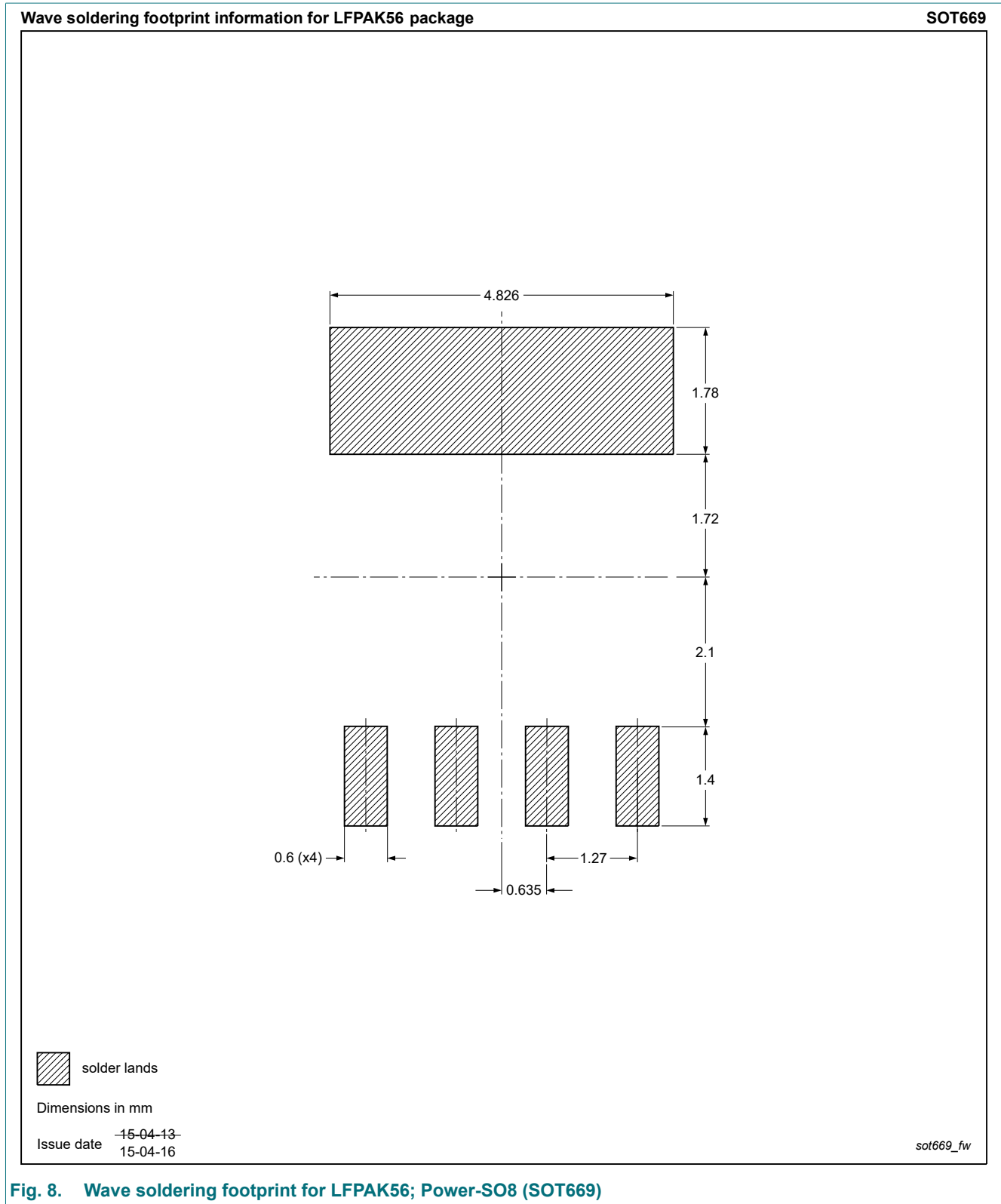


Fig. 7. Reflow soldering footprint for LPAK56; Power-SO8 (SOT669)
