


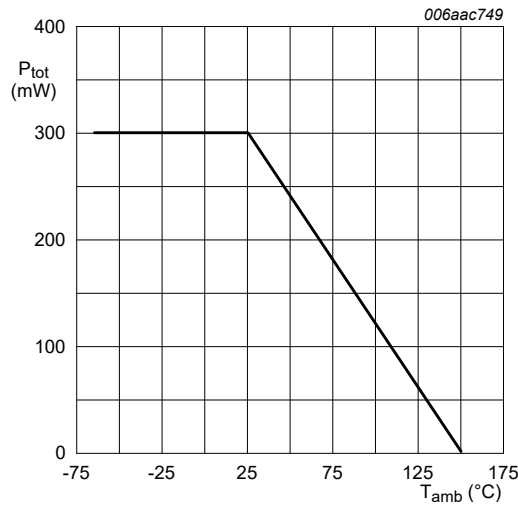

FR4 PCB, single-sided, 35 μm copper, tin-plated and standard footprint

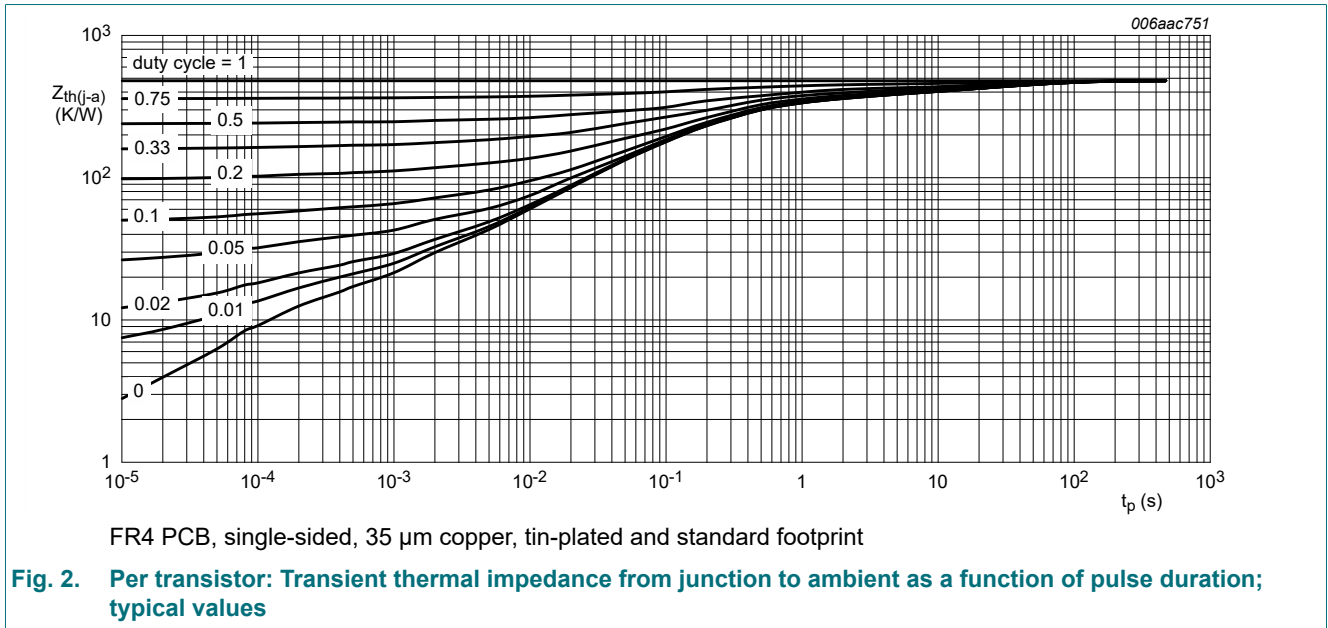
Fig. 1. Per device: Power derating curve

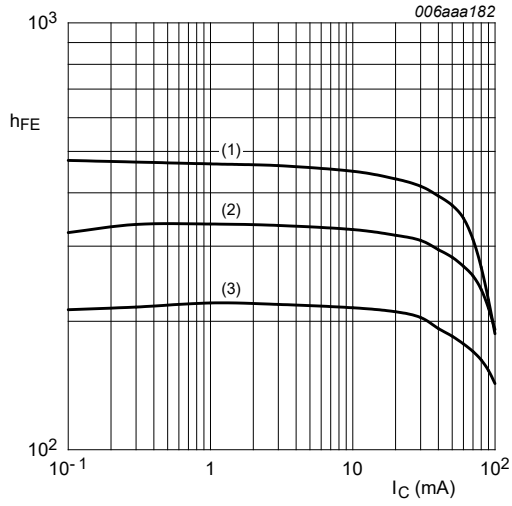

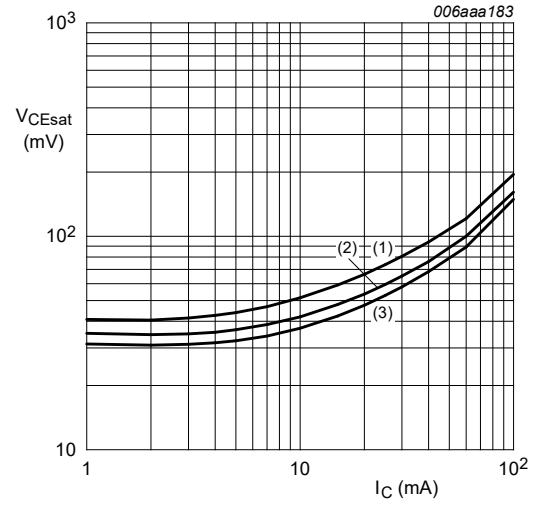

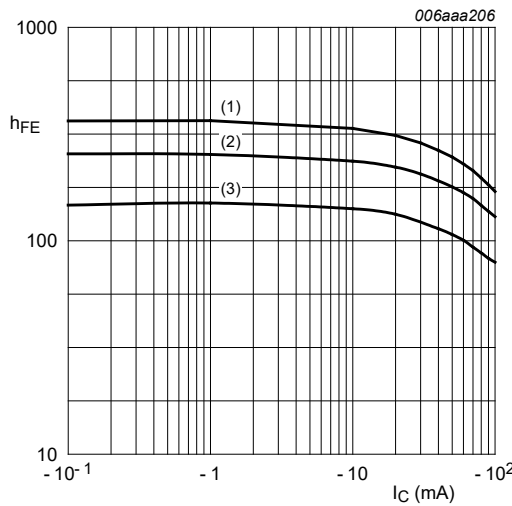

Fig. 3. TR1 (NPN): DC current gain as a function of collector current; typical values



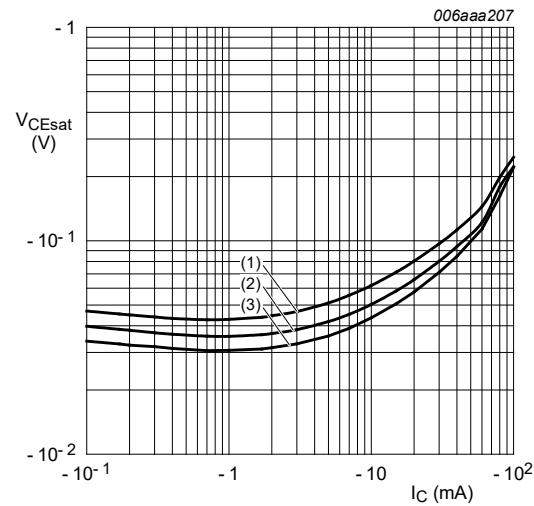

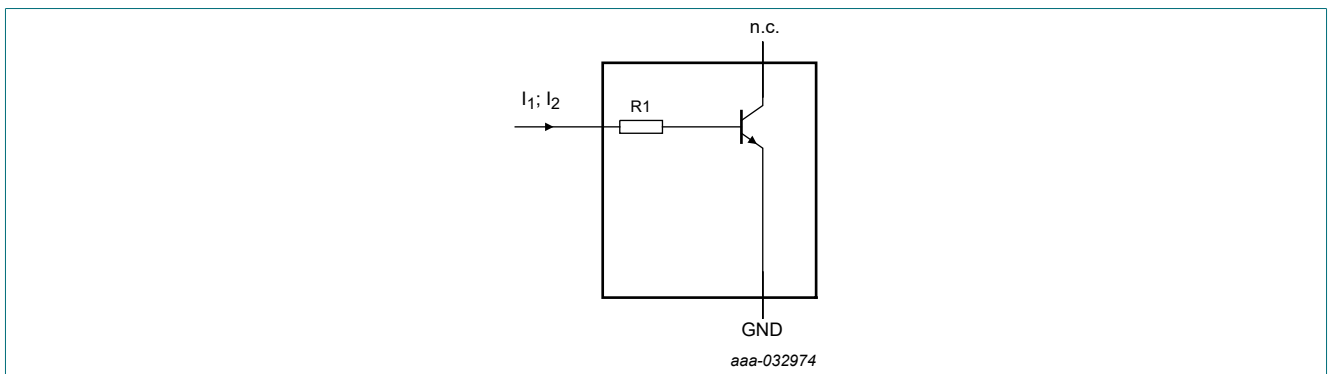


Fig. 7. TR1 (NPN): Resistor test circuit

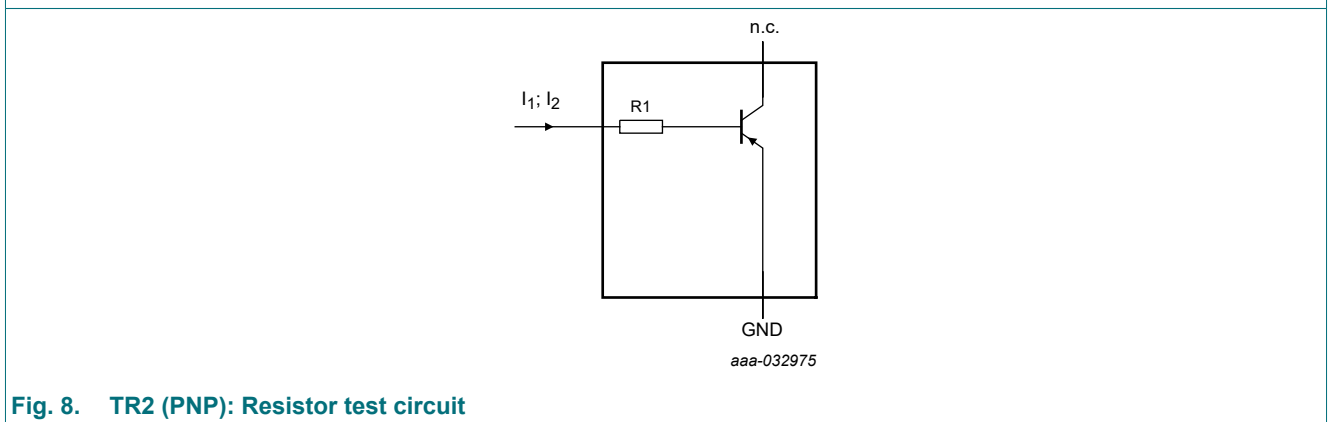


Fig. 8. TR2 (PNP): Resistor test circuit

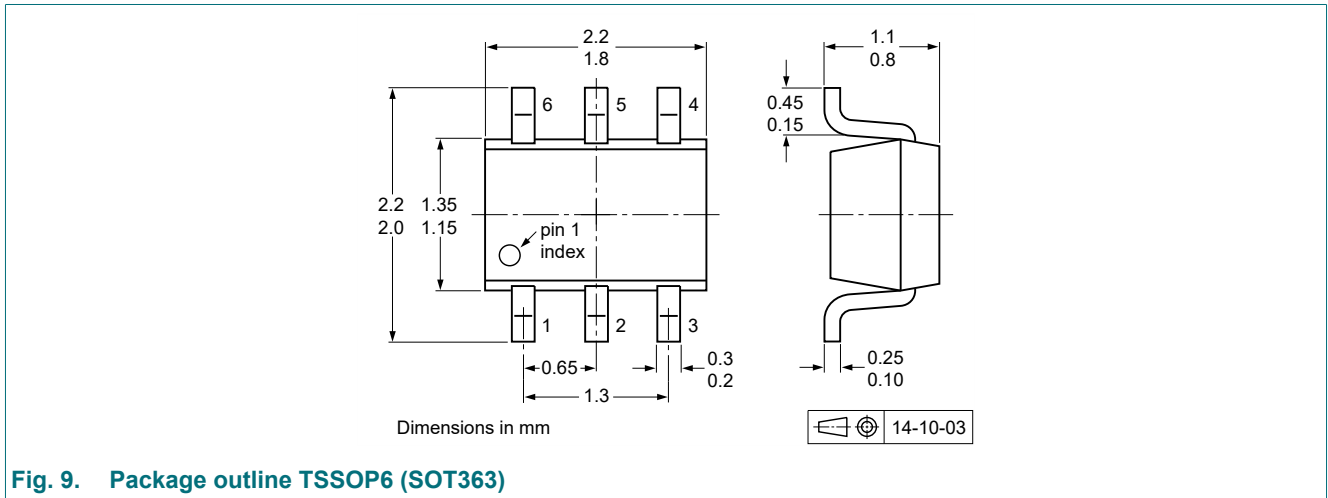


Fig. 9. Package outline TSSOP6 (SOT363)

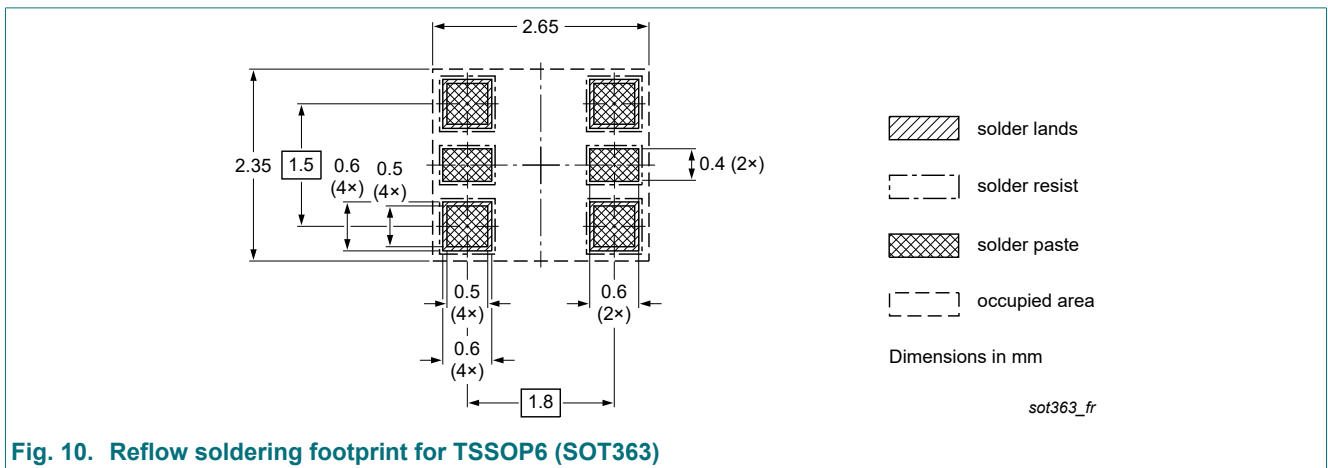


Fig. 10. Reflow soldering footprint for TSSOP6 (SOT363)

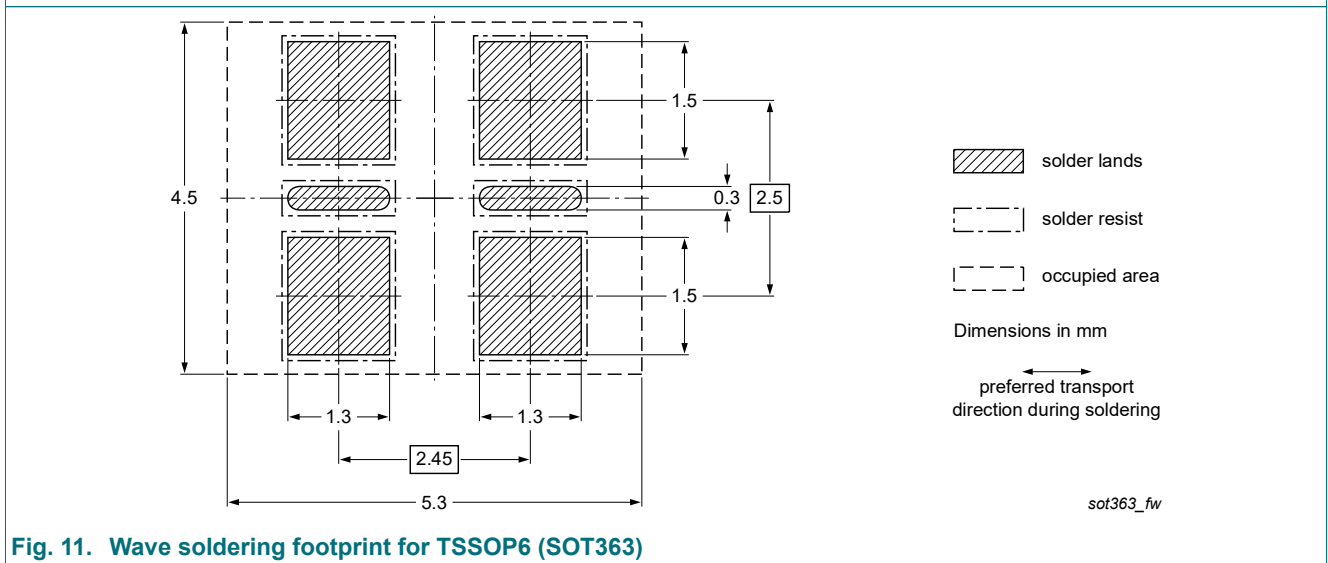


Fig. 11. Wave soldering footprint for TSSOP6 (SOT363)
