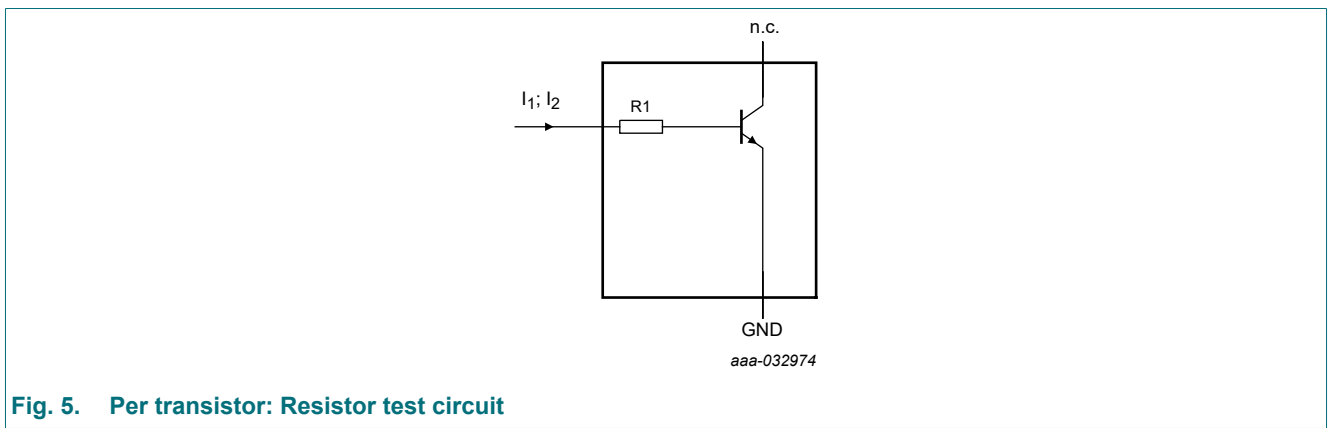


Fig. 5. Per transistor: Resistor test circuit

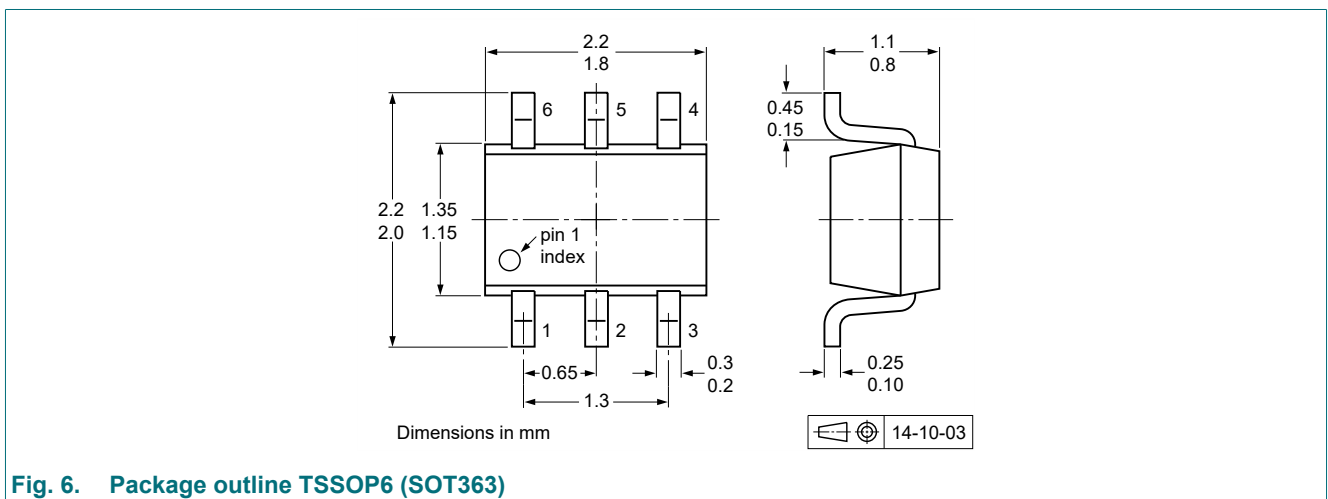


Fig. 6. Package outline TSSOP6 (SOT363)
