

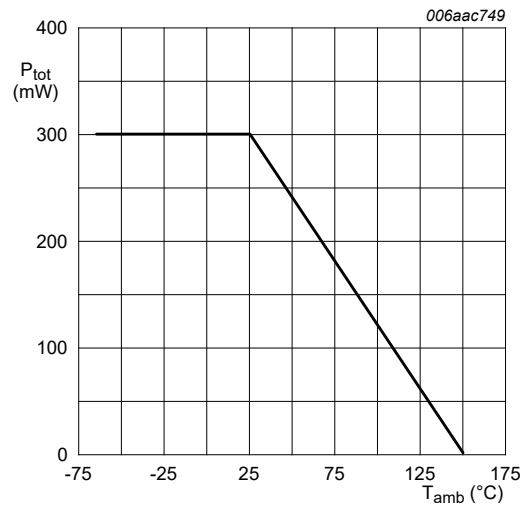

FR4 PCB, single-sided, 35 μm copper, tin-plated and standard footprint

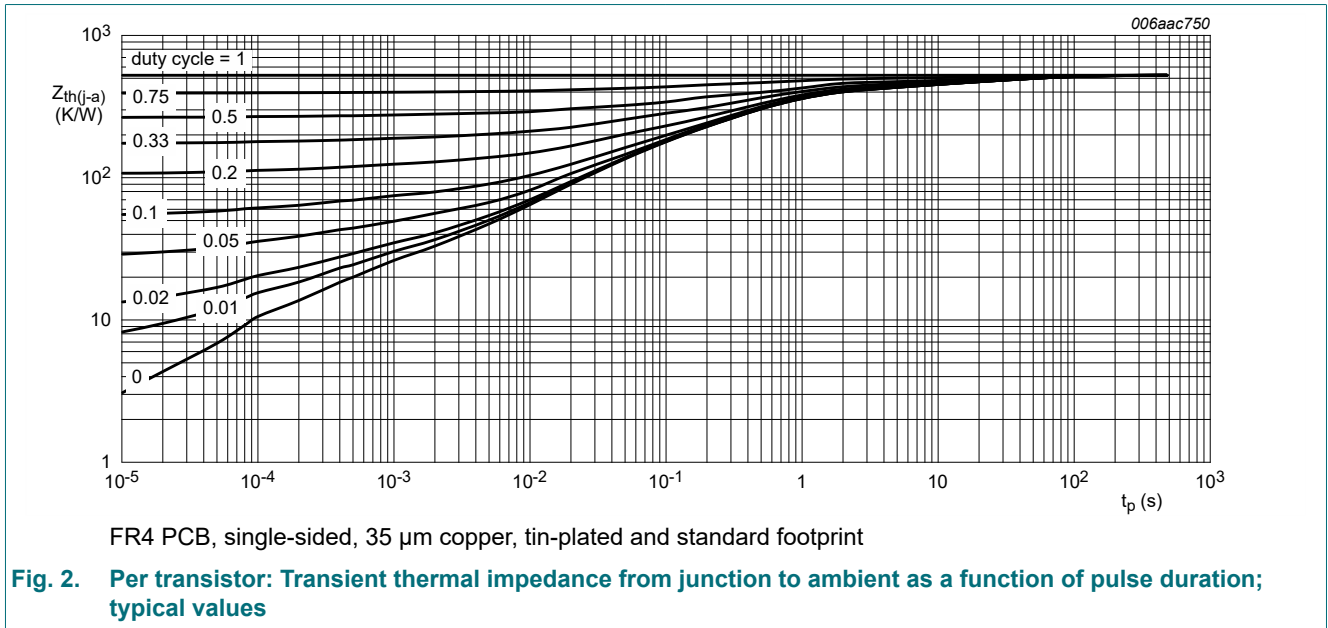
Fig. 1. Per device: Power derating curve

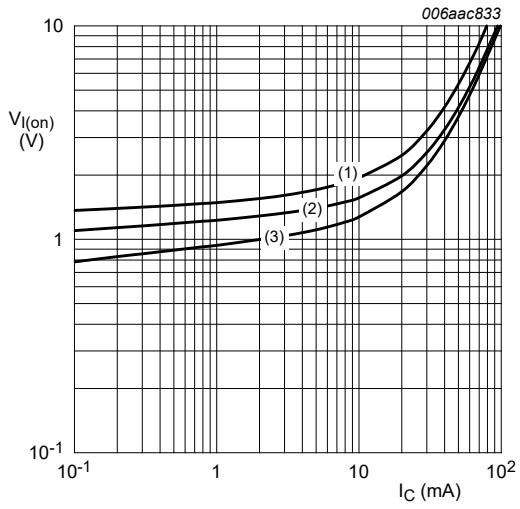

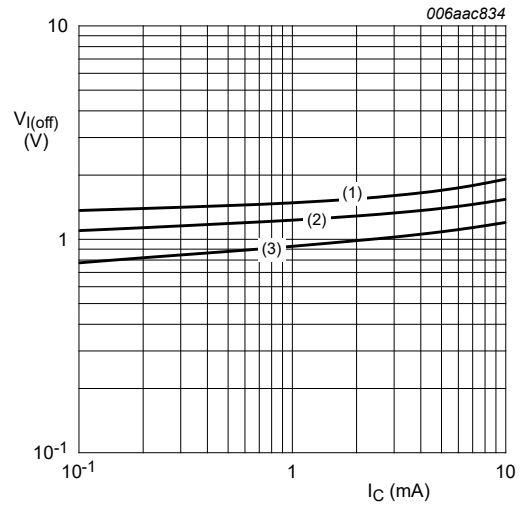

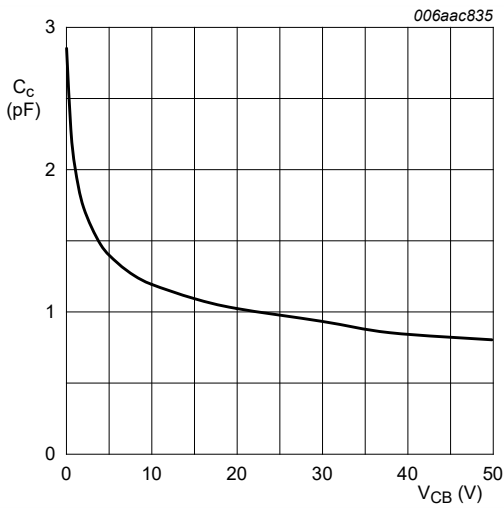

Fig. 5. On-state input voltage as a function of collector current; typical values



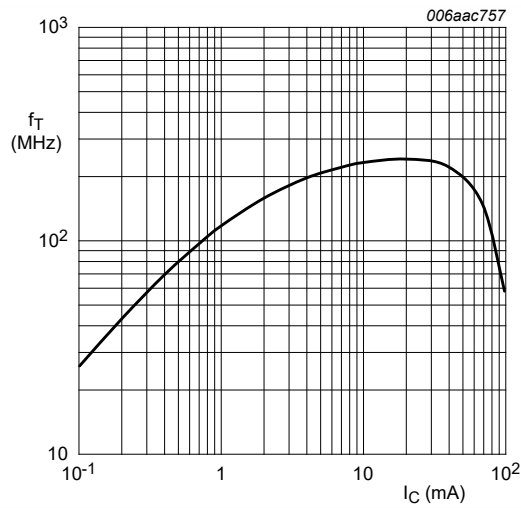

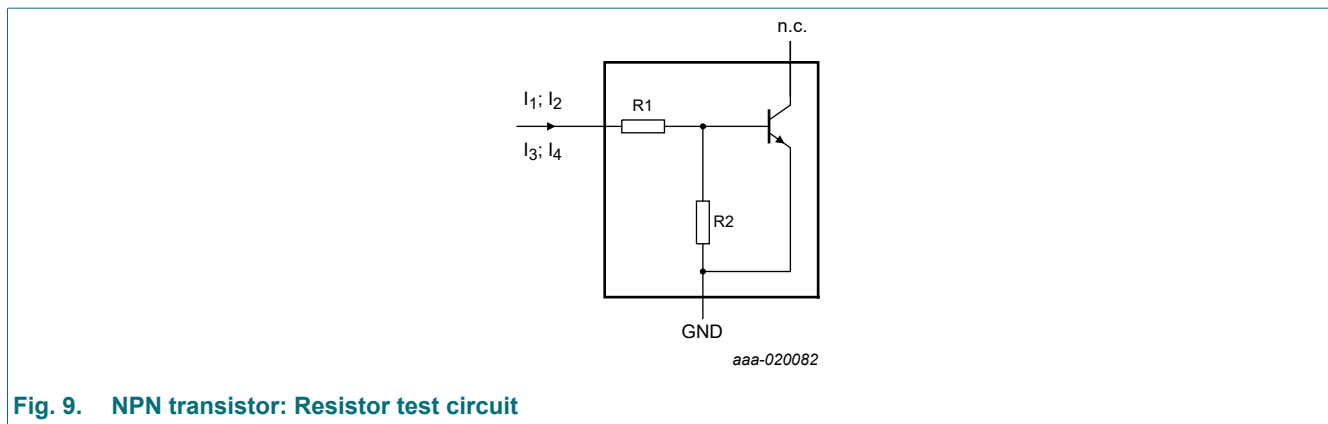


Fig. 9. NPN transistor: Resistor test circuit

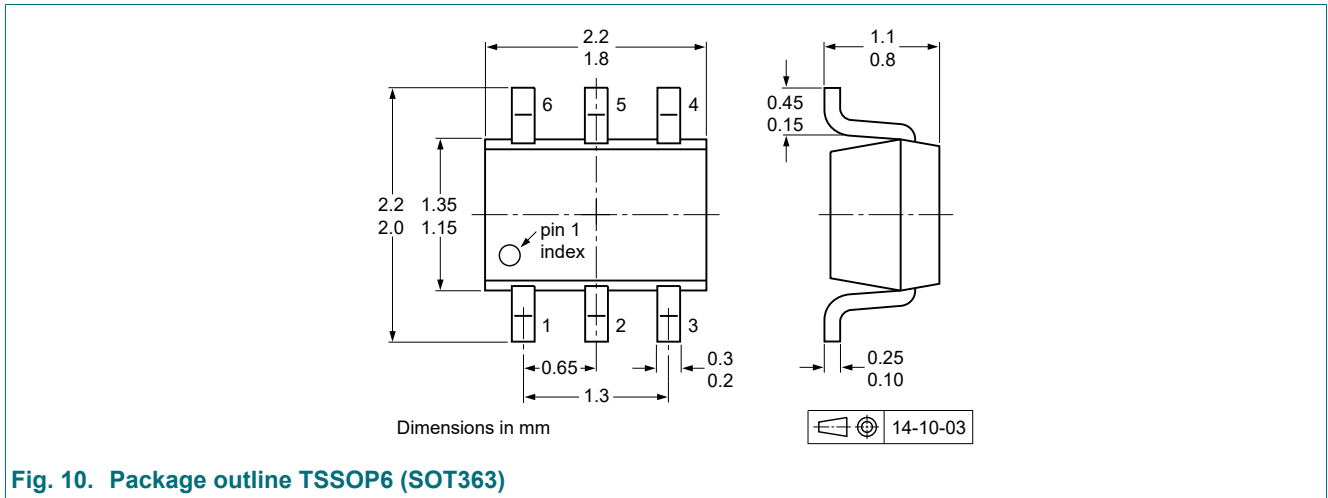


Fig. 10. Package outline TSSOP6 (SOT363)

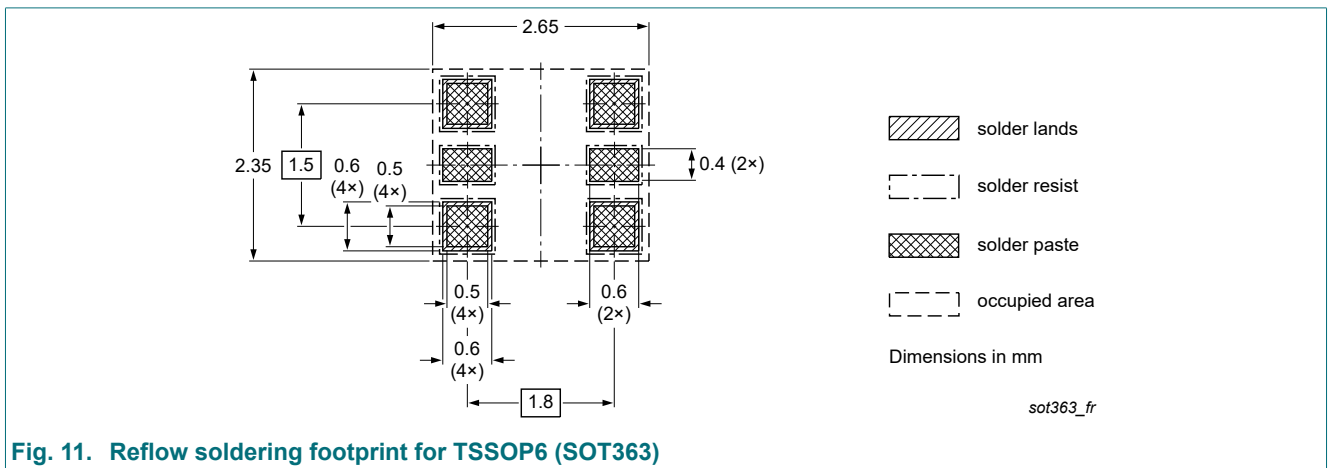


Fig. 11. Reflow soldering footprint for TSSOP6 (SOT363)

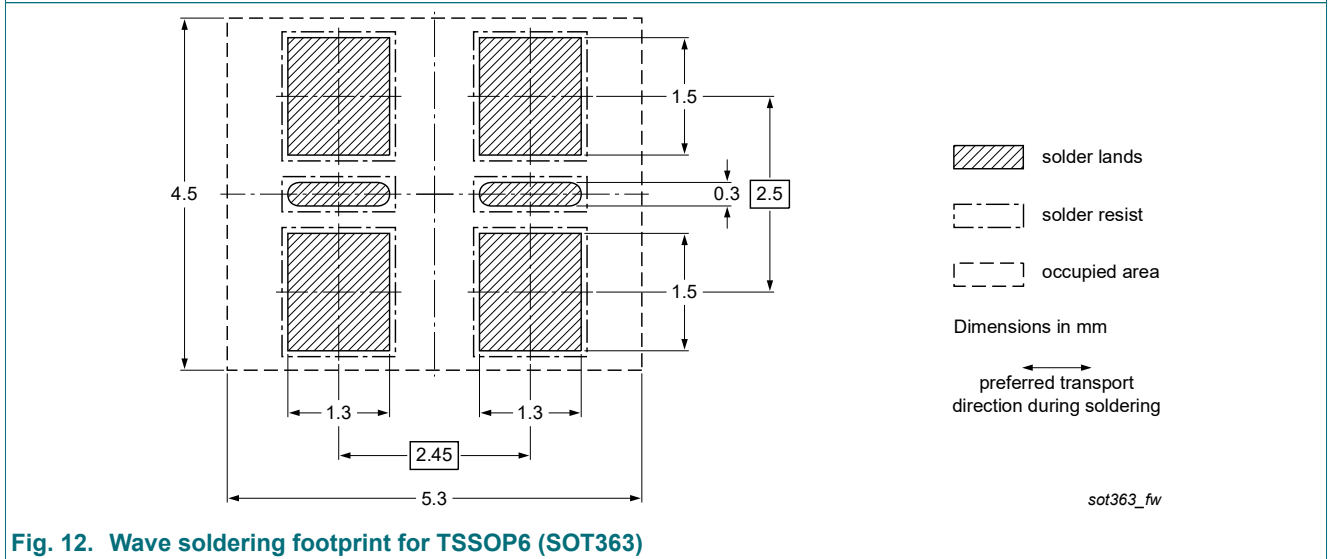


Fig. 12. Wave soldering footprint for TSSOP6 (SOT363)
