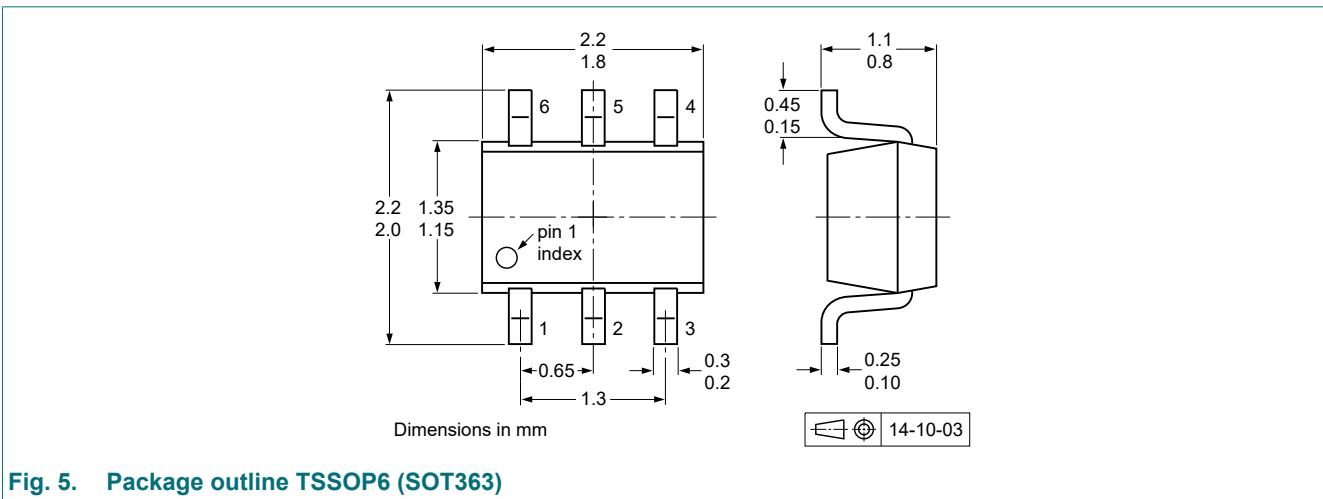

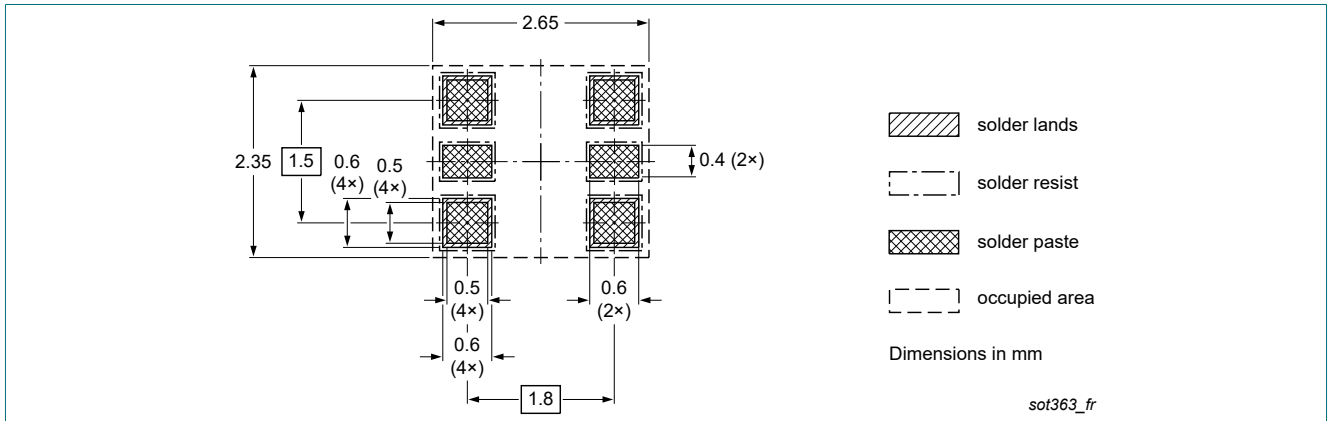


Fig. 6. Reflow soldering footprint for TSSOP6 (SOT363)

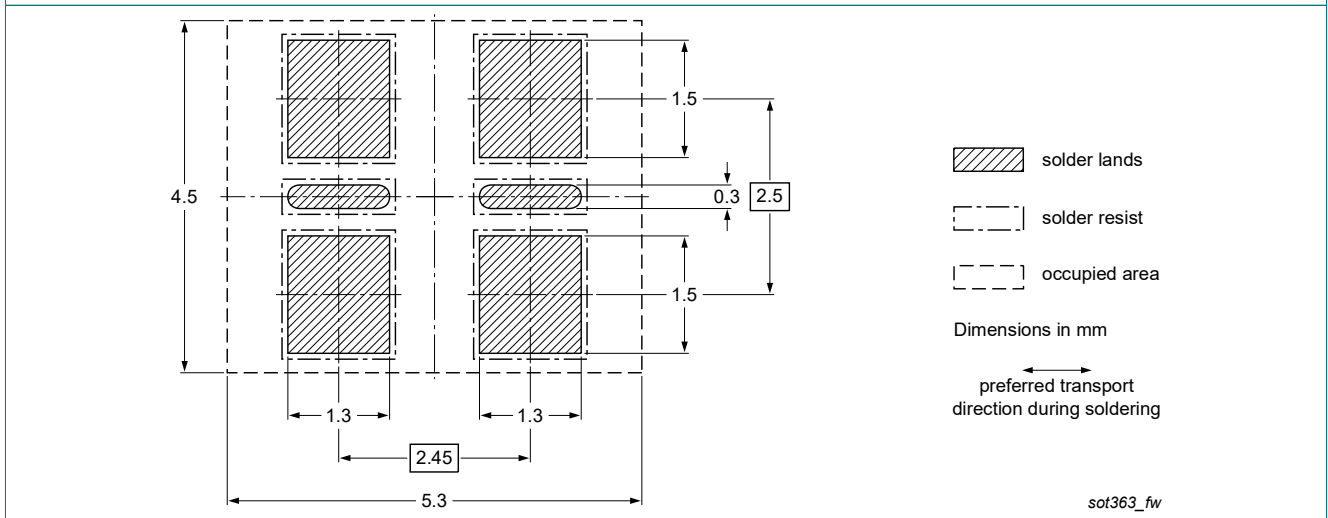


Fig. 7. Wave soldering footprint for TSSOP6 (SOT363)
