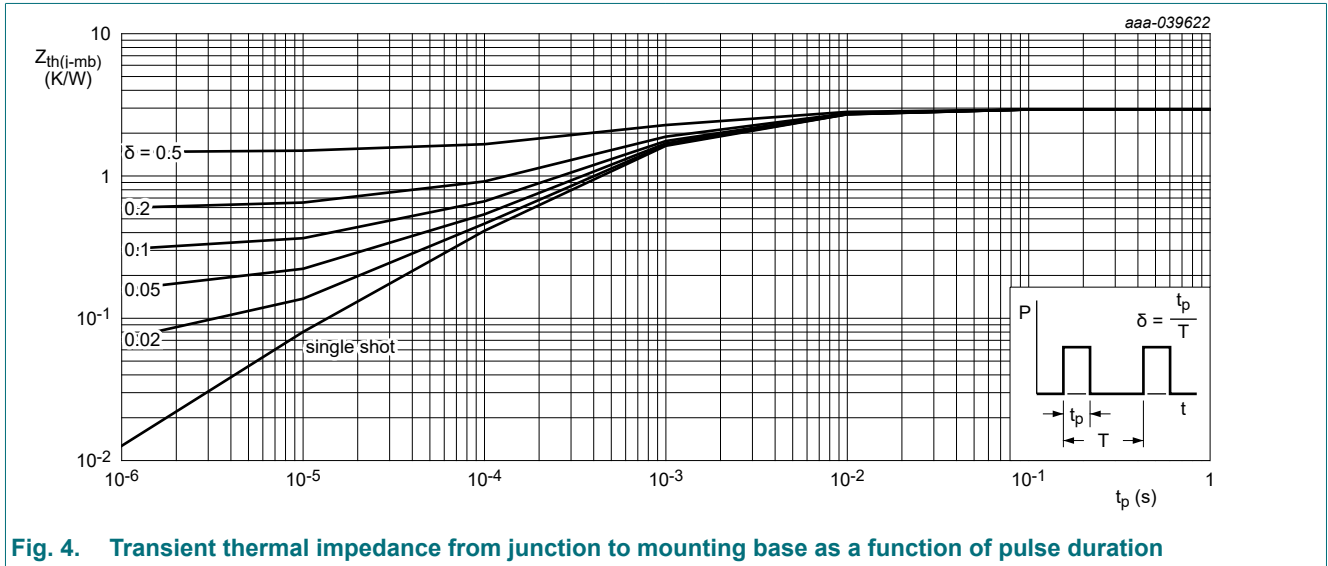


Fig. 4. Transient thermal impedance from junction to mounting base as a function of pulse duration

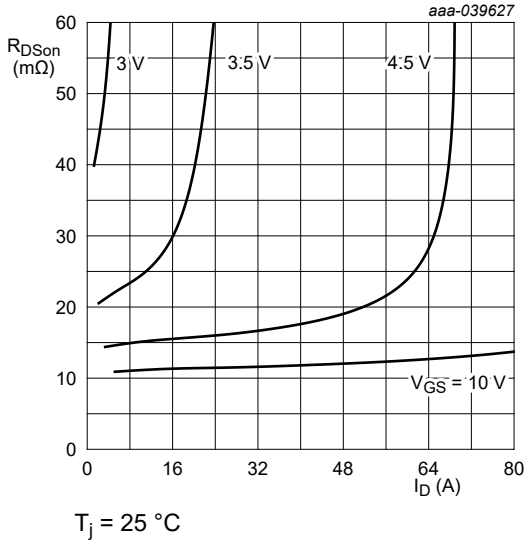
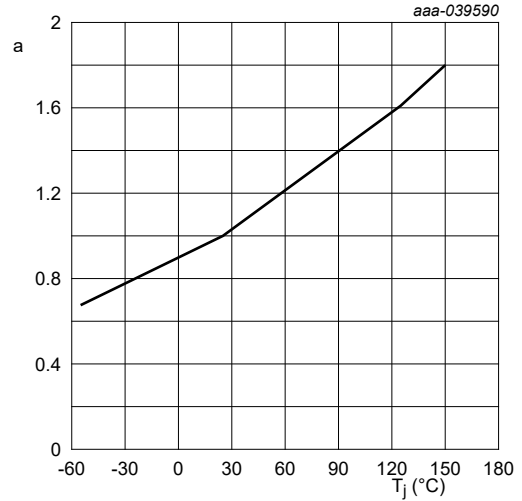


Fig. 9. Drain-source on-state resistance as a function of drain current; typical values

Fig. 10. Normalized drain-source on-state resistance factor as a function of junction temperature

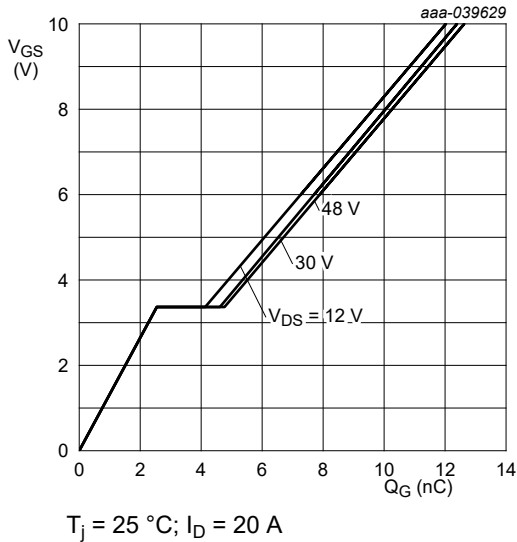


Fig. 11. Gate-source voltage as a function of gate charge; typical values

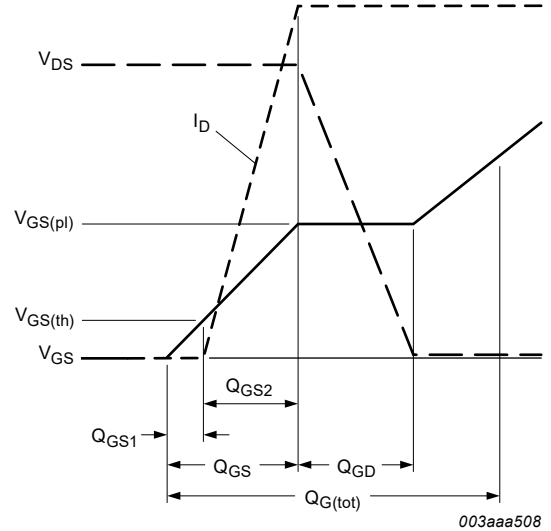
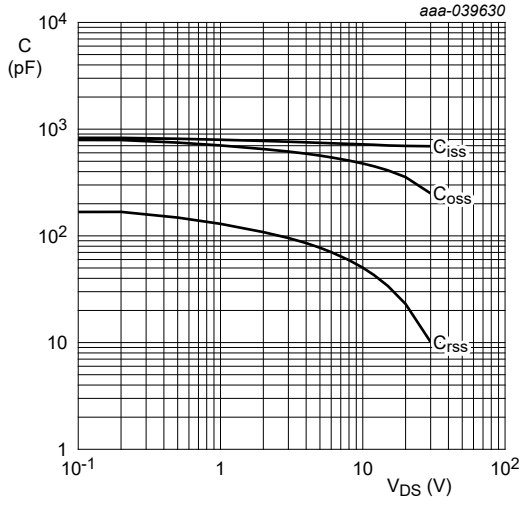
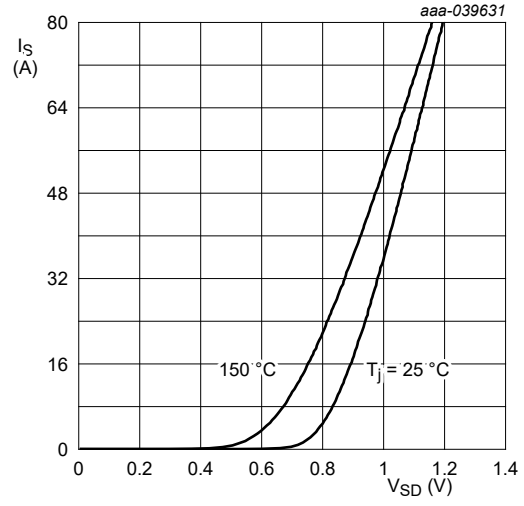


Fig. 12. Gate charge waveform definitions



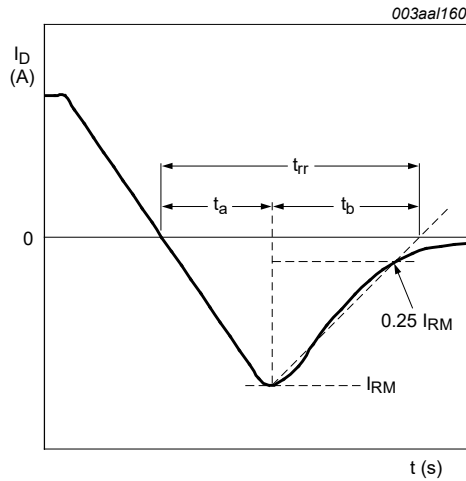

**Fig. 14.** Source-drain (diode forward) current as a function of source-drain (diode forward) voltage; typical values



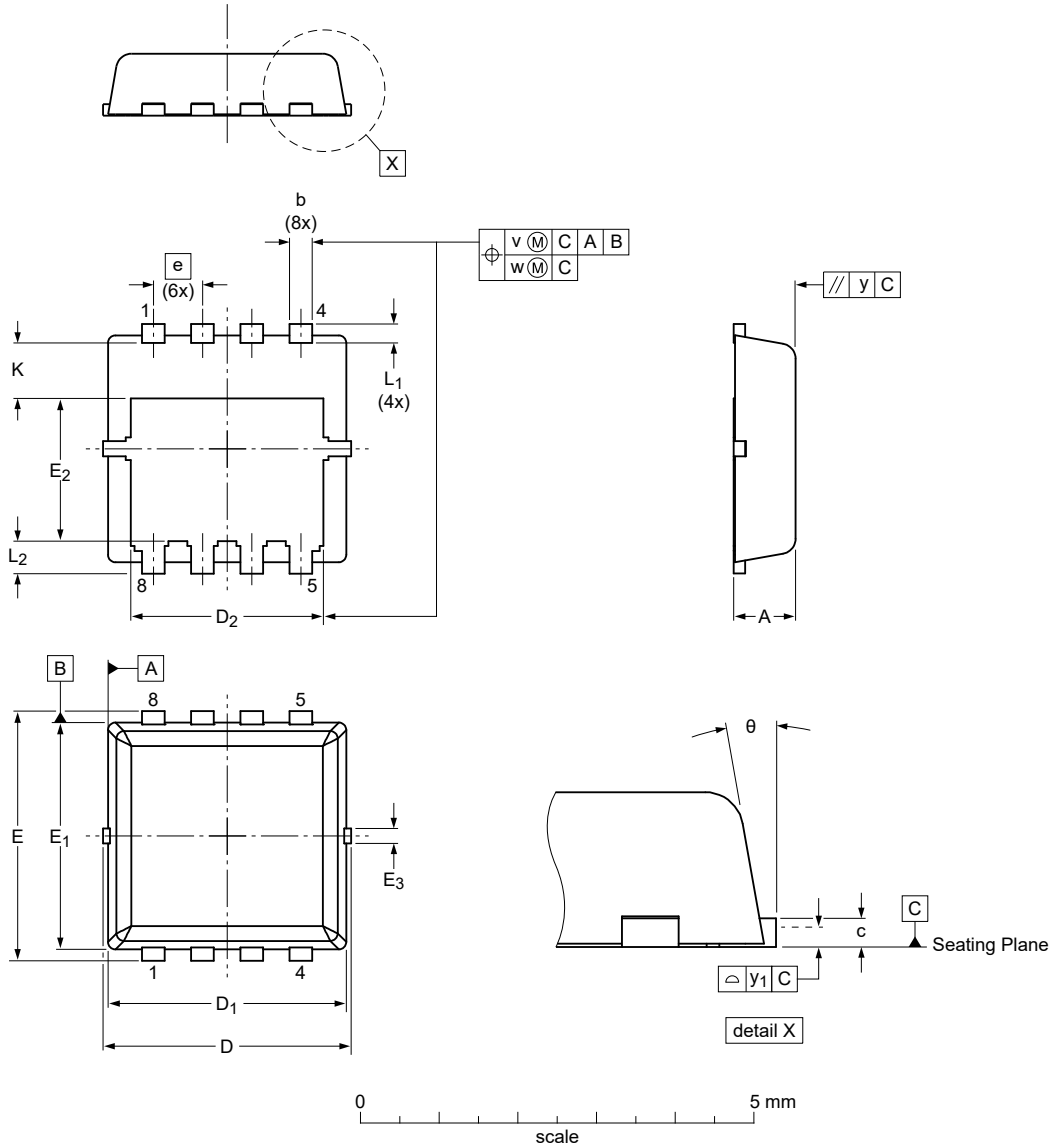
**Fig. 15.** Reverse recovery timing definition

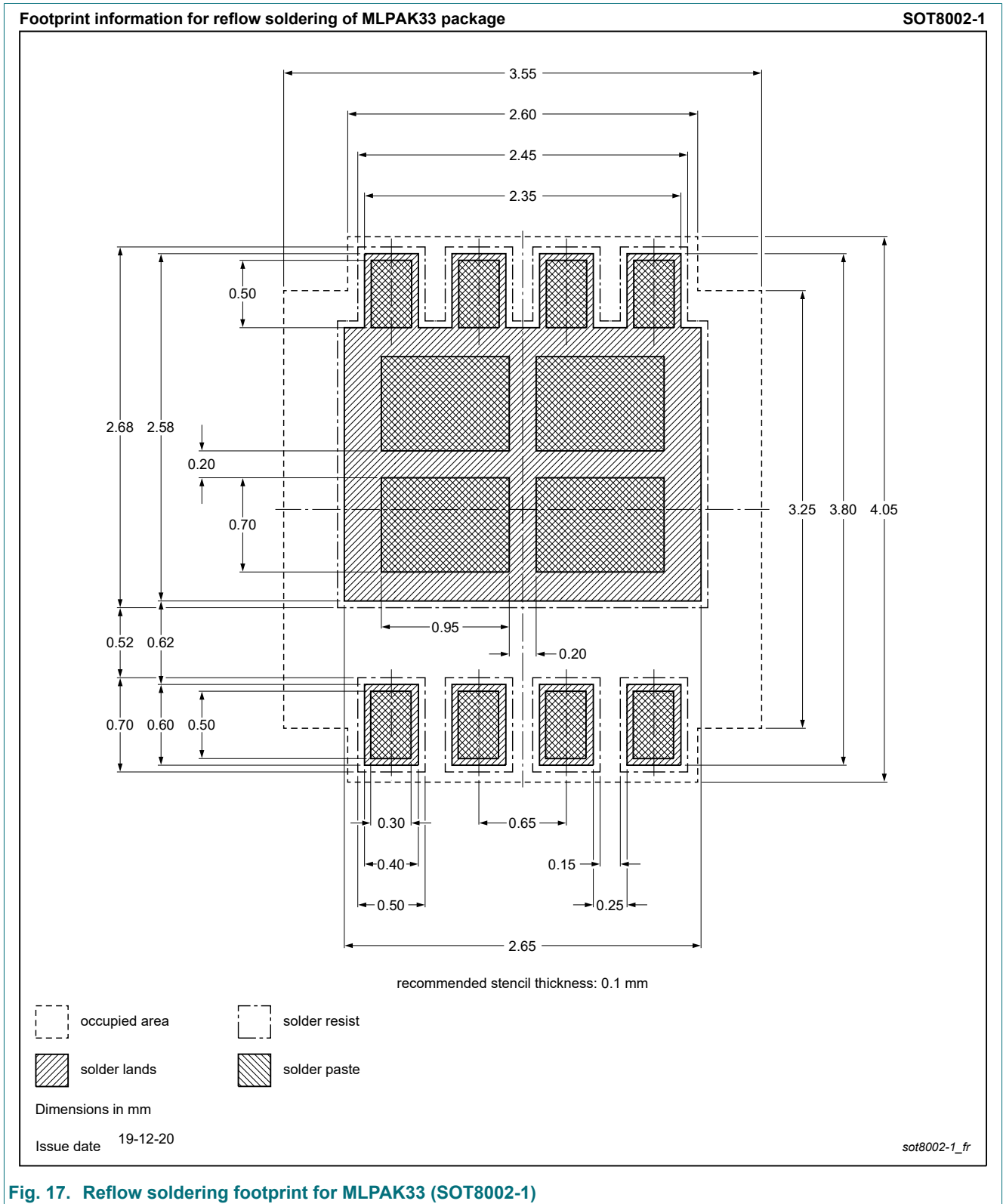


Fig. 17. Reflow soldering footprint for MLPAK33 (SOT8002-1)
