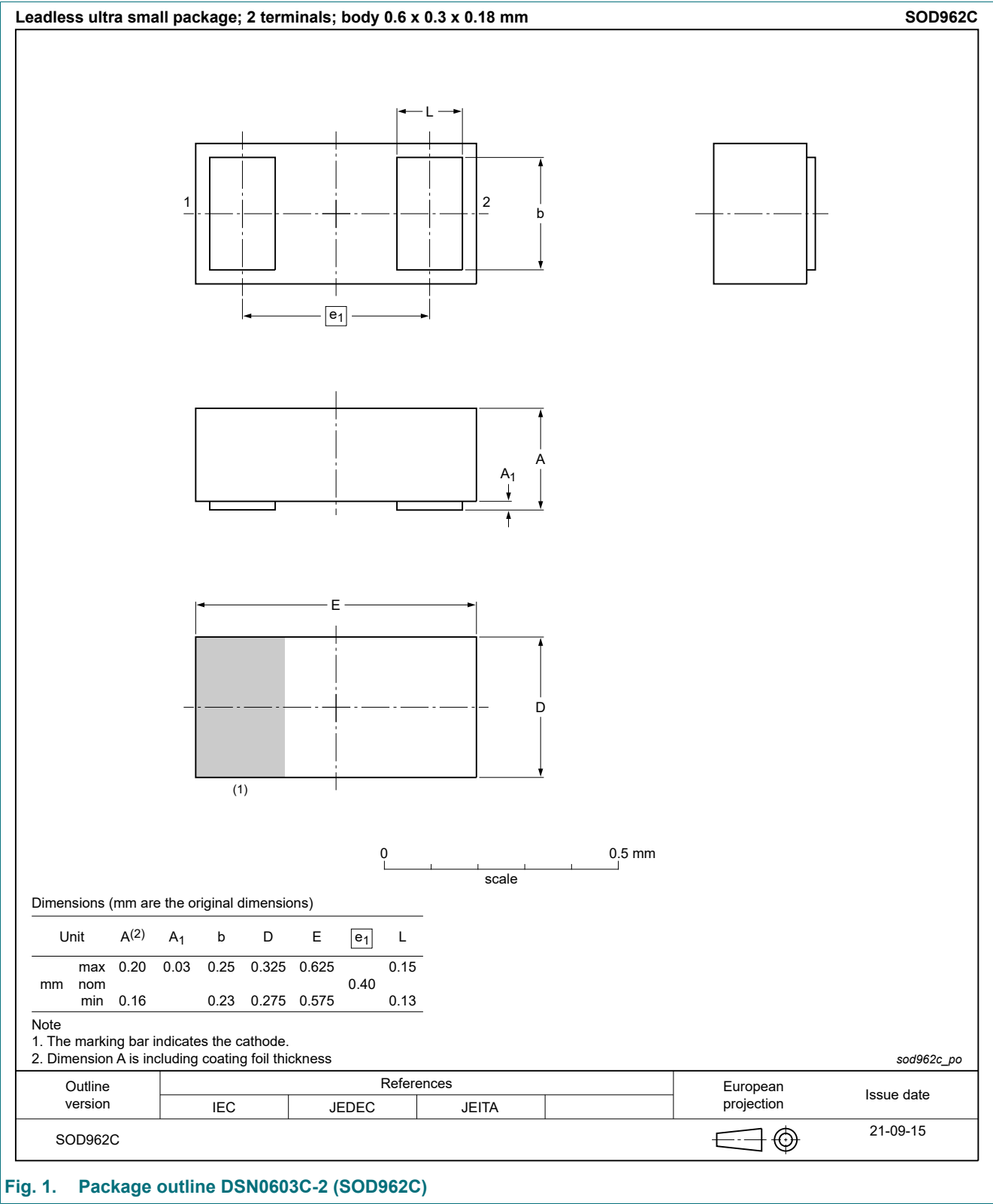


Fig. 1. Package outline DSN0603C-2 (SOD962C)

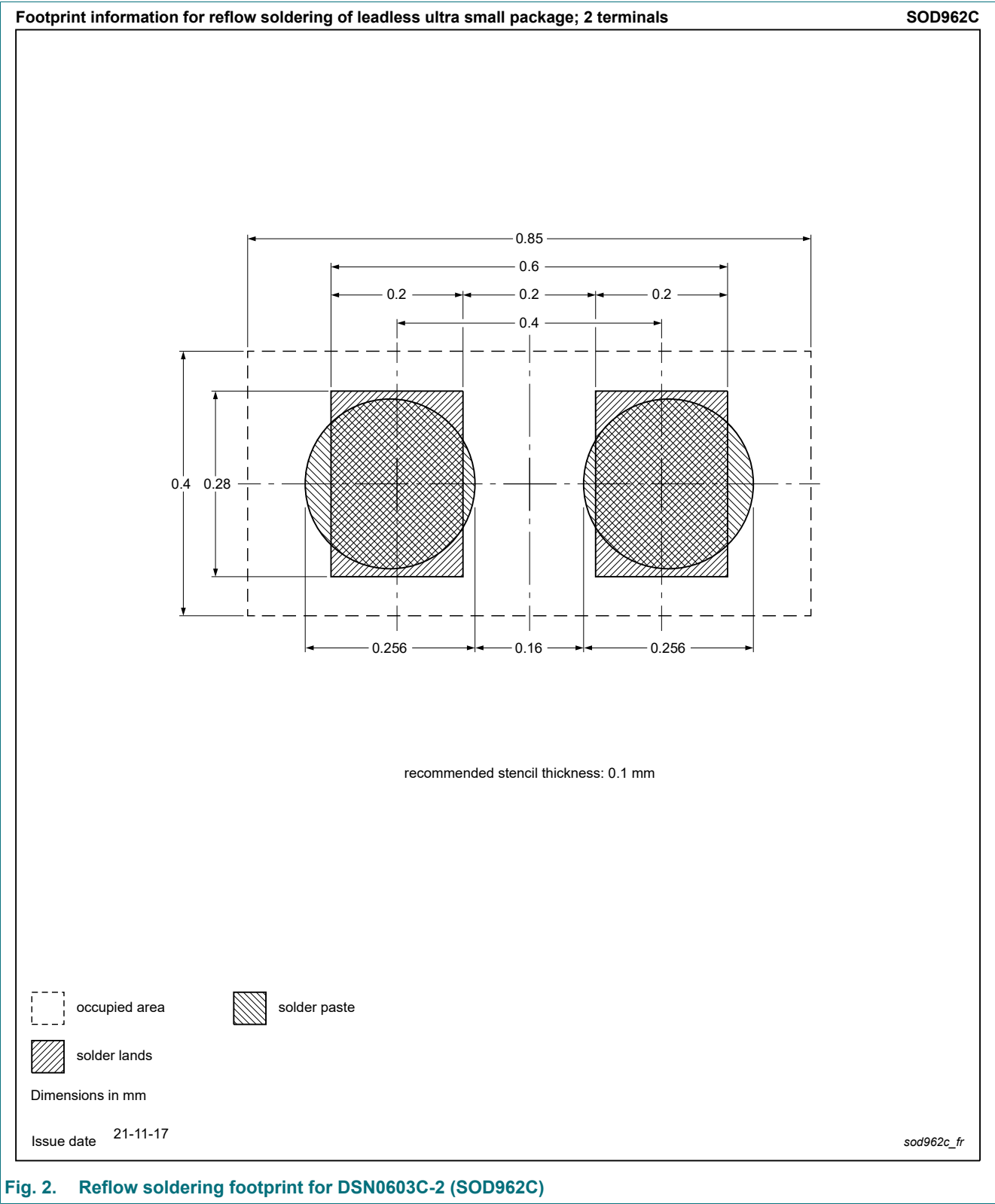


Fig. 2. Reflow soldering footprint for DSN0603C-2 (SOD962C)
