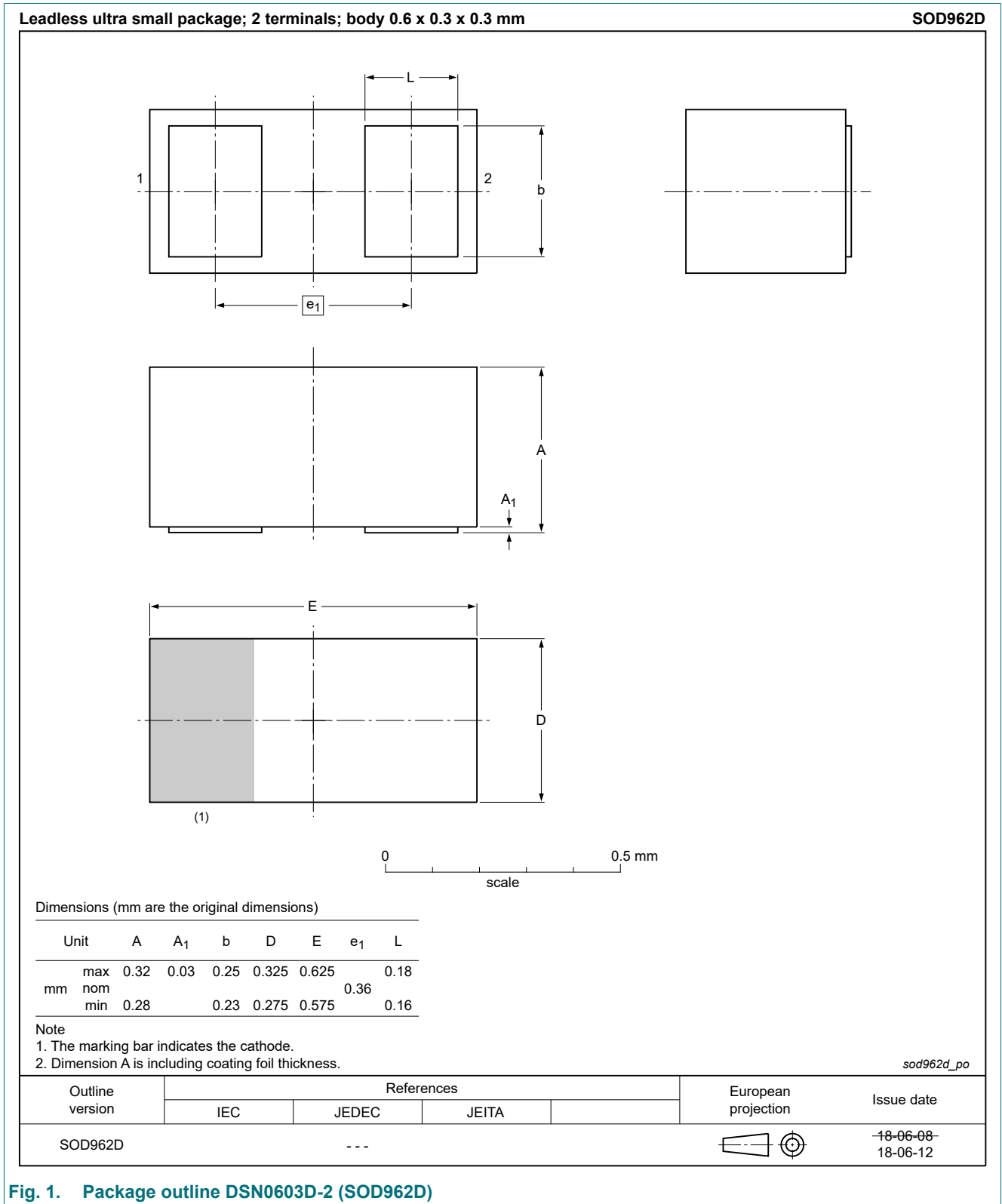
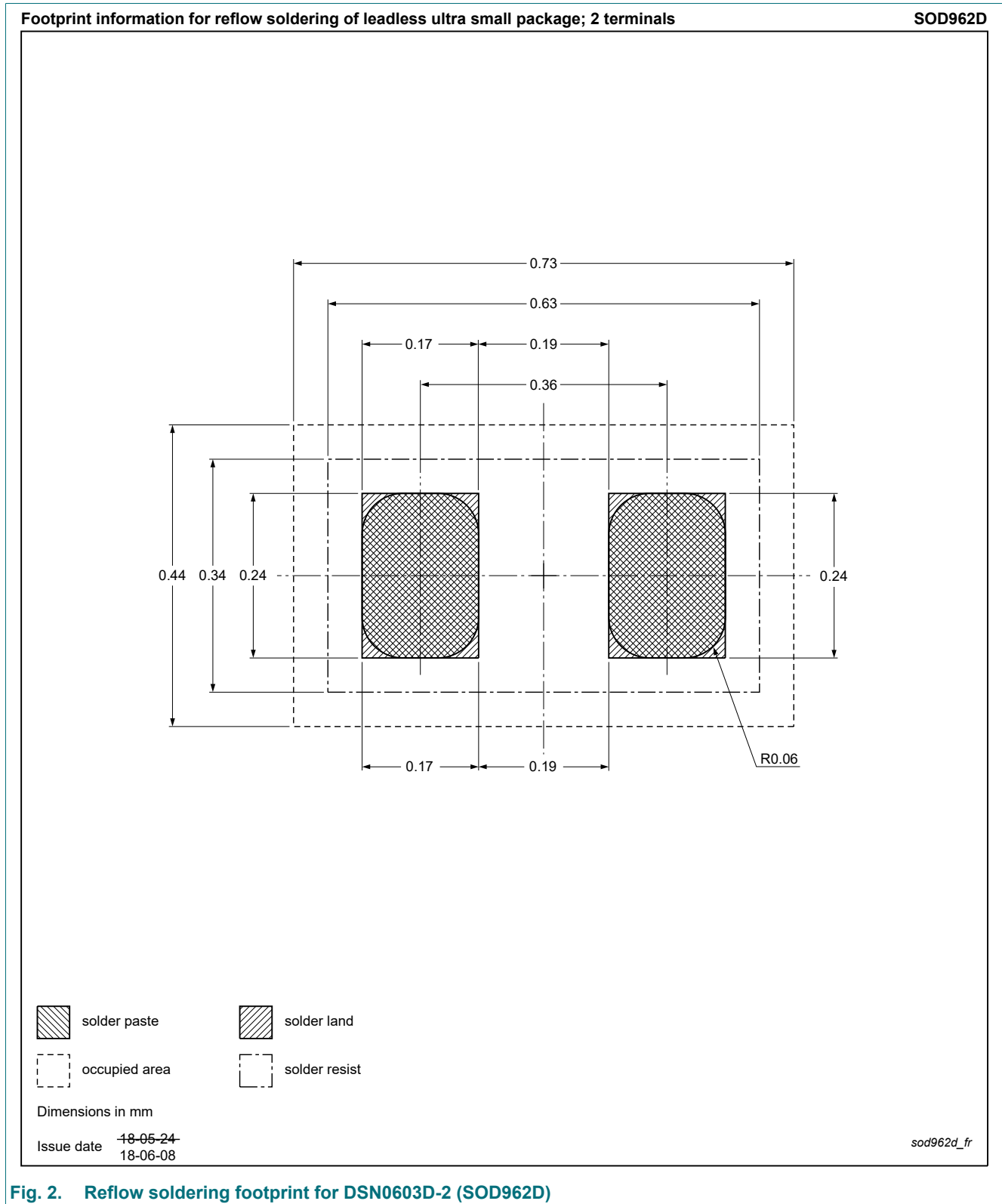


Fig. 1. Package outline DSN0603D-2 (SOD962D)
