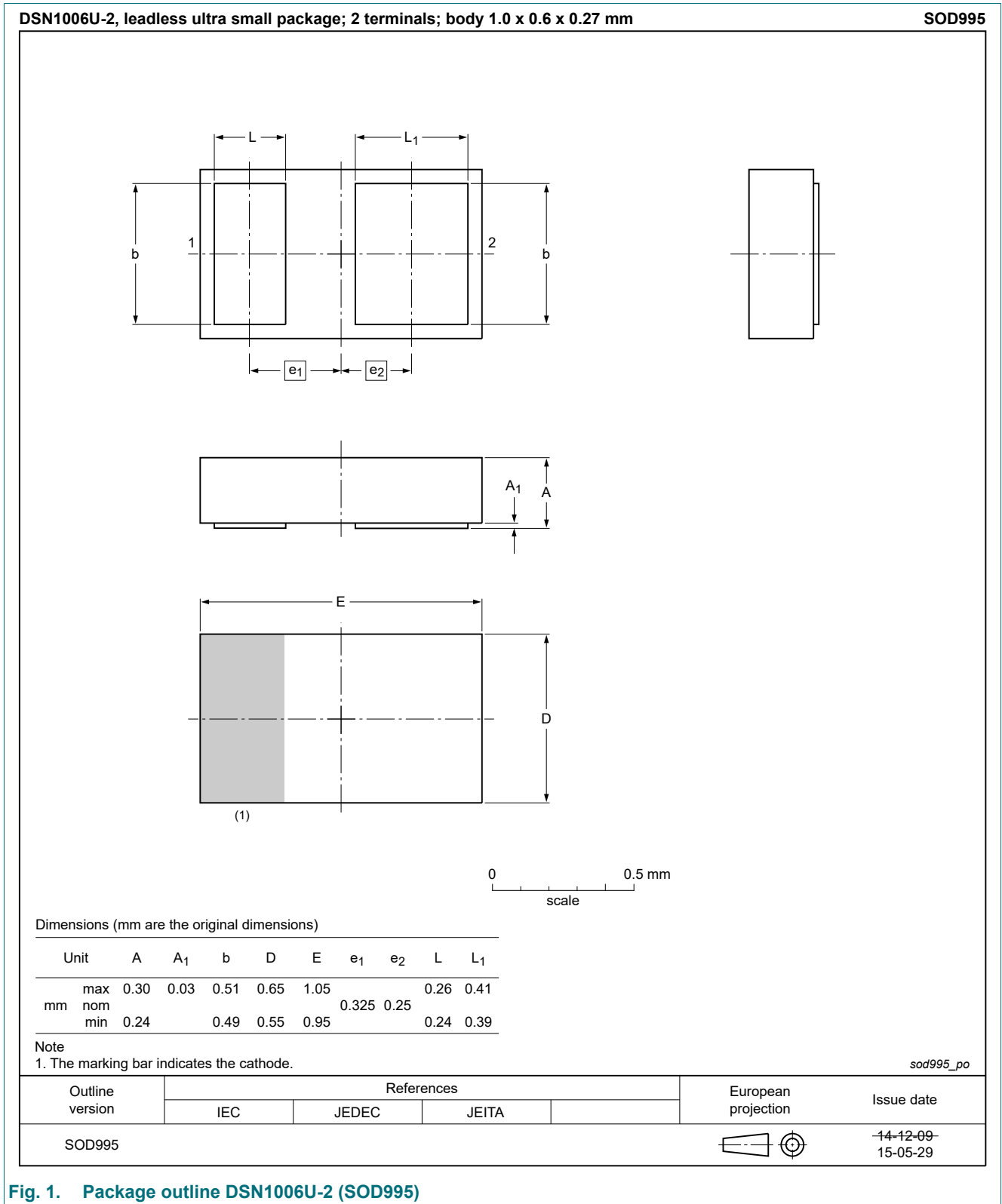


Fig. 1. Package outline DSN1006U-2 (SOD995)

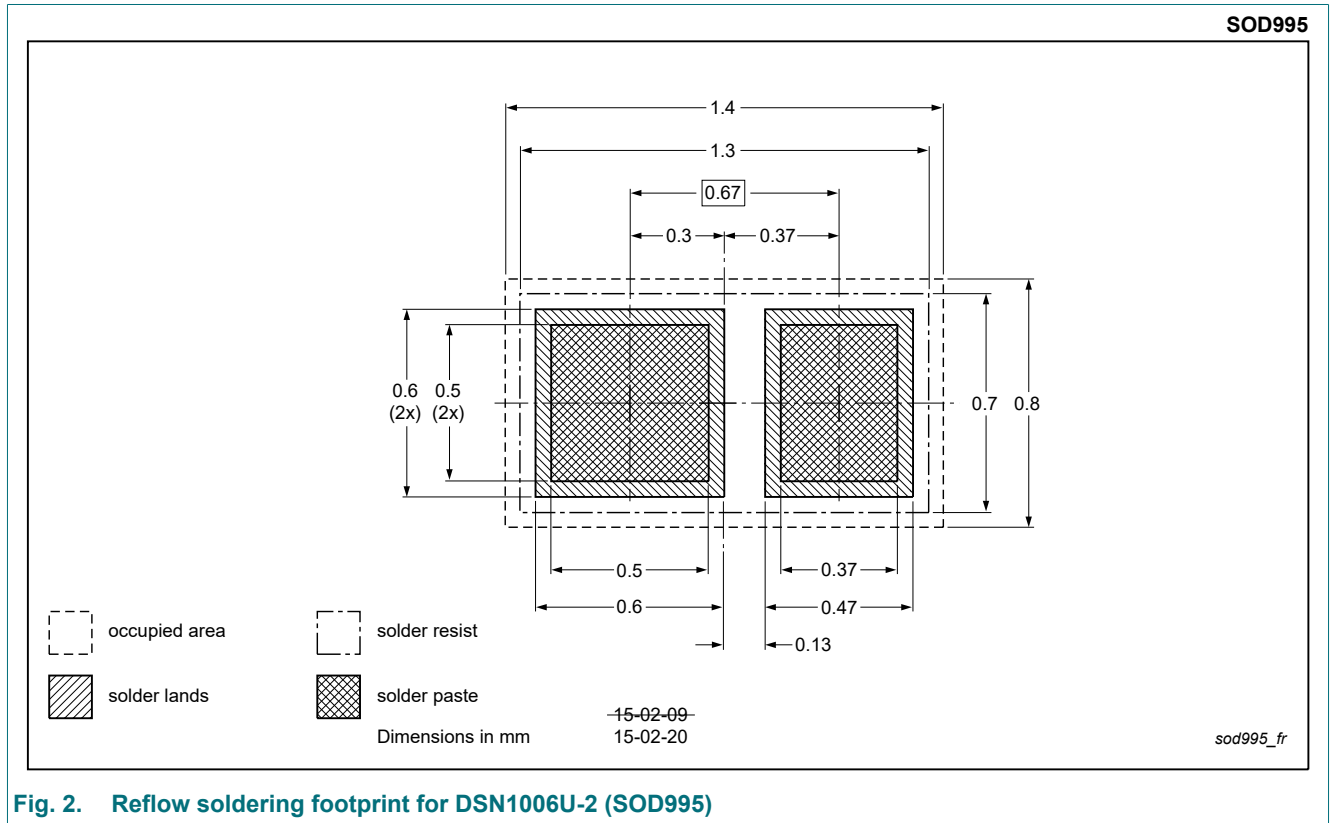


Fig. 2. Reflow soldering footprint for DSN1006U-2 (SOD995)
