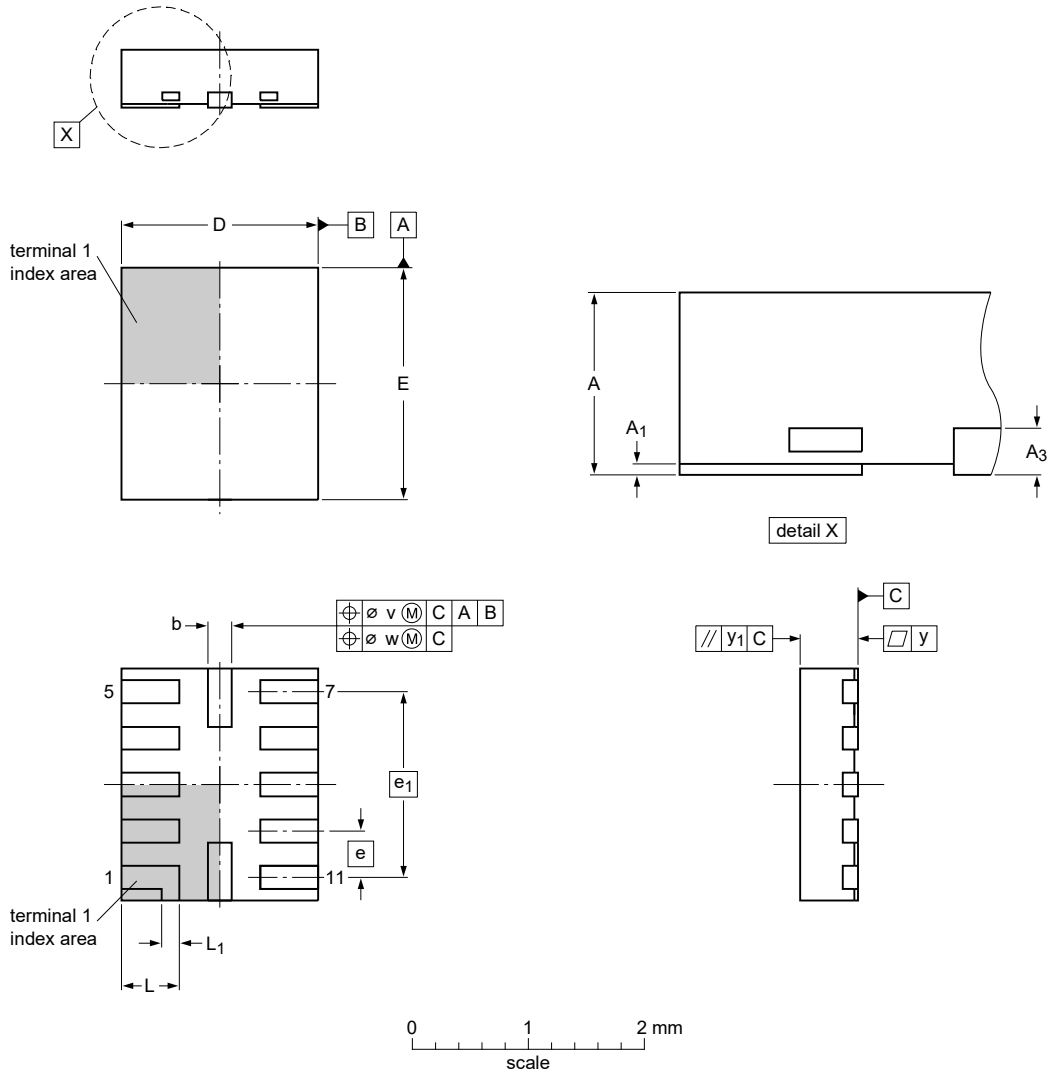

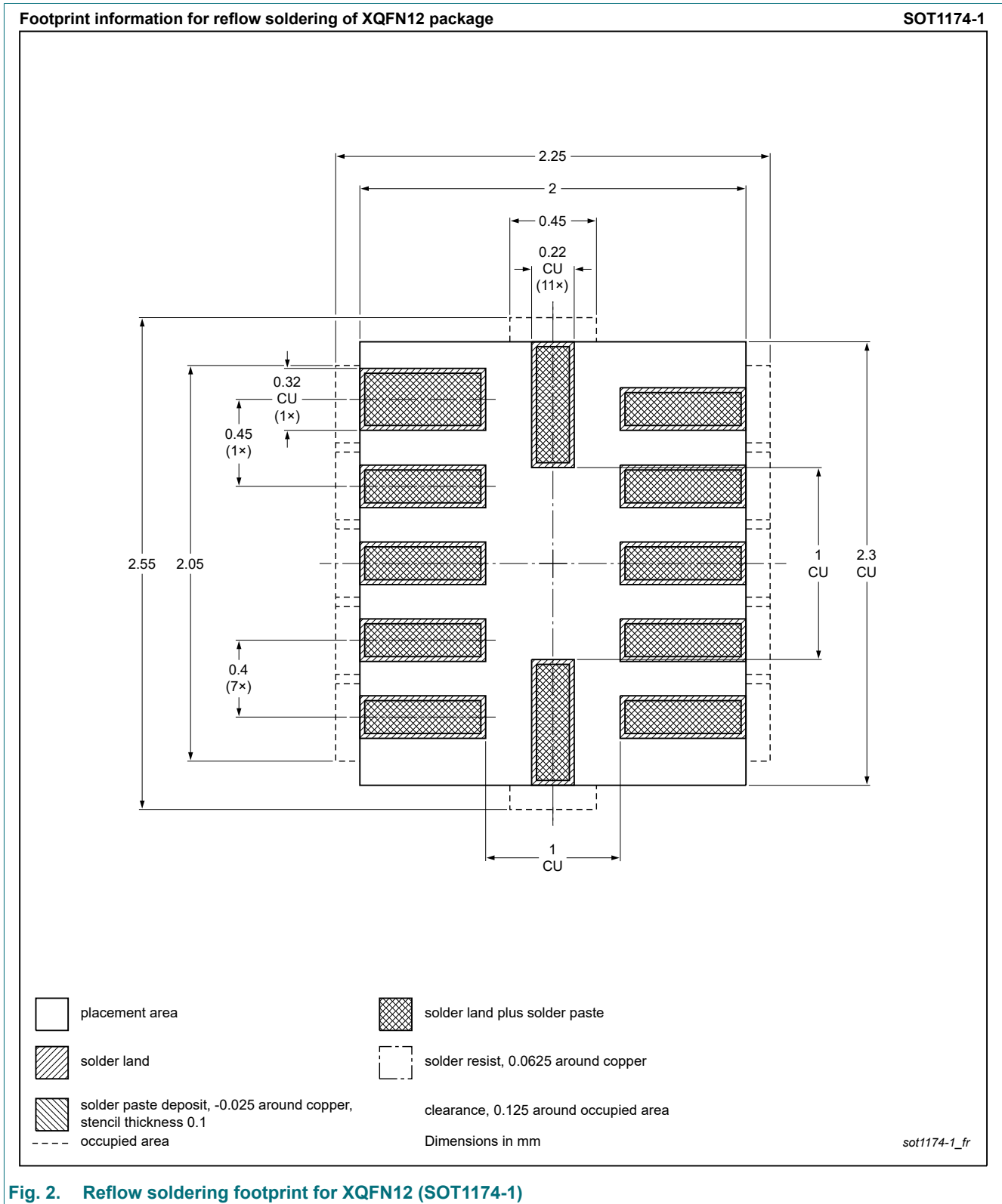


Fig. 2. Reflow soldering footprint for XQFN12 (SOT1174-1)
