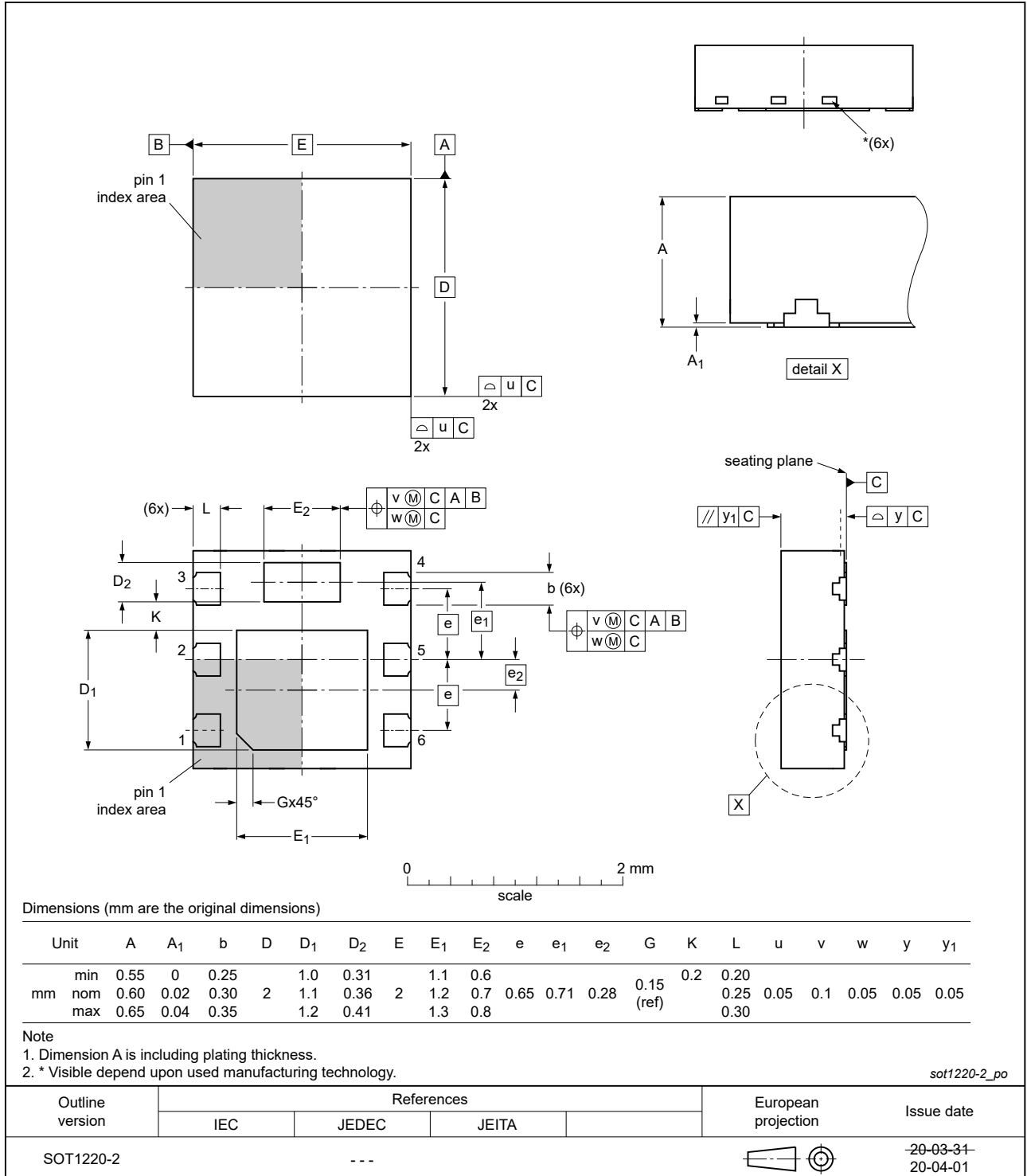


Fig. 1. Package outline DFN2020M-6 (SOT1220-2)

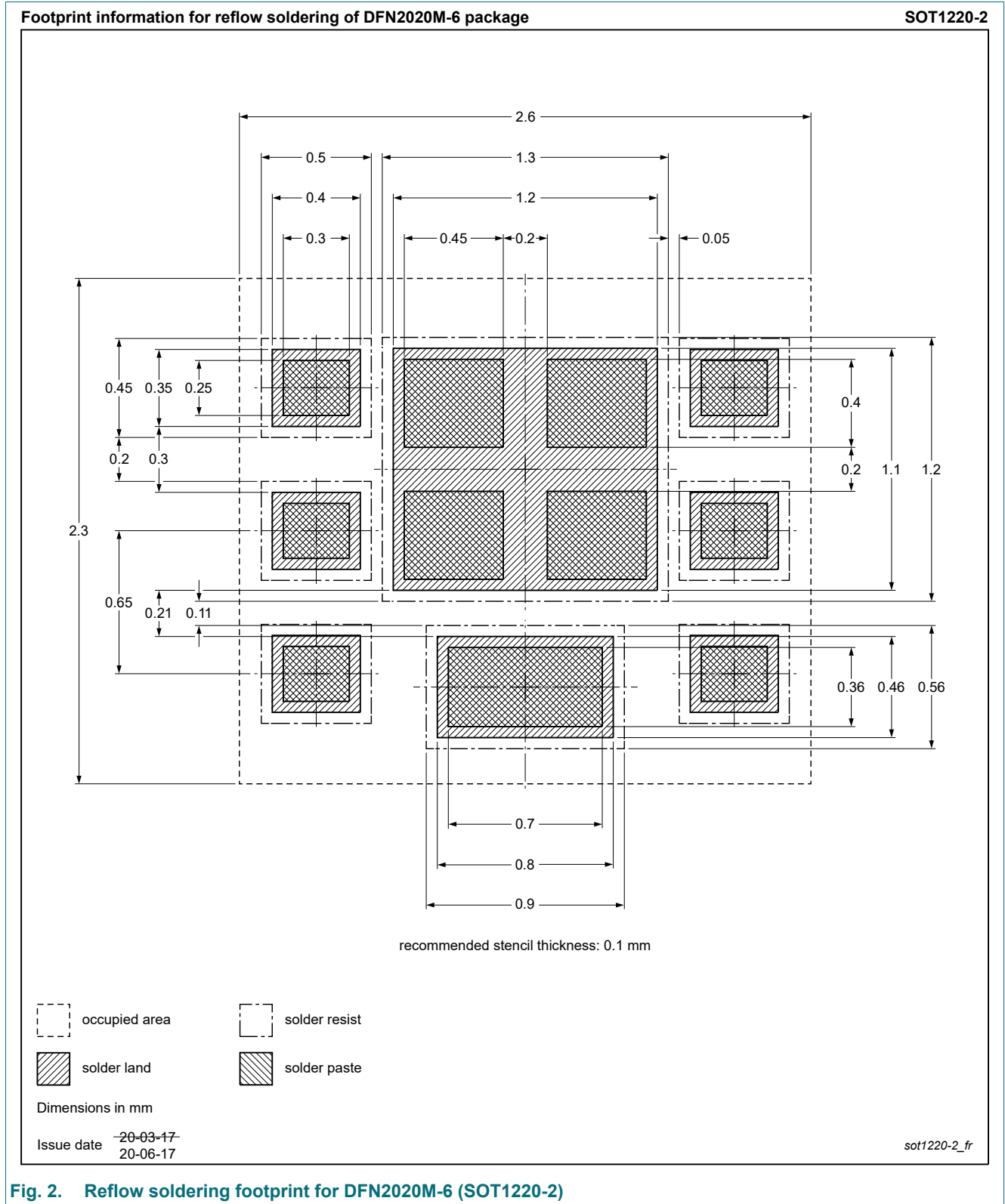


Fig. 2. Reflow soldering footprint for DFN2020M-6 (SOT1220-2)
