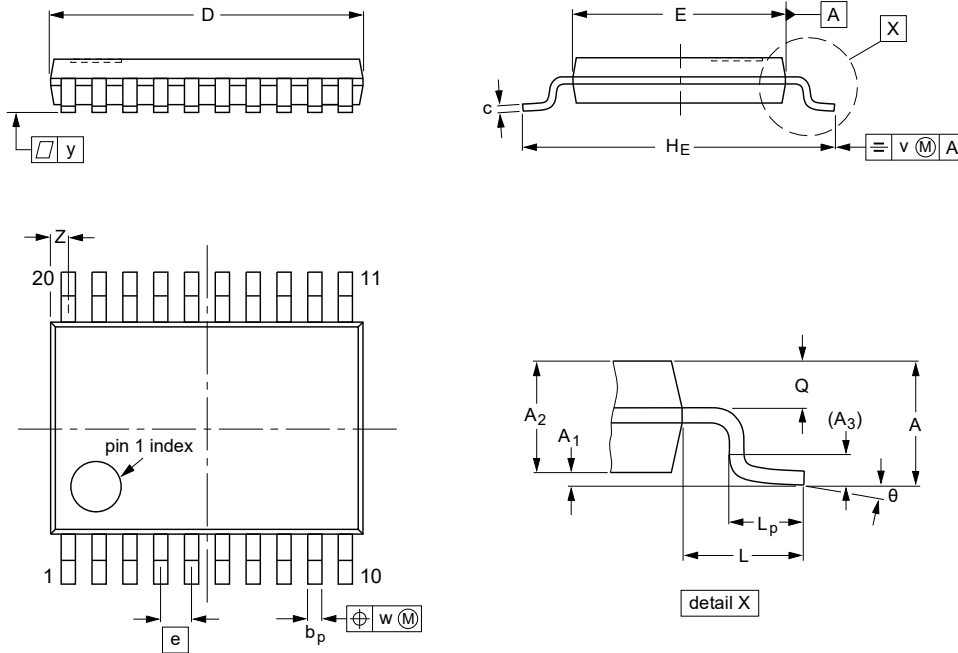

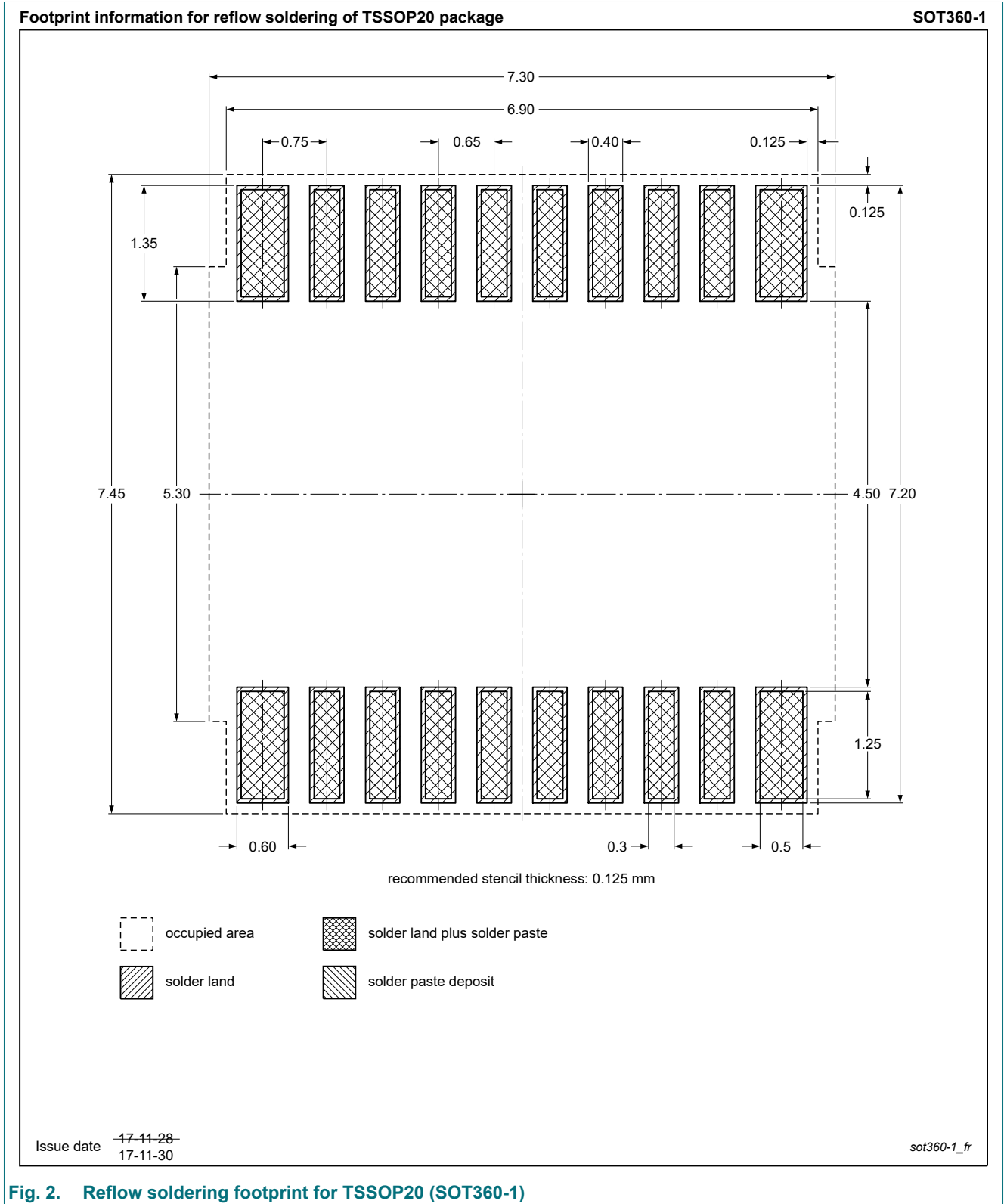


Fig. 2. Reflow soldering footprint for TSSOP20 (SOT360-1)
