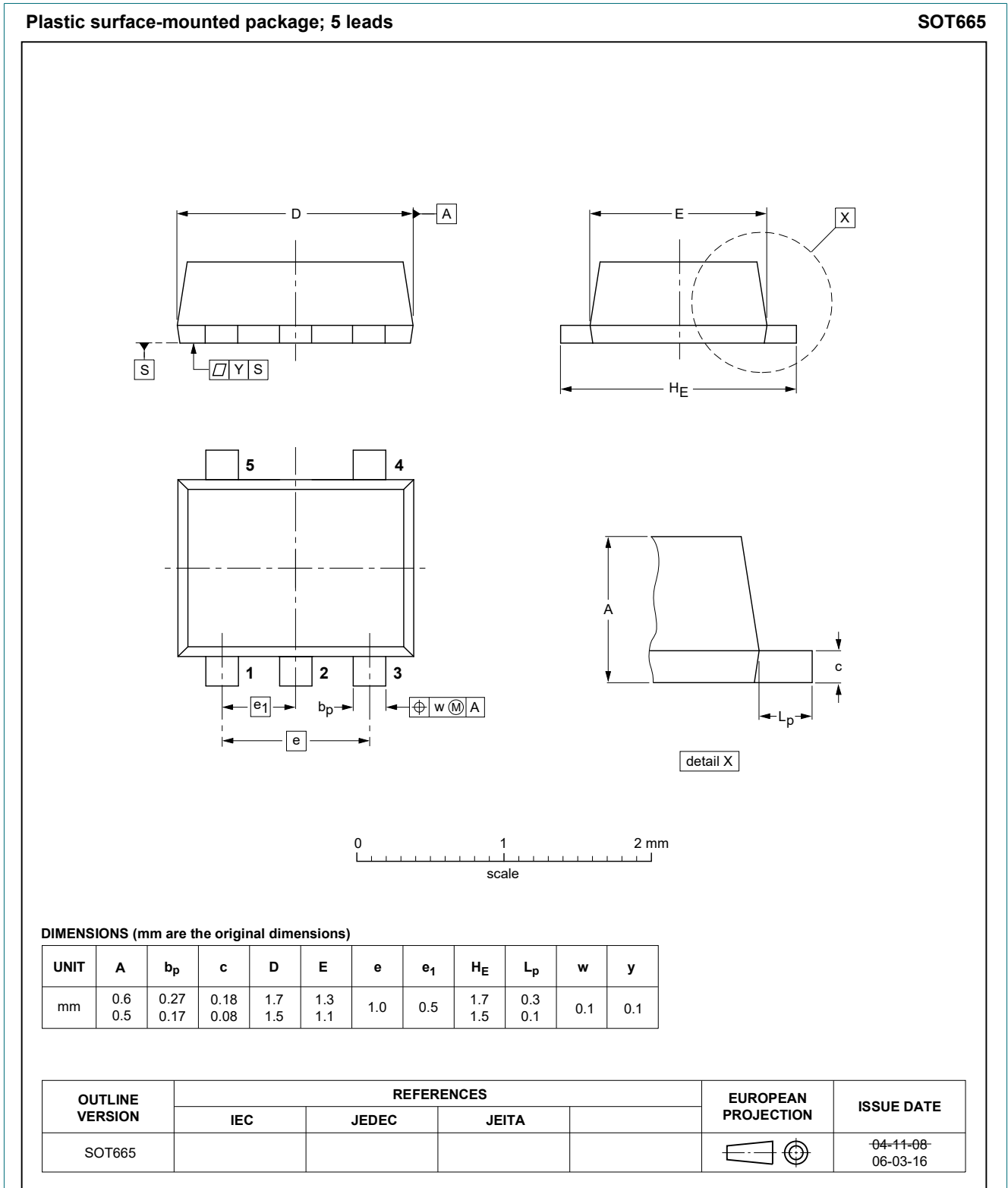


Fig. 1. Package outline SOT665

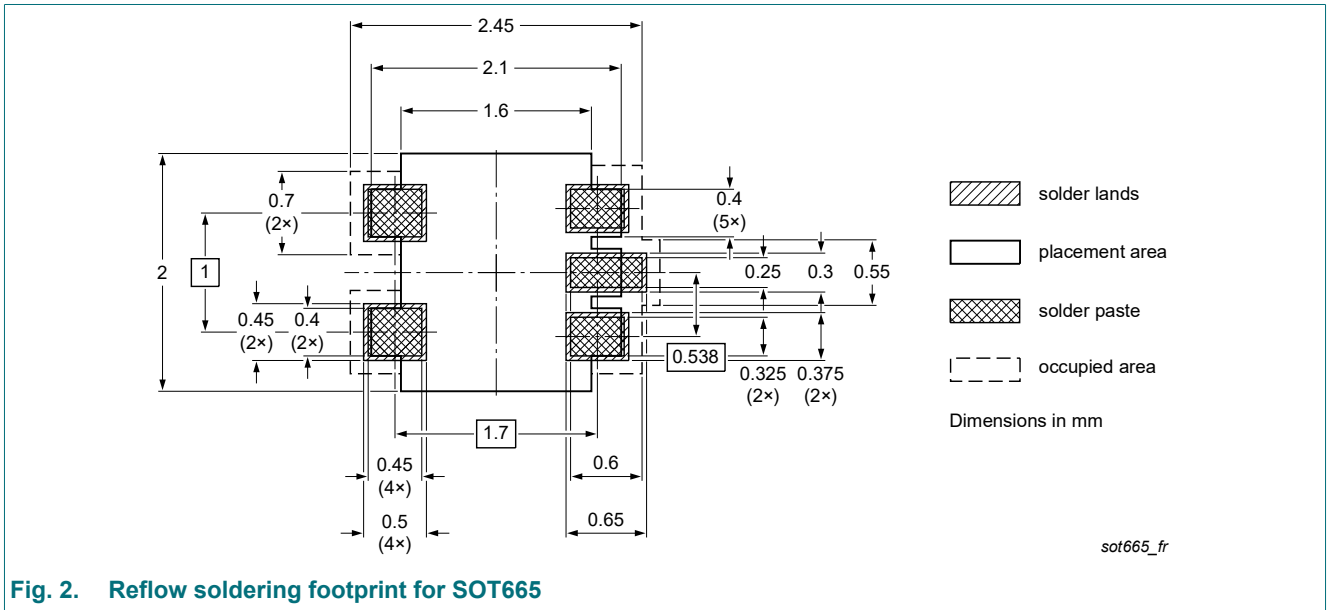


Fig. 2. Reflow soldering footprint for SOT665
