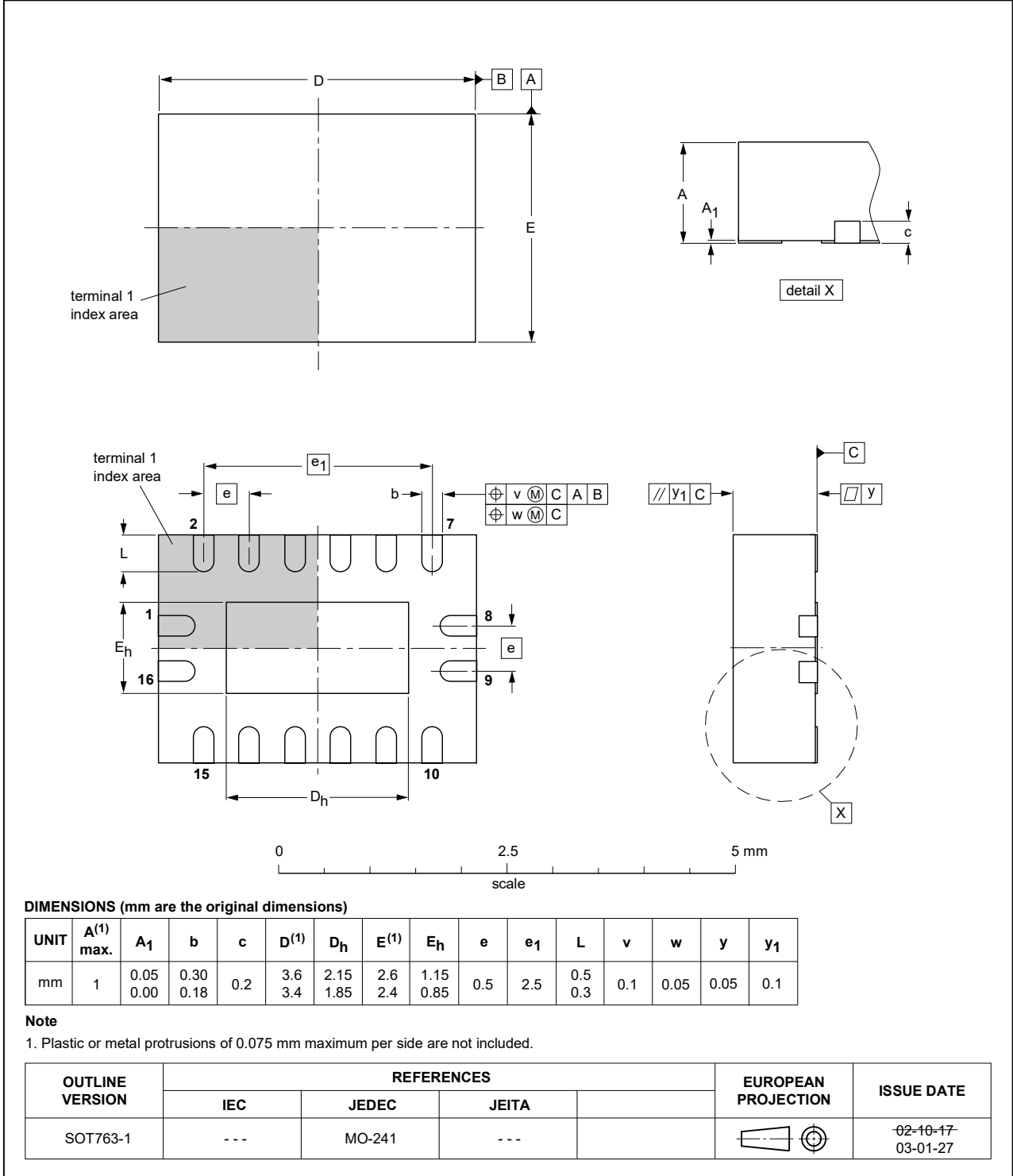


Fig. 1. Package outline DHVQFN16 (SOT763-1)

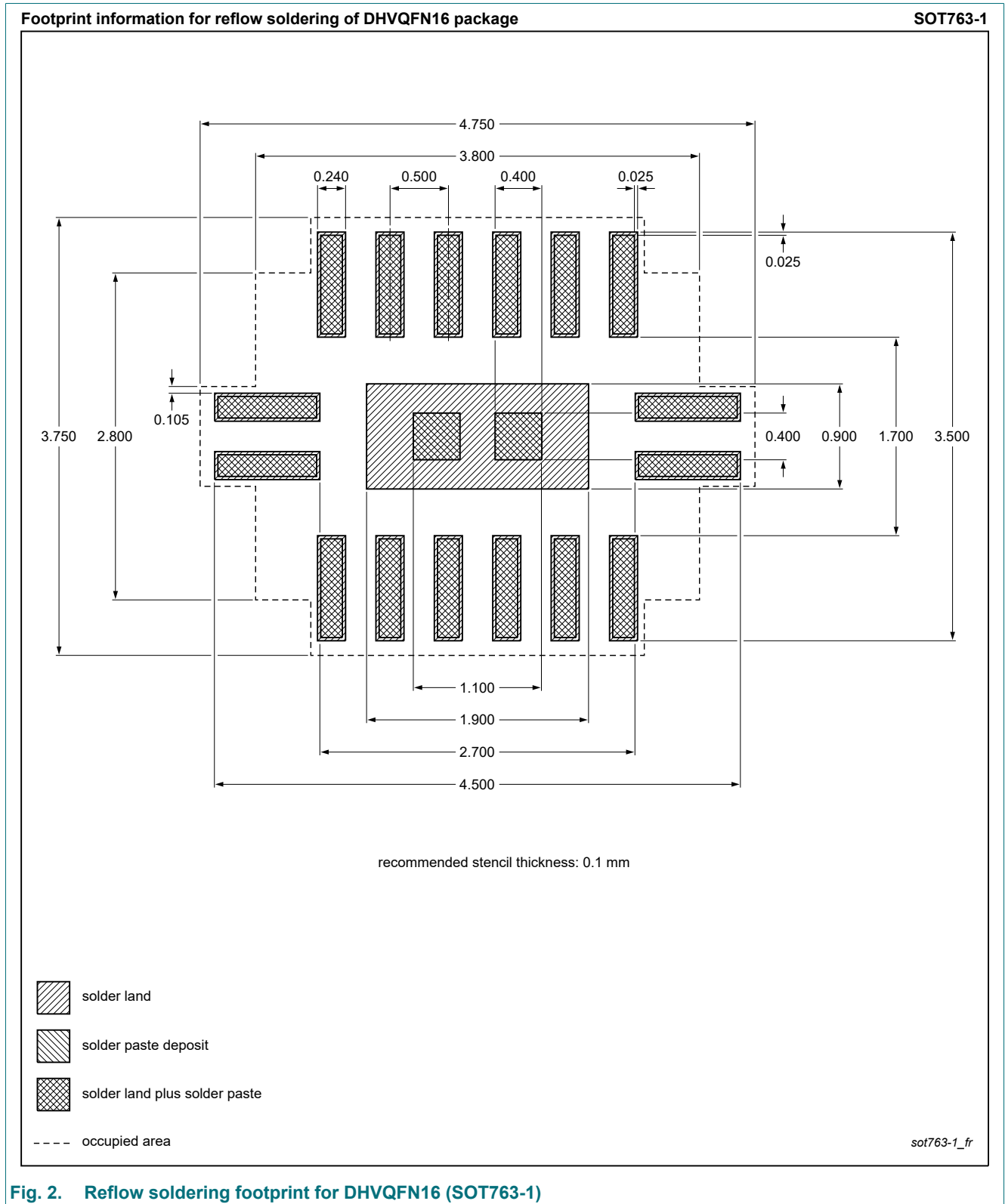


Fig. 2. Reflow soldering footprint for DHVQFN16 (SOT763-1)
