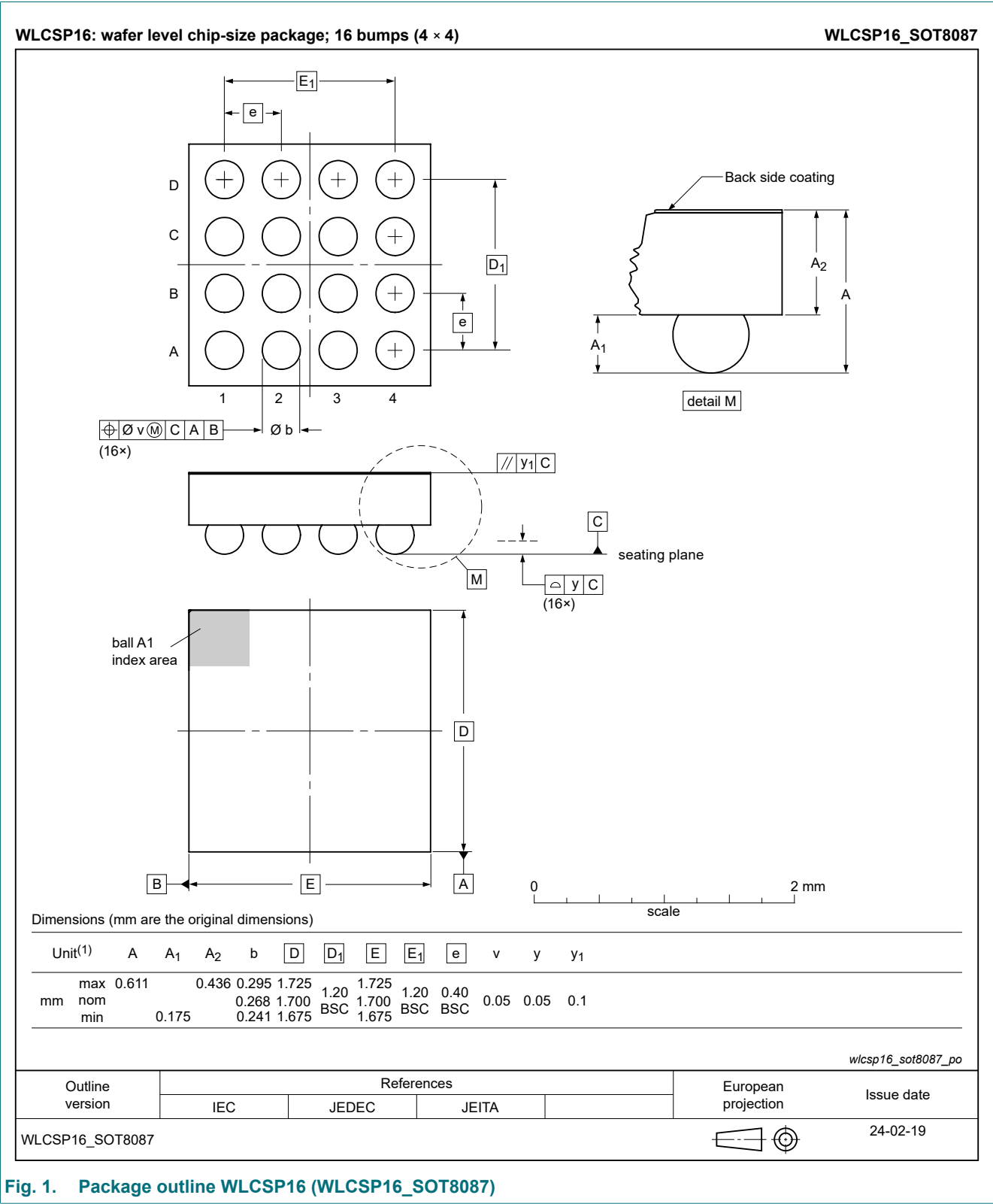
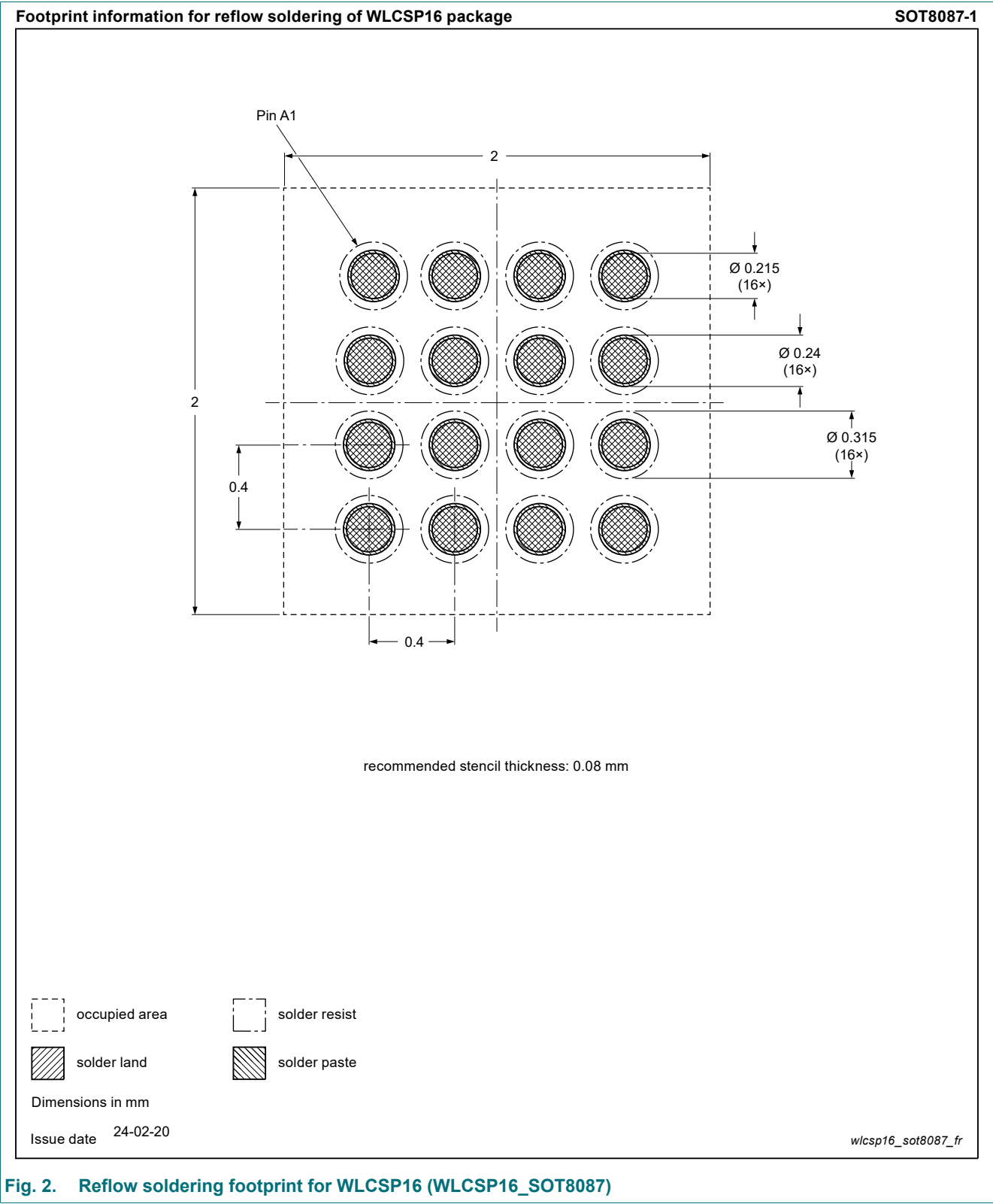


Fig. 1. Package outline WLCSP16 (WLCSP16\_SOT8087)
