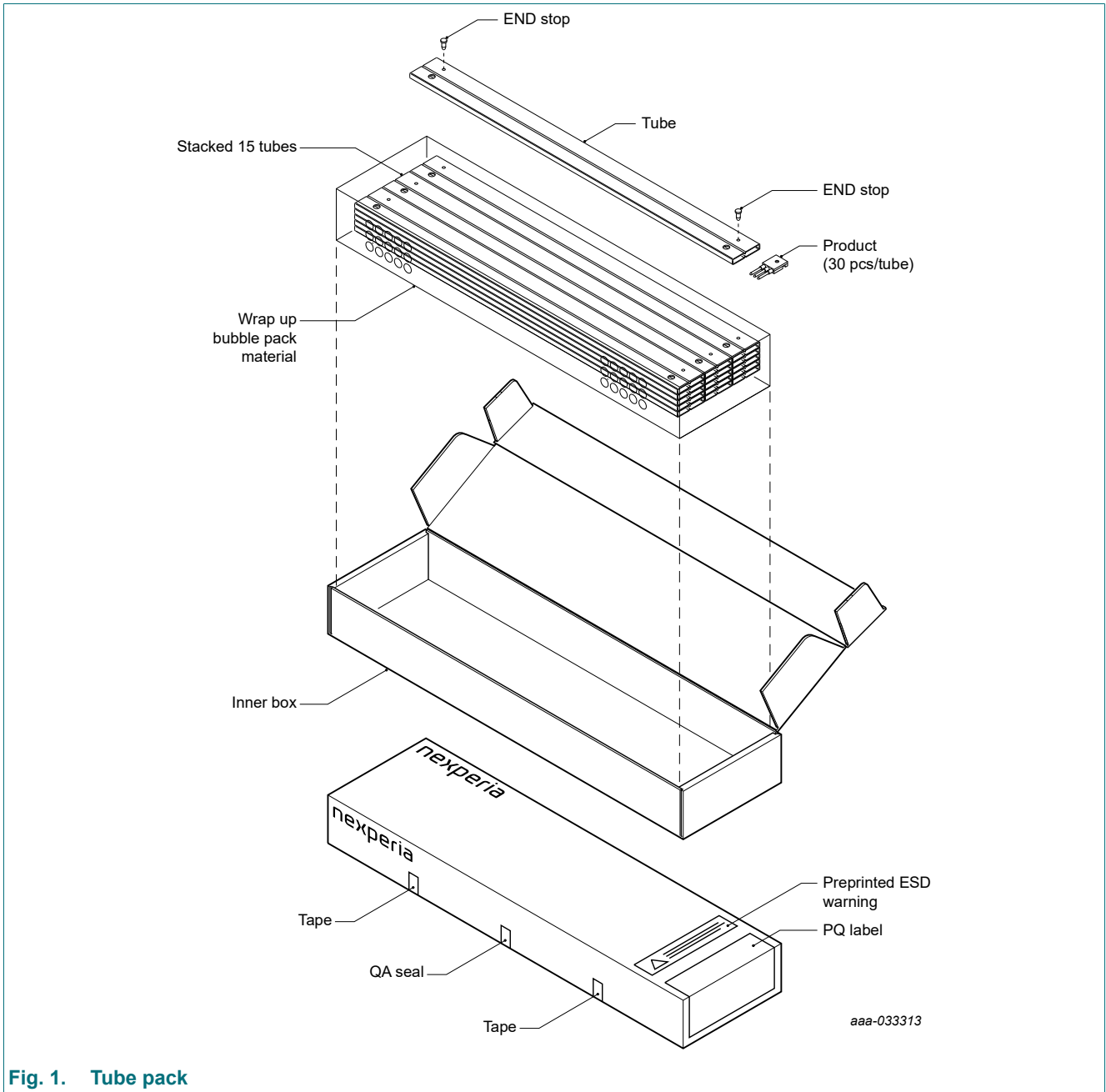


Fig. 1. Tube pack

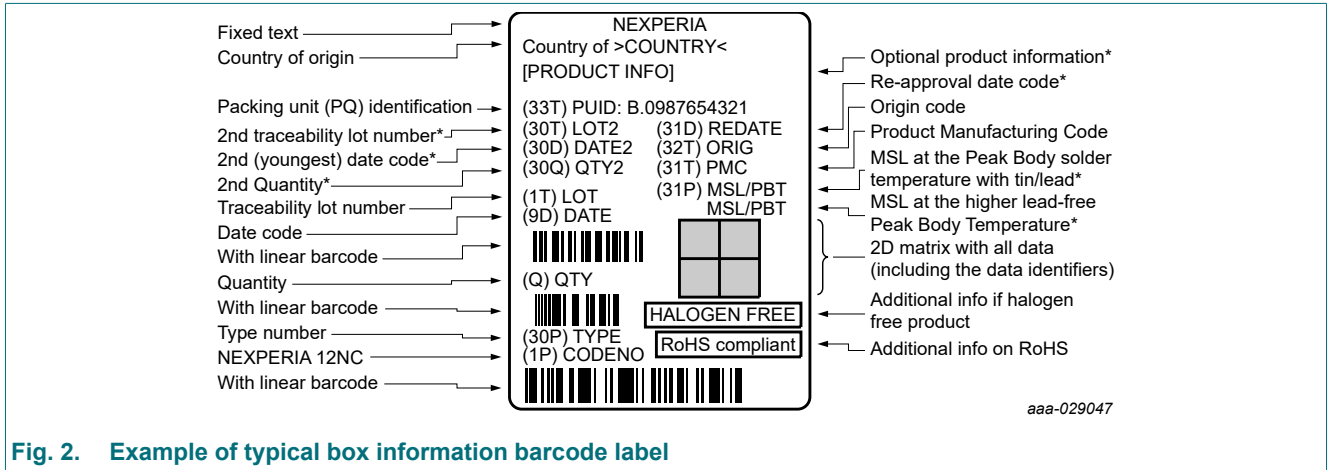


Fig. 2. Example of typical box information barcode label
